**I. Description of the Land.**— Allotments of land depicted in below names and extents in the Cadastral Map C.M.No. 310214, Block No. 02, Sheet No. 01 dated 07.11.2023 prepared by the Surveyor General, situated in the Village called Habaraghamada (Old Nalanda and Pilihudugolla) in No. E 410C, Habaraghamada Grama Niladhari Division in the Divisional Secretary's Division of Naula in Matale District of Central Province and bounded as follows.
