## **Land Acquisition Notices**

#### THE LAND ACQUISITION ACT (CHAPTER 460)

#### Notice under Section 7

I hereby give notice under Sub-section (1) of Section 7 of the Land Acquisition Act, as Amended by the Land Acquisition (Amendment) Act, No. 28 of 1964, that the Government intends to acquire the following land as it is required for public purpose.

Description of the land to be acquired:-

The allotments of land in total extent of about 0.4481 hectare depicted as Sheet No. 01 in Block No. 02 in the Cadastral Map No. 830255 of the Surveyor General, situated at the Village of Ridiyagama, in Ridiyagama Grama Niladhari Division, No. 129, in Magam Pattuwa Minor Division, in the Divisional Secretary's Division of Ambalantota, in Hambantota District, and bounded as follows.
