THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Kuragamage Don Lal Kantha, Minister of Agriculture, Livestock, Lands and Irrigation do hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are required for a public purpose and will be acquired under the provisions of that Act.

The allotments of land described as following names and extents, depicted in the Advance Tracing No. KU/BMK/2022/186 dated 10.11.2022, prepared by the Surveyor General, situated at the Village of Bogoda in the Grama Niladhari Division No. 1207 of Bogoda in the Divisional Secretary's Division of Bamunakotuwa in the District of Kurunegala, North Western Province and bounded as follows:

01. Lot 'A' – Weralugolla Medikelemookalana – Extent: 0.1481 Hectare
