As the Southern Provincial Council has been dissolved, the powers vested upon the Minister in charge of the subject under Section 24 of Co-operative Employees' Pension Statute No.02 of 2019, have been assigned to me, the Governor of the Southern Province by Article 154 C of the Constitution of the Democratic Socialist Republic of Sri Lanka and in terms of such powers, do hereby exclude Section 6.ii (C) and chart No.01 of schedule (A) of orders of the Co-operative Employees' Pension Statute No.02 of 2019 and substitute thereof with the following section and chart No. 01 and the said set of orders are amended and enacted. These orders shall be effective from 01.04.2024.

(C) In the case of a contributor who is below 55 years of age on the next birthday at the time of joining this scheme, monthly contributions shall be paid in accordance with the number of installments payable in respect of the period of active service from the date of contribution to the date of retirement as specified in Table No. 01 of Schedule (A) of these amended orders and shall be entitled to receive a pension as specified in column III of the said table
