THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Kuragamage Don Lal Kantha, Minister of Agriculture, Livestock, Land and Irrigation, hereby declare under Sub section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of the said Act.

Allotments of land depicted in below names and extents in Advance Tracing No. CO/DSO/2024/1 dated 26.12.2024 prepared by the Surveyor General, situated in the Village of Aluthmawatha (within ward No. 17 Aluthmawatha, within the Municipal Council limits of Colombo) in the Divisional Secretary's Division of Colombo in Colombo District of the Western Province and bounded as follows.

01. Lot A – Assessment No. 80/20, Wall's Lane – Extent: 0.0033 Hectare
