I hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, as amended by the Land Acquisition (Amendment) Act, No. 28 of 1964, that the Government intends to acquire the following land as it is needed to acquire an additional allotment of land for the Construction of Kulugammana Pump House of Kandy North-Pathadumbara Integrated Water Supply Project.
