- (e.) The relevant age limit for each job category shall be decided from time to time.
- (f.) A short term practical training will be provided to suit to relevant industrial field for selected applicants for foreign employment. A knowledge of the language of the job offering country will be given to applicants and they should pass in a test after training.
- (g.) Applicants should be prepared to submit following documents when request to do so.
 - i) Birth certificate
 - ii) National Identity card
 - iii) Passport
 - iv) Certificates of educational qualifications
 - v) Certificates of training courses and experience
