REPORT OF THE AUDITOR GENERAL ON THE ACCOUNTS OF THE UNIVERSITY OF JAFFNA FOR THE YEAR ENDED
 31ST DECEMBER, 2002 IN TERMS OF SECTION 108(2) OF THE UNIVERSITIES ACT, NO. 16 OF 1978

THE audit of accounts of the University of Jaffna for the year ended 31st December, 2002 was carried out under my direction in pursuance of provisions in Article 154(1) of the Constitution of the Democratic Socialist Republic of Sri Lanka read in conjunction with Sections 108(1) and III of the Universities Act, No. 16 of 1978 and Sub-sections (3), (4) and (7) of Section 13 of the Finance Act, No. 38 of 1971. This report is furnished in terms of Section 108(2) of the Universities Act. The detailed report in terms of Section 13(7)(a) of the Finance Act was furnished to the Vice Chancellor of the University on 24th July, 2003.

1.2 *Scope of Audit*

Audit opinion, comments and findings in this report are based on a review of the financial statements presented to audit and substantive tests of samples of transactions. The scope and the extent of such review and tests were such as to enable as wide an audit coverage as possible within the limitations of staff, other resources and time available to me. The audit was carried out in accordance with Sri Lanka Auditing Standards, methods and practices to obtain reasonable assurance as to whether the financial statements are free of material misstatements. The audit included examination of evidence supporting the amounts and disclosures in financial statements and assessment of accounting principles and significant estimates and judgments made in the preparation of the financial statements, evaluation of their overall presentation and determining whether accounting policies adopted were appropriate, consistently

applied and adequately disclosed. Sub-sections (3) and (4) of Section 13 of the Finance Act, No. 38 of 1971 give discretionary powers to the Auditor General of determine scope and extent of the audit.

2. Accounts

2.1 Rendition of accounts

Although the final accounts of the University of Jaffna for the year ended 31st December, 2002 should have been rendered for audit on or before 31st March, 2003, the accounts had been rendered for audit only on 04th June, 2003. However, the relevant schedules had not been rendered for audit up to 24th July, 2003.

2.2 Audit Opinion

Except for the effects of the adjustments arising from the matters referred to in paragraph 2:4 of this report, I am of opinion that the financial statements have been satisfactorily prepared to present fairly in all material respects, the financial position of the University as at 31st December, 2002 and the results of its operations and cash flow for the year then ended in accordance with Sri Lanka Accounting Standards and the stated accounting policies as set out in notes to the financial statements.

2.3 Financial Results

According to the accounts presented, the working of the University during the year ended 31st December, 2002 had resulted in a deficit of Rs. 324,974,588 and the Government Grant of Rs. 250,036,000 for recurrent expenditure of the University had reduced this deficit to Rs. 74,938,588. The corresponding deficit for the preceding year before taking into account the Government Grant for recurrent expenditure amounted to Rs. 301,292.658 and the Government Grant of Rs. 242,100,000 for recurrent expenditure of the year had reduced the deficit to Rs. 59,192,658.

2.4 Comments on Accounts

2.4.1 Accounting Deficiencies

Following accounting deficiencies were observed :-

- (a) A sum of Rs. 60,200 paid to two re-employed midwives on contract basis in the Ayurvedic Hospital, Kaithady had not been brought to account as recoverable from Department of Ayurvedic.
- (b) One month salary recoverable from an officer who had not given one calendar month notice of desire to leave the service with effect from 01.07.2002 and the no pay leave for the period 11th June to 30th June, 2002 had not been ascertained and brought to account.
- (c) Rent from students who were in occupation of Hostels, had not been recovered and brought to account.
- (d) Rent receivable from certain individuals for occupation of Quarters and Rest Houses operated by the University in Colombo and Jaffna had not been ascertained and disclosed in the accounts.
- (e) No pay leave for 08 days, amounting to Rs. 11,862 had not been recovered from a lecturer attached to the Department of Chemistry.
- (f) Several items of Medicine pilfered at the Department of Medicine had not been reported and not dealt with in the accounts.
- (g) The following items of assets donated by well-wishers to the University of Jaffna had not been brought to account.
 - (i) Properties donated by Malasiyan Ceylon Association valued at Rs. 1,000,000.
 - (ii) House and property donated by an individual valued at Rs. 200,000.
 - (iii) Land at Thirunelvely valued at Rs. 400,000.

- (h) Damages to the Faculty of Agriculture due to military operations had not been ascertained and brought to account.
- (i) Deposits of Rs. 43,279 with the District Secretariat, Jaffna made in 1975, 1979 and 1980 respectively had not been disclosed in the accounts.
- (j) A donated land to the extent of 3 larcham 14.39 kulies called Thevatharai, Kilakkupathy had not been valued and brought to account.
- (k) Direct credit aggregating Rs. 2,950,267 made to the bank accounts had not been brought to account.
- (l) Three months salary from those who had not given three calendar months notice of their desire to leave the service of the University in terms of the agreement entered into with the University had not been ascertained and brought to account.
- (m) Fixed assets had been shown in the balance sheet at book balance without being physically verified.
- (n) 25 acres of crown land at Poonthodam and 1/2 acres land at Park Road, Vavuniya vested in the Vavuniya Campus had not been valued and brought to account.
- (o) A sum of Rs. 1,000,000 being the Grant for recurrent expenditure for 2001 received in January, 2002 had been adjusted in the opening balance of General Reserve, before posting the balance in the main ledger. As a result, the transaction had not been disclosed under prior year adjustments.
- (p) Depreciation had been provided for the year under review in respect of certain fully depreciated vehicles.
- (q) Expenditure totalling Rs. 23,699 relating to the previous year had been treated as an expenditure of the year under review.
- (r) A sum of Rs. 519,894 being advances to suppliers had been treated as expenditure of the year under review.
- (s) A sum of Rs. 7,590 being the settlement of advance given to National Livestock Development Board in 1993 for supply of 220 birds at the rate of Rs. 34.50 each had been treated as expenditure of the year under review instead of being accounted for under prior year adjustments.
- (t) Expenditure amounting to Rs. 17,849 had been erroneously classified and charged to accounts.
- (u) Expenditure aggregating Rs. 47,648 of the Vavuniya Campus relating to the previous year had been treated as expenditure for the year under review.

2.4.2 *Accounts Receivable and Payable*

- (a) Out of the advances paid for supplies amounting to Rs. 3,706,683 for which letters of credits opened in previous years, supplies to the value of Rs. 1,184,834 had not been received up to 24th July, 2003.
- (b) Although a letter of credit for Rs. 136,839 had been opened in 1999, the relevant supplies had not been received by the University. However, a sum of Rs. 15,662 had been paid as National Security Levy.
- (c) Confirmations had not been obtained in respect of receivables and payables aggregating Rs. 259,462,974 and Rs. 17,608,037 respectively.

2.4.3 *Lack of Evidence for Audit*

Thirty eight items in the accounts aggregating Rs. 820,403,738 could not be satisfactorily vouched or accepted in audit in the absence of detailed schedules, verification reports, estimates, measurement sheets, air tickets, quotations, running charts, inventory certificates *etc.*

2.4.4 *Apparent Fraudulent Transaction :*

A cash deposit of Rs. 2,675 at the bank had not been credited to the accounts up to 24th July, 2003.

2.4.5 *Non-compliance with Laws, Rules, Regulations and Management Decisions :*

Instances of non-compliance with the provisions in the following Acts, Financial Requirements, Establishment Codes, Circulars etc. were observed in audit :

(a) Establishments Code of the University Grants Commission and the Higher Educational Institutions ;

Section 30 of Chapter III, Section 7.6 to 7.6.2 of Chapter V, Section 5.2 and 9.1 of Chapter XVII, Section 5:2, 9:1 Section 3.1 of Chapter XX, Section 2:2 (f) of Chapter XXV and Section 9:4 of Chapter XXVII ;

(b) Universities Act, No. 16 of 1978 Sections 71(1) and 71(2) ;

(c) University Grants Commission Circulars :

(i) Section 6(3) of No. 63 of February, 1980 ;

(ii) Finance and Supplies Circular No. 47 of March, 1975 ;

(iii) Circular No. 07/2002 of 13th June, 2002 ;

(d) Treasury Circulars

No. 842 of 19th December, 1978, No. 828 of 29th July, 1979 and No. 47 of 08th February, 1990 ;

(e) Financial Regulations

No. 264(1), 570, 571, 700(5), 754 and 880.

3. *Financial and Operating Review :*

3.1 *Financial Results :*

The working of the University for the year under review had resulted in a deficit of Rs. 74,938,588 as compared with the deficit of Rs. 59,192,658 for the preceding year thus showing an increase in deficit by Rs. 15,745,930.

3.2 *Uneconomic Transactions :*

(a) The University had paid a sum of Rs. 9,554 as demurrage for delay in clearing cargo from the warehouses of the Sri Lanka Ports Authority.

(b) A photocopier costing Rs. 153,450 had been provided to Colombo Stores without considering the necessity for photocopier for use at this unit.

(c) Spiral Bindings Springs had been purchased for Rs. 9,000 on 26th March, 2003 inspite of adequate stocks valued at Rs. 218,445 idling in store for more than five years.

(d) Four council members and seventeen members of University staff had been provided air passage at a cost of Rs. 152,423 during the year under review for travelling from Colombo to Jaffna and Jaffna to Colombo and back although road passage was available at least cost.

3.3 *Other Slow Moving, Idle and Underutilized Assets :*

(a) A sum of Rs. 16,710 and a sum of Rs. 28,067 had been held in 2 current accounts at People's Bank and Bank of Ceylon, Kilinochchi respectively as these accounts had not been operated since 1990.

(b) Eight items of drugs valued at Rs. 10,467 had not been used before the expiry date and lying in the Health Centre for periods ranging one to two years.

(c) 17 Monitors, 15 C. P. U., 01 Micro net work hub, 01 Scanner, 01 Printer and 01 Saver are lying in the Computer Unit due to lack of repairs for a long period of time. No action had been taken to repair these items and use or to dispose of them.

- (d) Five Time Recording Machines and stationery for these machines purchased for Rs. 170,000 and Rs. 12,400 respectively in the year 2002 had not been used for the intended purposes and allowed to lying idle at the Establishment Unit of the University.
- (e) 1.053 boxes of chalks values Rs. 28,793 had been lying in stores for a long period.
- (f) 146 Ribbon - Word Process costing Rs. 18,415 purchased in August, 2000 had not been used and lying at the stores up to 24th July, 2003.
- (g) A weighing balance at the Department of Parasitology had not been used for over five years due to lack of repairs.
- (h) Laboratory Equipment such as Electro Cardio Graft, Balance, Cycle, Audio Meter and Co2 Analyzer at the Department of Physiology are lying idle for periods ranging one to two years due to lack of repairs.
- (i) 11 Laboratory Equipment valued at Rs. 1,027,000 at the Department of Chemistry are lying idle for over one year due to lack of repairs.

3.4 *Identified Losses :*

- (a) 10 bags of cement costing Rs. 4,500 in the stores were found unsuitable for use.
- (b) Crimp tool for RJ 45 connector 2 numbers costing Rs. 8,505 found missing.

3.5 *Delays in Projects :*

- (a) Construction works under various projects for which agreements had been entered into as far back as 1981 had not been completed.
- (b) Consultancy fees amounting to Rs. 126,973 had been paid to a Company in July, 2002 for decoration of Auditorium at Medical Faculty. However, the works in connection with decoration of Auditorium had not yet been commenced.

3.6 *Assets not Properly Maintained :*

Although a sum of Rs. 6,803,452 had been spent for the maintenance of Land and Buildings of the University, the Health Centre of the University had not been properly maintained and provided with suitable facilities to operate the Health Centre efficiently and effectively.

3.7 *Extraneous Items of Expenditure :*

- (a) Expenditure amounting to Rs. 10,000 in connection with Sir Ponnambalam Ramanathan's Curupooja conducted at the Sri Parameshwaran Temple on 13th December, 2003 had been treated as other recurrent expenses.
- (b) A sum of Rs. 39,500 had been spent for the funeral of a student of the Medical Faculty.

3.8 *Recruitment of Staff:*

- (a) It is a regular feature of the University to make appointments for vacant posts on assignment basis without obtaining approval of the General Treasury and the Cabinet of Ministers. Thirteen officers retired from the University Service including seven of non academic staff had been appointed on assignment basis without the approval of the Treasury and the Cabinet of Ministers and a sum of Rs. 1,346,571 had been paid as remunerations.
- (b) Honorarium equivalent to monthly salary of the Doctors attached to Teaching Hospital, Jaffna had been paid directly for lectures and practices rendered to the University without obtaining approval of the Treasury and the Cabinet of Ministers and without considering the duration of services they performed for a day. Accordingly, these Doctors are drawing remunerations from two Institutions.

3.9 *Application of Specific Funds :*

The Grants received for specific purposes aggregating Rs. 20,482,979 and interest aggregating Rs. 2,391,830 thereon had not been utilized for the purposes for which they were granted.

3.10 *Funding Arrangements for Payment of Employees' Gratuity :*

A sum of Rs. 69,851,773 had been provided for payment of gratuities to the staff of the University at the end of the year under review. But a fund had not been established to meet the liabilities as and when they arise.

3.11 *Budgetary Control :*

Major variations were observed between the budget and the actual thus indicating that the budget had not been made use of as an effective instrument of management control.

4. *Systems and Controls :*

Deficiencies observed during the course of audit will be brought to the notice of the Vice Chancellor of the University by my detailed report to be furnished in terms of Section 13(7)(a) of the Finance Act. Special attention is needed in respect of the following areas of control:

- (a) Recruitment of Staff ;
- (b) Fixed Assets ;
- (c) Debtors ;
- (d) Advances ;
- (e) Purchases ;
- (f) Losses ;
- (g) Budget ;
- (h) Contract Administration ;
- (i) Stores ;
- (j) Endowment Fund ;
- (k) Internal Audit.

OBSERVATION OF THE GOVERNING AUTHORITY OF THE UNIVERSITY OF JAFFNA ON REPORT OF THE AUDITOR GENERAL ON THE ACCOUNTS OF THE UNIVERSITY OF JAFFNA FOR THE YEAR ENDED 31.12.2002

- 2.4.1 (a) The sum of Rs. 60,200.12 has been shown as debtors and included in the schedule in the year 2002 accounts.
- (b) All the dues are taken into account when the release of UPF is finalised.
 - (c) Rent paid by the students is reflected in the account and amount recoverable is shown as receivable.
 - (d) Rent received from the occupant in the Guest House and in the quarters is shown in the account and the dues is shown as receivable.
 - (e) This has been recovered in the year 2003.

- (f) This matter is being look into.
 - (g) These are taken into the account in the year 2003.
 - (h) action is taken to ascertain the loss in order to account the same in the year 2004.
 - (i) Since we need time to trace the documents action will be taken in due course.
 - (j) This is accounted in the year 2003.
 - (k) All direct credits have been identified and taken in to the account in the year 2003.
 - (l) Salary in lieu of notice is shown as due from UPF when the UPF is finalised.
 - (m) Action is taken to complete the Board of Survey in time.
 - (n) The value of these land have been accounted in 2002.
 - (o) Any adjustments in the general reserve will be shown separately in the income and expenditure appropriation account in future.
 - (p) Adjustment is made in the 2003 accounts.
 - (q) Necessary adjustment is made in the year 2003 accounts and all expenditure in connection with the prior year will be shown as prior year payment unless it is accounted as accrued expenditure. (r, s, t and n) This type of error will not occur in future.
- 2.4.2 (a) Shipment dates were extended at the request of the Supplier with the consent of the department's concerned.
- (b) Most of the orders placed in the year 2002 have been executed in the year 2003.
 - (c) Action is taken to obtain continuation for the receivable and payable.
- 2.4.3 Due to the lack of details of the sum of Rs. 820,403,738 we are unable to answer to this observation.
- 2.4.4 All the deposits to the bank accounts identified and taken into account in the year 2003.
- 2.4.5 Every step is taken to comply with the provision in the University Act, E-code and Circulars etc.
- 3.2 (a) Action is taken to clear the cargo without delay.
- (b) Since the University had to incur a big amount on photocopy in Colombo and to avoid the delay a photocopier was given to the Colombo Store.
 - (c) The size that was purchased was not available in the store.
 - (d) The University of Jaffna has got only three vehicles. The Car is assigned to the Vice-Chancellor and the Van is provided to the Faculty of Medicine only the Pick-up is in the pool for common purposes. Therefore it is not possible to provide the vehicle to the Deans, Registrar, Librarian and Bursar for their journey to Colombo on official duty. Further there is no train services is available to Jaffna. The officers of the University are entitled for mileage. When compared to the cost of mileage the flight charges is only a little bit higher side. Therefore the Council delegated the authority to the Vice-Chancellor to approve air passage on case-by-case basis depending on urgency.
- 3.3 (a) Action has been taken to close these two accounts.
- (b) The value of expiry drugs is Rs. 3,356.06 and not Rs. 10,467 as stated in the Audit report. These drugs were expired in a period of 3 years from 2000 to 2002.
 - (c) Action is taken to get the equipment repaired.

- (d) The University Administration had to postpone the action of introducing the Time Recorder as the employees of this University had protested the introduction of Time Recorder.
- (e) These items are issued from store and the present stock balance is 678 boxes.
- (f) Since the usage of the Word Processor is considerably reduced due to usage of Computer. The need for ribbon for Word Processor is reduced.
- (g) It is very difficult to find competent Persons/Firms to repair the machine locally.
- (h) Action is taken to send these items to Colombo for repair.
- (i) It is reported by the Head that the items mentioned in the report do not belong to the Department of Chemistry.
- 3.4 (a) Due to the non availability of sand the cement could not be used.
- (b) The value of Rs. 8,505 has been written off with the approval of the council granted at its 278th meeting held on 27.09.2003.
- 3.5 (a) There is no project for which agreements were signed in 1981 remain incomplete as on 31.12.2002.
- (b) Work could not be commenced in the year 2002 due to insufficient allocation for the year 2002.
- 3.6 The Health Centre building is structurally safe and no defects were observed in the year 2002. The annual allocation for the rehabilitation for the capital assets is insufficient to upgrade all University building in very high expectation.
- 3.7 (a) and (b) These type of expenditure will be avoided in future.
- 3.8 In spite of our repeated advertisement to the post of Senior Academic grades in Faculties of Medicine and Science no qualified persons were applied. Therefore the University Council decided to re-employ 6 Senior Academic Staff who had retired from the services object to the approval of the Cabinet. In the meantime the Council also decided to appoint these academic staff on assignment basis on a lumpsum payment as an interim measure until we obtain approval from the Cabinet. In order to carryout the academic programme of these Faculties which suffer with dearth of senior qualified experience staff.
- 3.9 The appointment of hospital consultants made on a payment of honorarium were cancelled and it is covered on visiting appointments on hourly basis.
- 3.10 The Treasury does not provide allocation to make investment for the provision of gratuity.
