Audit Opinion

The accounts of the Institute of Worker's Education affiliated to the University of Colombo for the year ended 31st December, 2005 were audited under my direction in pursuance of provisions in Article 154(1) of the Constitution of the Democratic Socialist Republic of Sri Lanka read in conjunction with Section 23 of the Institute of Workers' Education Ordiance No. 11 of 1979 enacted in terms of Section 18 of the Universities Act, No. 16 of 1978, Section 108(1) and III of the Universities Act and Sub-Section (3), (4) and (7) of Section 13 of the Finance Act, No. 38 of 1971.

Except for the effect on the financial statements of the matters referred to in para. 2.2 of my report, I am of opinion so far as appears from my examination and to the best of my information and according to the explanation given to me, that the financial statements have been prepared and presented in accordance with the Generally Accepted Principles and the stated accounting policies as set out in notes (from Note 1 to 3) to the financial statements and give a true and fair view of the financial position of the Institute, as at 31 December, 2005 and the financial results and cash flow for the year then ended.

Comments and observations arising out of the audit are contained in my report of even date addressed to the Director of the Institute of Worker's Education.
