  - "13C. Any member who has completed one year membership may be granted festival loan of Rs. 5,000/= repayable in ten (10) consecutive monthly instalements";
- (g) by the insertion immediately after rule 13F of the following new rule :-

13G. Any member who has more than five years continued membership, may be granted a loan of not exceeding rupees ten thousand (Rs. 10,000/-) in the event of his child having passed the G.C.E. (A/L) Examination. This loan shall be granted upon the production of a valid certificate issued by a recognized University or Higher Educational institute of Sri Lanka confirming that such child is following a course in higher education in such University or Higher Educational Institution. This loan shall be repaid in 36 equal monthly instalements, at an interest rate of 10 per centum (10%) per annum;

    - (iii) A certificate issued by the Medical Practitioner shall state the seriousness of the illness of the member, and recommend further medical treatment for the cure of such illness.

- (iv) It shall be lawful to establish a fund known as "the Medical Donation Fund" into which every member of the Association stall credit rupees ten (Rs. 10/-) every month."
