Report of the Auditor General on the Accounts of the University of Jaffna for the year ended 31 December, 2005 in terms of Section 108(2) of the Universities Act., No. 16 of 1978

The Audit of accounts of the University of Jaffna for the year ended 31 December, 2005 was carried out under my direction in pursuance of provisions in Article 154(1) of the Constitution of the Democratic Socialist Republic of Sri Lanka read in conjunction with Sections 108(1) and 111 of the Universities Act, No. 16 of 19 and Sub-sections (3), (4) and (7) of Section 13 of the Finance Act, No. 38 of 1971. This

report is issued in terms of Section 108(2) of the Universities Act. A detailed report in terms of Section 13(7)(a) of the Finance Act was furnished to the Vice Chancellor of the University on 19th May, 2006.

1:2 Scope of Audit

Audit opinion, comments and findings in this report are based on a review of the financial statements presented to audit and substantive tests of samples of transactions. The scope and the extent of such review and tests were such as to enable as wide an audit coverage as possible within the limitations of staff, other resources and time available to me. The audit was carried out in accordance with Sri Lanka Auditing Standards, methods and practices to obtain reasonable assurance as to whether the financial statements are free of material misstatements. The audit included examination of evidence supporting the amounts and disclosures in financial statements and assessment of accounting principles and significant estimates and judgements made in the preparation of financial statements, evaluation of their overall presentation and determining whether accounting policies adopted were appropriate, consistently applied and adequately disclosed. Sub-sections (3) and (4) of Section 13 of the Finance Act No.38 of 1971 give discretionary powers to the Auditor General to determine the scope and extent of the audit.

2. Accounts

2.1 *Audit Opinion*

Except for the effects on the financial statements of the matters referred to in paragraph 2.2 of this report . I am of opinion, so far as appears from my examination and to the best of my information and according to the explanations given to me that the financial statements have been prepared in accordance with Sri Lanka Accounting Standards and the stated accounting policies as set out in notes (No. 2) to the financial Statements and give a true and fair view of the financial position of the University as at 31 December 2005 and the financial results and cash flow for the year then ended.

2:2 *Comments on Accounts*

2:2:1 *Accounting Deficiencies*

Eighteen accounting deficiencies observed in audit test check based on sample of transactions relating to expenditure of Rs. 25,018,388 were brought to the notice of the Vice Chancellor of the University. Therefore, the possibility of similar accounting deficiencies other than the areas covered in audit cannot be ruled out.

2:2:2 *Accounts Receivables and Payables*

Following observations were made.

- (a) Confirmations had not been called for from debtors and creditors aggregating Rs. 341,525,924 and Rs. 29,659,510 respectively.
- (b) Age analysis in respect of debtors aggregating Rs. 159,872,791 and creditors aggregating Rs. 29,659,510 had not been furnished to audit.

2:2:3 *Lack of Evidence for Audit*

Assets to the value of Rs. 1,202,689,282 and expenditure aggregating Rs. 7,913,538 could not be satisfactorily vouched in audit due to lack of required evidence.

2:2:4 *Non-compliance with Laws, Rules, Regulations and Management Decisions*

Several provisions in the following laws. Treasury circulars and Financial Regulations of the Government, Establishments Code of the Democratic Socialist Republic of Sri Lanka. Establishments Code for University Grants Commission and Higher Educational Institutions had not been complied with and these non-compliances had been pointed out in my detailed report issued to the Vice Chancellor of the University.

3. Financial and Operating Review

3.1 Financial Review

3:1:1 Financial Results

According to the accounts presented, the working of the University for the year under review had resulted in a deficit of Rs. 457,391,785 before taking into account the Government grant for recurrent expenditure as compared with the corresponding deficit of Rs. 362,725,393 for the preceding year. After taking into account the Government grant of Rs. 391,000,000 received for recurrent expenditure, the deficit for the year under review had been reduced to Rs. 66,391,785 and the Government grant of Rs. 288,000,000 received for recurrent expenditure for the preceding year the deficit for that year had been reduced to Rs. 74,725,393.

3:1:2 Operation of Specific Funds

The Grants received for specific purposes and interest thereon aggregating Rs. 29,063,670 had not been utilized for the purposes for which they were granted for.

3:1:3 Uneconomic Transactions

Following uneconomic transactions were observed.

- (a) There are seventeen number self financing courses being conducted by the University. But not a single self financing course had been completed within the stipulated period. Certain courses the duration period of which was one year commenced in the year 2003 had not been completed even up to 30 April, 2006. As per accounts furnished a sum of Rs. 12,506,573 had been collected for these self financing courses at the rate ranging Rs. 30,000 to Rs. 50,000 from each student and a sum of Rs. 5,545,437 had been paid as lecture fees to the lecturers attached to the University. Further there were no information made available to audit regarding the number of students enrolled to each self financing course and number of students passed out.
- (b) Retired Lecturers are being employed on assignment basis and paid salaries on monthly basis contrary to rules and regulations. It is observed that certain staff appointed on assignment basis had filed cases in the Labour Tribunal for the entitlement of Employees Provident fund and Gratuity. The Labour Tribunal had given ruling that Gratuity and University Provident Fund that should be paid to retired lecturers engaged on assignment basis. As a result the University become liable for a commitments to the extent of Rs. 900,000 to those retired lecturers employed on assignment basis.

It should be noted that whenever necessity arise for the service of a lecturer it could be obtained on a visiting basis which is more economical.

- (c) Sixty one numbers of direct telephone lines had been provided for various facilities and service units in the University and most of the direct telephone lines had been utilised for the internal communication in the University instead of

utilising an intercom system. As a result a sum of Rs. 1,508,236 had been paid as telephone charges. This telephone charges could be reduced to Rs. 452,471 if the intercom system is used in its full capacity

- (d) Air passage had been paid for the University staff for foreign travel on Sabbatical leave before obtaining the Visas to the respective countries. Due to non issue of visas for the intended travel after purchasing the Air ticket. it was observed that this facilities had been abused by certain staff of the University.

3:1:4 *Identified Losses*

Loss of fixed assets, stores items and recoverable debts, to the value of Rs. 586,537 had been written off during the year under review.

3:1:5 *Delays in Projects*

Following observations are made.

- (a) Construction works under various projects for which agreements had been entered into as far back as 1989 had not been completed even up to 31 December 2005.
- (b) A sum of Rs. 7,611,885 had been paid to a construction company during 1999 to 2000 for the construction of a building for an auditorium at medical faculty. However, construction works had not yet been completed. Due to the undue delay, the cost of construction would have been tremendously increased and the objective of this Project had also not been achieved. In addition a sum of Rs. 6,000,000 had been paid to the Department of Buildings during the year under review for the interior decoration for the auditorium.
- (c) A sum of Rs. 2,116,555 had been spent on building materials for repairs work in addition to the salaries and wages paid to the direct employees involved in maintenance of building of the University. The Engineer in charge of the maintenance of building had given a report stating that there were no balances of building materials and other fittings given for the maintenance works, although there were unused items of building materials in the maintenance stores as at the end of the year under review. However, the buildings of the University had not been maintained satisfactorily.
- (d) A sum of Rs. 2,607,050 had been paid in December, 2005 as an advance to the Ceylon Electricity Board for the supply of bulk electricity to the faculty of agriculture although that project had not been commenced even up to 30 April 2006.
- (e) A sum of Rs. 2,000,000 had been paid to the Department of Buildings as an advance in 1989 for the construction of over head tank for students hostel at Thirunelvely. However the construction of overhead tank had not been completed even up to the date of this report. Further no information or details of this construction works had been made available for audit.
- (f) A sum of Rs. 986,552 had been allocated in the annual budget for the administrative expenditure for the proposed faculty of engineering. However, faculty of engineering had been established in the Jaffna University.
- (g) A sum of Rs. 535,540 had been collected at the rate of Rs. 65 per student for the issue of student guide. However, the students guide had not been issued to the respective students up to 30 April, 2006.

3.2 **Operating Review**

3:2:1 *Appointments to the Academic Staff*

Following observations were made.

- (a) Appointments to the permanent posts of lecturers had been made separately to each and every faculty of the University as a general rule resulting in engaging several lecturers in the same field of study. In preparing time tables for various faculties, the availability of the services of permanent lecturers in other faculties had not been considered. Whenever the service of lecturers in the permanent staff were required for another Faculty, separate letters of appointment had been issued to them as visiting lecturers and additional lecture fees had been paid for such services.

- (b) In several instances, temporary lecturers, tutors, demonstrators etc., had been appointed on the request made by the Heads of Department without following proper recruitment procedure.
- (c) The regular feature of the University that the filling of vacant posts of academic staff is in an improper manner without giving an opportunity to complete those who have qualifications and expect employment in the University system. Although this had been pointed out in my report for previous years no action had been taken to rectify this deficiencies.
- (d) A senior lecturer-Grade I and an Instructor Grade III had been reinstated after a period of 13 to 18 years absence from their service and their period of absence had been treated as special no pay leave without proper authority.

3:2:2 *Academic Activities*

A sum of Rs. 235,016,998 had been paid as salaries and allowances for 429 academic staff for having conducted lecturers at various faculties for 5,367 students. However, the following information had not been made available for audit to enable to evaluate the economy, efficiency, and effectiveness of the activities undertaken by the academic staff such as number of students in each faculty, lectures delivered by each lecturer in each faculty, number of hours lectured/performed number of examinations held, number of students passed out etc., had not been made available for audit.

3:2:3 *Courses and Examinations*

Following observations are made.

- (a) Total number of students registered for 10 courses of the University was 5367. Total recurrent expenditure incurred for those courses during the year under review amounted to Rs. 263,801,236. The average recurrent cost per student for the year was Rs. 510,923.
- (b) Dates to hold the examinations for various courses conducted by each faculty of the University and target dates to release results of the examinations had not been determined. It was further observed that there were considerable delays in releasing the results of examination conducted by certain faculties during the years 2004 and 2005. According to the University Grants Commission Circular No. 636 of 14 July, 1995 the results should be released within three months after the examination. But, results had been delayed for the period ranging from 6 months to 12 months.

3:2:4 *Granting leave with Pay and No Pay for Postgraduate Studies*

Following observations are made.

- (a) Study leave had been approved for more than one year to the lecturers who had gone abroad for studies without taking into consideration the instruction in Section 27.4 of chapter 10 of the Establishments Code for the University Grants Commission and the Higher Educational Institutions.
- (b) There were instances that study leave had been approved to the lecturers under probationary period.

3:3 *Budgetary Control*

Major variations were observed between the budget and the actual thus indicating that the budget had not been made use of as an effective instrument of management control.

4. **Systems and Controls**

Deficiencies observed during the course of audit were brought to the notice of the Vice Chancellor of the University by my detailed report issued in terms of Section 13(7)(a) of the Finance Act. Special attention is needed in respect of the following areas of control.

- (a) Personnel Management
- (b) Budget
- (c) Purchases
- (d) Stores

- (e) Debtors
- (f) Contract Administration
- (g) Library Administration
- (h) Internal Audit

AUDIT OPINION

Observation of the Governing Authority of the University of Jaffna on Report of the Auditor General on the Accounts of the University of Jaffna for the Year ended 31st December, 2005.

- 2.2.2 (a) Most of the receivable amounts represent the balance of loans/advances paid to the Employees and the payable account represent the students deposit and staff security deposit. Therefore no confirmation is needed.
- (b) Due to non submission of details of the sum of Rs. 189,532,301 by the Audit we are unable to make any comments on this observation.
Age analysis is given for all the loans/advances inclusive of supplies advance.
- 2:2:3 Due to non submission of details of the sum of Rs. 1,210,602,820 by the Audit we are unable to make any comments on this observation.
- 2:2:4 University complies with the provision in the Universities Act, E. Code and Circulars etc. as far as possible.
- 3:1:3 (a) In the year 2005 the Faculty of Graduate Studies had conducted only five different self financing courses for ten batches of Students (some of them are two years duration and some are conducted in two different centers). The main reason for the delay is getting the scripts marked by second examiners, most of whom are from outside the University. In addition to this there has been considerable delay due to the situation that prevailed in and around the University. Now we are taking every effort to complete these courses within the stipulated time.

The courses conducted by the Faculty of Graduate Studies are very popular and useful to the students in their career development and to render their services to the society in a most effective manner. Further these courses provide an opportunity for the University to achieve one of its prime objectives, which is the mission of the University.

The Faculty of Graduate Studies is conducting classes only during the week ends and after working hours. This arrangement does not in any way disturb the normal functioning of the University.

- (b) In spite of several attempts made by the University through newspaper advertisements etc the University did not receive applications to recruit staff for senior positions with the required qualifications. To keep the academic programmes going

on it became necessary to employ the retired dons. Although Cabinet memoranda were sent through the University Grant Commission to get approval for re-employment as recommended by the University Council no response was received. To carry out the academic programmes the services of Prof. V. Tharmaratnam was obtained on assignment basis. Later the UGC gave the approval to get the services of Prof. V. Tharmaratnam on assignment basis taking into consideration the lack of Senior staff in Mathematics.

The three teachers referred to in Section 3.1.3(a) of the report were employed in the previous years and not in 2005.

When there is a dearth of qualified teachers in some disciplines, and when no applications are received to fill the cadre vacancies, there is no alternative other than to employ retired staff, if they are available. Some of the departments have more than 50% of the senior cadre positions unfilled. In those Departments it is not adequate to employ outsiders or retired university teachers as Visiting Lecturers. In addition to taking Lecturers, Senior hands are required to assist, guide and supervise the students in their projects, assignments, continues assessments etc. Teachers (on contract) are appointed only to a few departments which are very much in dearth of qualified senior staff in the Faculties of Medicine and Science.

When teachers are appointed on assignment basis their fixed salary is determined as that of the basic salary of the position he/she held at the time of retirement. If these appointees are entitled to receive gratuity, ETF and UPF according to the Laws of the country, the payment of benefits shall not be considered as liability but as legal obligation.

Although economical, the needs of certain very poorly staffed departments cannot be fulfilled by visiting appointments as has been explained above.

- (c) The University has provided official telephones only to a limited number of officers who are entitled for the same.

The existing intercom telephone system (PABX system) which was installed about 25 years ago is now outdated and not functioning. The University made attempts to repair the system but did not succeed. Technical Officers from the Sri Lanka Telecom, Jaffna have also inspected the system and reported that the system cannot be repaired.

During the year 2003 tenders were invited to obtain consultancy service for the Supply, installation, testing and commissioning of a PABX system to University of Jaffna. The University Council at its 277th Meeting held on 26.07.2003 decided to with hold the memo submitted to obtain the Consultancy Service from a private Company in order to get information from other Universities regarding the network system including the intercom facilities.

Further the network system to connect all the departments and branches for inter-communication is being installed under the SIDA Project by the Faculty of Science. Hence once the installation of network system is completed, the telephone charges can be reduced.

- (d) Due to the situation prevailing in our country there was a frequent disruption in transport and communication. The staff who wants to go abroad had to make their travel arrangements within a short period. Considering the difficulties faced by the staff payments were made to the Air Lines before the visa was issued. However the University has decided to make payments after confirming that the visa had been issued.

- 3.1.5 (a) No work for which agreements were signed before 1989 remain incomplete. But Arts Faculty Complex and Ramanathan Academy of Fine Arts started before 1989 remain incomplete. As these were very big projects works were entrusted to the Department of Buildings in stages, and the completed stages(Buildings) are being used. Please note that from 1990-1996 there was total ban on transport of construction materials to the north and there were restrictions and free transport was not possible until A-09 highway was opened in April, 2002.

- (b) The Rs. 7,611,885 paid was for the balance work of stage 1 which did not include finishes, decoration, sheeting etc. After completing the documentation for interior decoration work tenders were called thrice. But on each occasion the University Tender Board could not recommend a successful bidder. Later the University Council awarded this part of the work to the Department of Buildings who needed an advance in full to start work.

- (c) There is neither a Maintenance stores nor a Store Keeper at the Maintenance Branch. The store items received from the Finance Branch are recorded in a register and issued for work. Once issued for work the balance is considered as nil. Since the Maintenance Branch was not closed during the year end and as there was continuous work there are chances of few items of job in progress available in the workshop. Some of the works continue for several days.

The amount of Rs. 2,116,555 as indicated by the Auditor General is for the minor repairs of buildings/Structure/Services and not for the day to day upkeep.

- (d) Construction of Faculty of Agriculture under NECORD funding has commenced in September 2005 at Ponnagar, Kilinochchi but behind schedule as at present.
- (e) This work was suspended by the Department of Buildings in 1990 due to war like situation in Jaffna. Subsequently two number wells and pump house were completed in 1999. We have written and reminded the Department of Buildings to complete the work on the water tank.
- (f) These allocations were made for the approved cadre of the Engineering Faculty of the University of Jaffna. No allocation has been made by the University Grants Commission for Buildings. Also the Government has not issued the required *Gazette* notification to establish a Faculty of Engineering.
- (g) Action has already been taken to issue Guide books to students by the respective Faculties. Many Faculties have published students hand books.
- 3:2:1 (a) The permanent teaching staff are involved in faculty as well as interfaculty teaching without any additional remuneration other than their salary. When the teaching load of a teacher in his/her departments/Faculty is far in excess of the approved academic norms of a particular academic position, payment is made by appointing them as visiting lecturers for the lectures they take out side their academic norms in departments out side the faculty to which they belong to. Only a small number of such visiting appointments are made under inevitable circumstances.

Cadres are determined by the University Grants Commission based on the needs of each faculty. Further although the title of the "Field of Study" may look alike, the scope of the course and the courses contents could be very different. For example the way physics, chemistry and mathematics is taught in a science faculty is different from how it is taught in an engineering faculty.

- (b) The temporary posts in Assistant Lecturer, Tutor, Demonstrator and instructors are regularly advertised before the commencement of every academic year and recruitment is made by following the proper recruitment procedure.

However when an appointed person resigns or leaves the service during an academic year and when there is no adequate time to fill the vacancy by advertisement, appointments are made on the request of the Head and the Dean in a very few occasions, so as to carry out the academic programme within the scheduled academic calendar. Such appointments (a few) are made only for the balance period of the appointments of the person resigned.

- (c) Other than getting the services of a few senior academics on work assignment (or contract) basis, no other appointments were made without giving opportunity to those who have the qualification to compete. All vacant positions are advertised regularly and all eligible applicants in terms of the scheme of recruitment are called for interviews and they are evaluated by legally constituted selection boards. Appointments are made based on the recommendations of selection committees, thereby giving opportunities to all the eligible applicants.
- (d) Both staff were reinstated as per the related Public Administration Circular No. 11/1993 of 04/06/1993 adopted by the UGC Establishment Circular letter No. 13/1993 of 14/07/1993.
- 3:2:2 The requested information shall be furnished in the future.
- 3:2:3 (b) In some Faculties examinations are conducted at the end of the academic year. In some at the end of each semester. However the results of the examinations conducted at the end of the first semester are released along with the result of the second semester. This is their examinations regulations. This is because if the results are released for each semester, there is a possibility of students skipping two out of five course units in the second semester. However, the structure of the Degree Programme are changed now and for the new batches of students results are released within three months.
- 3:2:4(a&b) The sections of the Establishment Code of the University Grants Commission and the Higher Educational Institutions referred to in these paragraphs were amended by the University Grants Commission Circular No. 429 of 02/03/1990 by which the authority is delegated to the Councils of Universities to use their discretions for the timing of granting study leave to teachers.
- 3:3 The following steps have been taken with regard to Budgetary Control.

- (i) Budget is approved by the Finance Committee & the Council annually.
- (ii) Vote Ledger is computerized in order to monitor the expenditure within the allocation.
- (iii) Monthly Comparative statement (Budgeted amount - Actual Expenditure) is placed before the Finance Committee.
- (iv) Sub imprest to the Vavuniya Campus is monitored by a separate votes ledger at the Finance Branch of the University.

4.0 (a) Every effort is taken to adopt effective system and control on the matters referred to in the report. The following steps have already been taken.

(a) Procurement and Inventory Control

Procurement: An effective system is adopted with regard to purchases. The following procedures are followed.

- (i) Items exceeding the value of Rs. 200,000 is approved by the purchasing committee.
- (ii) Quotation/tender procedure is followed depending on the value of the items.
- (iii) Report of the TEC is obtained where necessary.
- (iv) Quality is certified by a team consisting of members from user department, an officer from the supply division and Internal Auditor.
- (v) Items are taken into Inventory Register and GRN is raised before the payment is made.

Inventory Control

- (i) Receipts and issues have been computerized.
- (ii) Expenditure is accounted through monthly stores analysis.
- (iii) Two separate stores advance account namely Stores Advance Account (Supplies), Store Advance Account (Maintenance) are maintained in the Main Ledger.
- (iv) Subsidiary Store Ledger Accounts are reconciled with the Main Ledger Accounts.
- (v) Faculty wise expenditure is monitored.
- (vi) Stock balance and the value of each item could be extracted at any time.

Debtors

- (i) Loans function have been computerized and recoveries are made promptly. Balancing and reconciliation are done quarterly.
- (ii) Supplies advances are monitored periodically and prompt action is taken to receive the goods for the advances paid.
