### Notes to the Financial Statements

#### 01. Significant Accounting Policies

##### 1. General

1.1 The financial statement of the Postgraduate Institute of Medicine has been prepared on the historical basis in accordance with generally accepted accounting principles applied on a consistent basis and conformity with the Sri Lanka Accounting Standards.

1.2 Provisions have been made for all known liabilities

##### 2. Assets and the Basis of their value :

##### 2.1 Lands and Building and Equipment Depreciation

The tangible assets are shown at cost less accumulated depreciation. Depreciation is charged on straight line method at the following rates per Annum :

Depreciation has not been provided on for the year of purchase, while a Full year depreciation is provided in the year of disposal.

##### 2.2 Stocks

Stocks have been valued according to the First in First out basis.

##### 3. Provision for Gratuity

Full provision is made in the accounts for the retiring gratuity payments to all the employees from the initial year of joining the services. This provision is not extremely funded or actuarially.
