AT the meeting held on 28th September, 2005 the Board of Directors of the State Mortgage and Investment Bank resolved specially and unanimously :

1. Whereas, Ramya Attanayake of Pannipitiya has made default in the payment due on Mortgage Bond No. 4605 dated 27.08.1998 attested by I. G. Abeyasinghe, Notary Public of Colombo and a sum of Rupees Five Hundred and Twenty-four Thousand Seven Hundred and Twenty-four and Cents Sixteen (Rs. 524,724.16) is due on account of Principal and Interest as at 31.08.2005 together with further interest thereafter at Rupees One Hundred Ninety-eight and cents Thirty-eight (Rs. 198.38) per day, till date of full and final settlement, in terms of Mortgage Bond No. 4605 aforesaid (less any payments made on thereafter).
