Rules which have been passed by the Act, No. 16 of 1908 in the
Parliament and amended from time to time by the Acts No. 15 of 1931,

No. 04 of 1988 and No. 40 of 1946 and by the *Gazette* No. 7906 dated
12th February 1932 and for the last time by the *Gazette Extra
Ordinary* No. 1073/19 dated 01.04.1999 and published in the *Gazette*
dated 21.03.1997 are hereby further amended in the following manner.
These rules shall come in to force with effect from 01.01.2006.

1. Rule 7

By amending in the following manner new paragraph (1 a) which
has been included immediately after the para (a) (1) of rule 7 :-

(1 a) Minimum contribution for membership shall be Rupees Two
Hundred (Rs. 200) per month from January, 2006 and members who
exercise their option to make contribution which shall increase
consecutively, by Rupees Fifty (Rs. 50) per annum until the monthly
contribution reaches Rupees Five Hundred (Rs. 500) after a period of
6 years shall be entitled to the following benefits. Maximum contribution
for membership shall be Rupees Five Hundred (Rs. 500).

2. Rule 9

By amending in the following manner the paragraph which has been included immediately after the paragraph 2 of rule 9 :-

At the retirements, demise or expulsion from service, donations obtained from every member who has exercised option to increase contribution to the corporation as indicated in rule 9(2)(11)7(1) shall be added to the gratuity in the following manner.

24 (3) - By substituting Rs. 3,000 in place of Rs. 1,000 and by substituting Rs. 200 in place of Rs. 75.

5. Rule 31

31 - 4 (a) - Recoveries and deposits : by substituting the term "a recovery of Rs. 25 until it amounts to Rs. 250" in place of "a recovery of Rs. 10 until it amounts to Rs. 100".

31 - 4 (c) By substituting Rs. 25 in place of Rs. 10.

31 - 4 (e) By substituting Rs. 10,000 in place of Rs. 7,000.

34 - 4 (f) By amending the last sentence of this paragraph as "Every member in the corporation shall be debited an extra sum of Rs. 50 in case of death of a member".

6. Rule 32

- (a) By substituting Rs. 25,000 in place of Rs. 5,000 indicated under the heading 'Benefits'.
- (b) By substituting Rs. 25,000 in place of Rs. 5,000 indicated under the heading 'Request'.

7. Rule 33

By substituting following words and figures in place of all words indicated under the heading "Eligibility".

A member who has a continuous membership of

- (a) more than ten (10) years, shall be granted a loan of Rupees Twenty-five Thousand (Rs. 25,000) ; and
- (b) less than ten (10) years, shall be granted a loan of Rupees Ten Thousand (Rs. 10,000).

This loan shall be recovered in 60 installments and the interest to be charged shall be 12% per annum. Two members of the association, at least one with over 10 years continuous membership shall be furnished as guarantors. One guarantor is eligible to stand as surety strictly for two borrowers.

8. Rule 34

By substituting following words in place of the words indicated under the heading 'membership' in rule 34.

- (a) This scheme shall be open to all members of the Ceylon Railway Benefits Association.
- (b) This lottery shall be drawn from among the Accounts continuously maintained in the Ceylon Railway Benefits Association and the Lottery shall be organized by the committee of the said association.

Winning accounts of members shall be credited each with a sum of Rupees Two Hundred and Fifty (Rs. 250). This lottery shall be drawn every year at the annual general meeting of the association.
