## DEMOCRATIC SOCIALIST REPUBLIC OF SRI LANKA PUBLIC SERVICE PROVIDENT FUND ANNUAL ACCOUNTS FOR THE YEAR 2004

#### Review of the Board of Management

- (1) OBJECTIVE.— The Objective and the purpose of the Fund, is to afford Provident Fund benefits to those public servants who are not pensionable.
  - (2) Functions. The main functions of the P. S. P. F. are,
    - (a) To recover and credit the Fund by an amount equivalent to 8% of the monthly salaries of those who are non pensionable and are serving in the various departments of the Island and in the foreign missions abroad.
    - (b) To receive the contributions and to store, such contributions in a methodical manner.
    - (c) To process and maintain individual accounts of such contributors to enable the contributors to be notified of the amount lying to their credit at the end of each financial year, and refund the benefits at the end of contributor's service.
    - (d) To invest the excess money of the Fund in "Government securities" to enable the contributors to secure a higher interest and appropriate such interest, at the end of every financial year.
- (3) Financial Results.— The amount received as Compulsory contribution and Government contribution during the year under review was Rs.225,527,179 and Rs.251,412,810 respectively, while the contributions received during the year 2003 was Rs.168,148,320 and Rs.243,607,780 respectively. The total income from investment of the Fund after tax was Rs.978,461,203 as compared with Rs.877,860,313 last year, which is an increase of 11.46%. After providing for administrative expenses of the fund amounting to Rs.3,930,488 a sum of Rs.974,530,714 was available for appropriation as interest to the contributors. The percentage of interest thus available was 10.34% as compared with the percentage of interest of 10.51% during the previous year. However, the percentage of interest rounded up to the nearest quarter being 10.25% amounting to Rs.966,279,838 was appropriated and the balance amounting to Rs.8,250,877 was transferred to the General reserve.
  - (4) Accounting Policies
    - (a) Basis of Accounting:

The Financial statements are prepared in accordance with generally accepted accounting principals and the provision of the Public Service Provident Fund Ordinance No.18 of 1942.

 $(b) \ \ Rent, Electricity \ and \ Water \ Supply:$ 

The Board of Management of the Public Service Provident Fund decided to bear the expenses of Rent, Electricity and Water supply from the Fund commencing from the year 1993. The expenses already incurred by the Director of Pensions have been provided in the accounts on the following basis:

Report of the Auditor General on the Accounts of the Public Service Provident fund for the ended 31st December, 2004

The audit of accounts of the Public Service Provident Fund for the year ended 31st December, 2004 was carried out under my direction in pursuance of Provisions in Article 154(3) of the Constitution of the Democratic Socialist Republic of Sri Lanka read in conjunction with Section 24(1) of the Public Service Provident Fund Ordinance (Cap. 621).

1:2 Scope of Audit.— Audit opinion, comments and findings in this report are based on a review of the financial statements presented to audit and substantive test of samples of transactions. The scope and the extent of such review and tests were such as to enable as wide an audit coverage as possible within the limitations of staff, other resources and time

available to me. The audit was carried out in accordance with Sri Lanka Auditing Standards, methods and practices to obtain reasonable assurance as to whether the financial statements are free of meterial misstatements. The audit included examination of evidence supporting the amounts and disclosures in financial statements and assessment of accounting principles and significant estimates and judgements made in the preparation of financial statements, evaluation of their overall presentation and determining whether accounting policies adopted were appropriate, consistently applied and adequately disclosed.

#### 2. Accounts

- 2.1 Rendition of Accounts.—Although the annual accounts should be rendered to audit before 30th April of the following year in terms of Tresuary Circular No. 836 of 16th August, 1977, the accounts of the Fund for the year ended 31st December, 2004 were rendered to audit on 07th August, 2006 after a delay of one year and 3 months.
- 2.2 Audit Opinion.— Except for the effects of the adjustments arising from the matters referred to in paragraph 2.3 of this report, I am of opinion so far as appears from my examination and to the best of my information and according to the expianation given to me that the financial statements have been prepared and presented in accordance with generally accepted accounting principles and accounting policies set out in notes No.4 and give a true and fair view of the financial position of the Fund as at 31st December, 2004 and the financial results and cash flow for the year then ended.

#### 2.3 Comments on Accounts:

#### 2.3.1 Accounting Deficiencies. – The Following accounting deficiencies were observed

- (a) Tax amounting to Rs.12,366,029 payable on Investment Income for the year under review had not been taken into consideration in preparing the accounts for the year under review while tax amounting to Rs.10,860,504 paid on Investment Income for the preceding year had been accounted as expenditure for the year under review.
- (b) The Interest Income for the year under review had been overstated by a sum of Rs.509,340 as a result, surplus for the year had been overstated by a similar amount.
- (c) Investment income amounting to Rs.4,584,060 received during the year 2003 had been treated as income for the year under reveiw. The tax amounting to Rs.509,340 paid thereon had been shown as expenditure for the year. As a result, surplus for the year had been undersated by a similar amount.
- (d) The erroneous credit balance after setting off erroneous debits and credits, amounted to Rs.2,794,066 as at 01st January, 1990. According to the final accounts presented from 1990 to 2004, a sum of Rs. 52,450,286,664 and Rs.52,439,120,527 respectively had been shown separately as total erroneous debits and credits. A register had not been maintained in respect of this. The balances had been shown in the accounts as an erroneous debit balance of Rs.8,372,071 as at 31 December, 2004 after setting off erroneous debit and credit balances. It was observed that effective action had not been taken to settle the erroneous debit and credit balances.

#### $2.3.2\ Obtaining\ Debit\ and\ Credit\ Advices:$

According to Section 04 of the Public Service Provident Fund Circular No. 1/97 dated 31st July, 1997 of the Department of Pensions, the respective institutions should send advices relating to debits and credits to the Fund each month to the Secretary to the Fund before the 15th day of the succeeding month. However, only two institutions had sent these advices for the year under review. An efficient and effective action had not been taken even during the year under review too as previous years to obtain these advices.

#### 2.3.3 Payment of Contributions:

Instances were observed where Contributions had been paid based on abatements records certified and sent at times. Whilst the detailed obatement records had not been submitted to the fund. Therefore, in could not be satisfied in audit of the correctness of these payment.

#### $2.3.4\ Lack\ of\ Evidence\ for\ Audit:$

Although there are about 289 institutions under Provincial Councils, only 57 files had been furnished to audit for examination of contributions received relating to the year 2004. Records had not been maintained to identify separately the institutions by names and the number of institutions that should sent the contributions. Files had been maintained only in respect of the institutions that send the contributions. Therefore it could be ascertained in audit, the contributions receivable and the bonus receivable thereon.

#### 2.3.5 Interest Paid in Making Payment of Contributions:

It was observed at the examination of accounts that there had been delays often in making payment of contributions and bonus by the institutions under Provincial Concils. But, at making refunds, interest is calculated treating that the contributions has been received promptly without taking into consideration the actual date of receipt. Therefore, it was observed that interests and paid out of the Fund for contributions that had been received.

#### 3. Financial and Operating Review:

#### 3.1 Financial Results

According to the accounts presented, the financial results for the year under review was a surplus of Rs. 974,530,714, while the financial results was a surplus of Rs. 8,250,877 after appropriation. The corresponding financial results for the preceding year, was a surplus of Rs. 864,186,258 while the financial results was a surplus of Rs.1,219,923 after appropriation thus indicating an increase of financial results after appropriation by Rs.7,030,954 as compared with the preceding year.

#### 3.2 Informing the Balances of the Members Accounts to the Contributors

According to Section 25 of the Public Service Provident Fund Act, the Director of Pensions should inform the contributors after the close of the financial year, the balances of the members accounts prevailed as at 31st December. Although the total number of members of the Fund as at 31st December, 2004 was Rs. 173,002, it was intimated to me that balances as at 31st December, 2004 had been prepared only in respect of Rs. 35,000 Officers of the Reserve Police. Action had not been taken to inform the year and balances to the members for over several years due to non-receipt of abatement registers and non-maintenance of updated accounts separately for each contributor. However, updated registers of members had not been maintained to identify separately the active members and in-active members.

#### 3.3 Budgetary Control

The budget for the year 2004 furnished to audit on 12 March 2004 had not been prepared and presented in terms of Paragraph 4 of the Treasury Circular No.836 of 16 August 1977.

#### 4. Systems and Controls:

Special attention is needed in respect of the following areas of control.

- (a) Obtaining abatement registers
- (b) Obtaining contributions.
- (c) Maintenance of registers, books and records including the Cash Book
- (d) Settlement of erroneous debit and credit balances.

#### 2.1 Rendition of Accounts.-

Agree with observation

#### 2.3 Comments on Accounts:

#### 2.3.1 Accounting Deficiencies

- (a) As in previous years tax adjusments for interest was done in the year which the interest amounts was actually received. Since this fund was established by the Consolidated Fund and this Fund which contained of persons who receive salaries from the Consolidated Fund, it may be exemption from taxation and step was also taken aware Commissioner of Inland Revenue regarding this matter in written. With hope of such tax exemption, tax amounts will not be provided for interest receivable amount.
- (b) Interest warrant for these investments in year 2003 was received only in year 2004. However, Rs.5,093,400 which receivable interest for year 2003 was adjusted to profits at the time of preparation of Income and Expenditure Account for year 2003. Amount relevant for year 2004 was also adjusted to Income and Expenditure Account for year 2004.

Tax amounts for interests were adjusted as mentioned in 2.3.1 (a) above,. Therefore, disagree with the observations.

(c) Although a separate record was not maintained for erroneous debits and credits, an Adjustment Account comprising of all details on balances for each year up to 2002 was maintained in General Ledger as a memorandum Account. Accordingly, a separate Register was not maintained. A copy of the Adjustment Account in detail for year 2003 and 2004 and age analysis which prepared concering erroneous debits and credit balances to 31.12.2004. (Annex I, II, III, IV)

In order to clear these balances, step was taken to aware concerned Departments and Ministers in written and telephone conversations. However, concerned authorities were not paid any attention for those reminders.

#### 2.3.2 Obtaining debit and Credit Notices:

Agree with the observations

Debit notices were not obtained as all P. S. P. F. payments from year 2004 was made by cheques. In order to get received notices of all credits to the Fund, the concerned Departments and Ministries were informed by circulars, letters and telephone conversations. Up to date they maintain a procedure of sending a list alone with cheques or a monthly report regarding credit of the relevant amount. Settlement of balances will be executed based on such reports.

#### 2.3.3 Refund of Contributions:

All payments are being made based on Abetment Records. Contributions shall refund having obtained a Recovery Report that attested by the concerned institution which has not lodged Abatement Report but contributions were recovered for the particular year. That was caused due to receipt of Abatement Records by annually.

However, Board of Control of the Fund having met on 24.08.2005 decided to grant approval to exercise the authority to make payment based on Recovery Reports in intances where if there may be difficulty to obtain Abatement Records.

#### 2.3.4 Lack of Evidence for Auditing:

Separate record is maintained in respect of the institutions such as offices in Provincial Councils and other projects which send amounts to the fund by cheques. Separate statements are being recorded concerning each institute of respective Provincial Council. Relevant particulars are recorded only if contributions are received by the Fund from an institution.

About 192 separate files are maintained by subject clerks for contribution receipts. As these files needed for daily official requirements, part thereof would have released for the auditing. Other files may have provided if needed. Institutions which funded by foreign invested projects and that pay salaries from other funds except the Consolidated Fund do provide 12% contribution as their share. Such receives during the year 2004 is only 0.5% of the total receivables.

### 2.3.5 Interest paid in making Payment of Contribution:

This is payable from the Fund having taken into account of Abetment Records with based on the files and records which maintained for receivables to the Fund from institutions of Provincial Councils. Further, a report regarding the contributions which sent to the Fund is provided at instances when the particular institution applied for award of payments. Therefore, interests will not be paid from the Fund for contributory amounts which not received to the Fund. Accordingly, in terms of Public Service Provident Fund Act, interests will be paid in respect of the balance amounts which kept in accounts of members.

#### 3. Financial and Operating Review:

#### 3.1 Financial Results

#### $3.2\,$ Informing the Balances of Members Accounts to the Contributor :

For the time being the balances of the members' accounts up to year 1999 is forwarded. As new computer program is preparing presently action will be taken to inform balances of the accounts of members after having inserted data of members. Agree with the observations.
