## NOTES TO THE ACCOUNTS

### 1. GENERAL ACCOUNTING POLICIES

- 1.1 The financial statement of the Institute have been prepared on historical basis in accordance with generally accepted accounting principles applied on a consistent basis and in conformity with Sri Lanka Accounting Standards.
- 1.2 Provisions have been made for all liabilities.
- 1.3 Income and expenditure with regard to academic programmes have been accounted on cash basis. Equivalent amount of income to the expenses of the programs during the financial period have been transferred to income & Expenditure Account. Balance Income of the programmes has been recognized under restricted funds.
- 1.4 Income of academic programmes will be recognized at the end of the budgeted period.

### 2. ASSETS AND THE BASIS OF VALUATION

- 2.1 Depreciable assets are depreciated and provision for depreciation is made on ledger Balances.
- 2.2 Fixed Assets shown at cost less accumulated depreciation. Depreciation has been charged on cost of the assets at the following rates per annum in order to write off such assets over their estimated useful economic lives.

Building & Structures	5%
Furniture & Equipment	10% / 20%
Motor Vehicles	20%
Computers	20%
Library Books & Periodicals	20%
Other Assets	10% / 20%

- 2.3 Ledger Balance of the stocks is shown in the Accounts.

### 3. LIABILITIES AND PROVISIONS

Full Provision is made in the accounts for retiring gratuity payable to all employees of the Institute. The provision in not representing equivalent amount of fund and made out of treasury grant.

### **Auditor General's Report on the Financial Statements of the Institutes of Human Resources Development affiliated to the University of Colombo for the year ending 31st December 2006 in terms of Section 108 (2) of the Universities Act No. 16 of 1978 and section 13 (7) (A) of the Finance Act No. 38 of 1971**

Financial Statements of the Human Resources Development Institute affiliated to the University of Colombo were audited under my direction in terms of Article 154 (1) of the Constitution of the Democratic Socialist Republic of Sri Lanka read with section 23 of the Human Resources Development Institute Regulations No. 11 of 1979 enacted in terms of section 18 of the Universities Act No. 16 of 1978, section 108 (1) and 111 of the Universities Act and sub-sections (3), (4) and (7) of section 13 of the Finance Act No. 38 of 1971. This report is issued in terms of Section 108 (2) of the Universities Act and Section 13 (7) (A) of the Finance Act No. 38 of 1971.

- 1.2 Scope of Audit.- Audit opinion comments and findings in this report are based on a review of the financial statements presented to audit and substantive tests of samples of transactions. The scope and extent of such reviews and tests were such as to enable as wide and audit coverage as possible within the limitations of staff, resources and time available to me Audit was carried out in accordance with the Sri Lanka Audit Standards, systems and practices in order to obtain a reasonable confirmation that the financial statements are free from pro rata erroneous statements. Checking of evidence in support of values and findings in the financial statements, assessment of accounting principles, vital estimates and conclusions followed in preparing the financial statements, evaluation of entire presentation of financial statements and suitability of accounting policies used, whether

they have been uniformly followed and whether adequate disclosures have been made all these were included in the audit. Sub sections (3) and (4) of section 13 of the Finance Act, No. 38 of 1971 gives discretionary powers to the Auditor General to determine the scope and extent of the audit.

## 2. Financial Statements :

2.1 *Opinion.*- As appeared at my investigations and in accordance with the maximum information and clarifications furnished to me, the Human Resources Development Institute of the University of Colombo has maintained proper accounting books, for the year ended 31st December 2006 and subject to the impact of the comments appearing in paragraph 2.2 of this report on Financial statements. I am of opinion that the financial statements presented have been satisfactorily prepared in accordance with the abovementioned books and Sri Lanka Accounting Standards and accounting policies referred to and also in accordance with schedules furnished with the financial statements (B-1 to B-21 and P-1 to P-6)

## 2.2 *Comments of Financial Statements :*

2.2.1 Accounting Deficiencies.- Sum of Rs. 625,050 credited by the Bank to the self financing Courses Account in the year 2006 has been shown as an unidentifed credit without bringing it into account duly identified.

2.2.2 Accounts Receivable.- Under the miscellaneous Advance Account there was an unsettled advance of Rs. 226,741 which is more then 10 years old.

### **Non-compliance with laws, Rules, Regulations and Management Decisions**

Instances of noncompliance with laws, rules, regulations etc, are given below :

#### *Reference to laws, Rules, Regulations etc.*

#### *Noncompliance*

University Grants Commission's  
Circular No. 861 dated 26th April 2005

(i) 58 members of the staff who participated in the work connected with the final examination of the English Language Certificate Course had been paid Rs. 186,350 Where as the amount payable was Rs. 25,925 an thus incurring an overpayment of Rs. 160,425

(ii) Payments for work connected with Teachers English language Certificate Course No. 24 and No. 25 and English Language Certificate Course No. 02 and 03 had been paid in violation of the circular. In this connection reply of the Director of Institute is as follows.

"All these examinations were conducted during week ends. In terms of the Circular No. 861 all members of the staff are entitled to the government approved overtime allowance or holiday allowance in addition to the allowances mentioned in the circular. The academic committee of the Institute has approved payment of earned amounts duly prepared in accordance with the circular.

## (b) Government Financial Regulations :

(i) F. R. 756

No Survey had been held after the year 2002 in respect of library books and periodicals valued at Rs. 2,996,022

(ii) F. R. 880

No action had been taken to obtain any security from the officer who is the custodian of money.

## 2.2.3 Transactions leading to Disputes.- Following observations are made –

(a) A sum of Rs. 126,124 had been paid in the year 2006 as salaries and incentives on account of the second and third language proficiency in terms of the circular issued by the University Grants Commission in violation of the Public Enterprises Department Circular No. 95 of 4th June 1994,



- (b) A sum of Rs. 10,000 as Long Service Allowance, a sum of Rs. 18,000 as honorarium to an officer and a sum of Rs. 200,350 as incentives to officers for the English Certificate Course No. 24 had been paid in violation of the Public Enterprises Department Circular No. 95 of 14th June 1994. Further a sum of Rs. 27,500 had been paid to six officers who came from outside the institute on public holidays to serve in the interview boards for selecting candidates to follow the degree course on labour education.

### 3. Financial and Operational Review :

- 3.1 *Financial Results.*- According to the accounts submitted the working of the Institution for the year ended December 31, 2006 resulted in a deficiency of Rs. 17,011,739 prior to taking into account, the government grant for recurrent expenditure, as compared with the corresponding deficiency of Rs. 15,644,515 for the previous year. In view of the government grant of Rs. 15,480,000 for recurrent expenditure, the deficiency for the year under review was reduced to Rs. 1,531,739 in view of the government grant of Rs. 11,800,000 for recurrent expenditure in the previous year the deficiency for that year was reduced to Rs. 3,844,815.

### 3.2 *Performance :*

following observations are made :

- (a) Number of students registered in the year 2006 for the Degree Course in Labour Education registered in the principal degree course conducted by the Institute is 712 which reflected an increase of 88 students over the previous year's registration. Release of results of the examinations held in the year 2006 took more than 30 months except in the case of one examination.
- (b) 05 fee levying courses had been conducted during the year 2006 and the total number of students participated in these was 2,778.187 students being 7% of the total students did not sit the examinations. Number of failures was 132 and it amounted to 5% of the total students.
- (c) The amount collected as course fees during the year 2006 was Rs. 10,355,000 and this shows 4% decrease when compared with the previous year's collection.
- (d) 3075 hours were allocated in the year 2006 for the degree course in Labour Education and the total lecture hours amounted to 2,810. This represented 91%. Of the total lecture hours, 445 hours were used by the two internal lecturers while 2365 hours, were used by the external lecturers. Accordingly of the total lecture hours the internal lecturers used 16%. The total cost of external lectures amounted to Rs. 1,060,856 the average cost per external lecture hour being Rs. 449.
- (e) A lecturer in the Drug Abuse Management Study Diploma Course No. 02 and No. 03 was given a maximum of 50 lecture hours and he was required to lecture at least for 13 hours. No academic time table had been utilized for this course and no lecture was required to complete a specific number of lecture hours. Similarly out of the 13 visiting lecturers of this course, except one, all the others had not completed 50 hours of lecturers. There were three lecturers who had conducted lectures for less than 13 hours.
- 3.3 *Irregular Payment.*- Although a sum of Rs. 154,500 had been spent on the preparation and revision of Course material for the English Certificate Course, no material alterations or revisions could be found when the course material connected with these payments were compared with the previous course material prepared by the same coordinator.
- 3.4 *Budgetary Control.*- There were considerable variations between the estimated expenditure/income included in the budget for 2006 and the actual expenditure/income, Accordingly it was observed that the budget for the year under reference had not been utilized as an effective management controlling tool.
