#### NOTES TO THE ACCOUNTS

1. General Accounting Policies :

1.3 Income and expenditure with regard to academic programmes have been accounted on cash basis. Equivalent amount of income to the expenses of the programmes during the financial period have been transferred to Income & Expenditure Account. Balance Income of the programmes has been recognized under current liabilities.

1.4 Income of academic programs will be recognized at the end of the budgeted period.

2. Assets and the Basis of Valuation :

2.1 Depreciation has not been provided on for the year of purchase of all assets, while full year depreciation is provided in the year of disposal.

2.2 Fixed Assets shown at cost less accumulated depreciation. Deprecation has been charged on cost of the assets at the following rates per annum in order to write off such assets over their estimated useful economic lives.

Building & Structures	5%
Furniture & Equipment	10%
Motor Vehicles	10%
Computers	20%
Library Books and Periodicals	10%
Other Assets	10%

2.3 Vehicle is registered under the Register of the University of Colombo and value of the vehicle has been recorded in the account.

2.4 The Building is used by the Faculty of Education & the National Institute of Library and Information Sciences. Value of the building Rs. 47,532,868.44 is not taken into accounts.

2.5 Closing stock of consumable stock has been valued at cost.

3. Liabilities and Provisions :

3.1 Full Provision is made in the accounts for retiring gratuity payable to all employees of the Institute. The provision is not representing equivalent amount of fund and payments are made out of Treasury grant.

**Report of the Auditor General on the Financial Statements of the National Institute of Library and Information Sciences Affiliated to the University of Colombo for the year ended 31 December 2006 in terms of Section 108(2) of the Universities Act, No. 16 of 1978 and Section 13(7) (a) of the Finance Act, No. 38 of 1971.**

THE audit of the financial statements of the National Institute of Library and Information Science Affiliated to the University of Colombo for the year ended 31 December 2006 was carried out under my direction in pursuance of provisions in Article 154(1) of the Constitution of Democratic Socialist Republic of Sri Lanka read in conjunction with Section 108(1) and 111 of the Universities Act, No. 16 of 1978 and Sub-sections (3), (4) and (7) of Section 13 of the Finance Act, No. 38 of 1971. This report is issued in terms of Section 108(2) of the Universities Act and Section 13(7) (a) of the Finance Act.

#### 1.2 *Scope of Audit*

Audit opinion, comments and findings in this report are based on a review of the financial statements presented to audit and substantive tests of samples of transactions. The scope and extent of such review and tests were such as to enable as wide and audit coverage as possible within the limitations of staff, other resources and time available to me. The audit was carried out in accordance with Sri Lanka Auditing Standards, methods and practices to obtain reasonable assurance as to whether the financial statements are free of material misstatements. The audit included examination of evidence supporting the amounts and disclosures in financial statements and assessment of accounting principles and significant estimates and judgments made in the preparation of financial statements, evaluation of their overall presentation and determining whether accounting policies adopted were appropriate, consistently applied and adequately disclosed. Sub-sections (3) and (4) of Section 13 of the Finance Act, No. 38 of 1971 give discretionary powers to the Auditor General to determine the scope and extent of the audit.

#### 2. *Financial Statements*

##### 2.1 *Opinion*

So far as appears from my examination and to the best of my information and according to the explanations given to me, I am of opinion that the National Institute of Library and Information Science has maintained proper books of account for the year ended 31 December 2006 and except for the effects on the financial statements of the matters referred to in paragraph 2.2 of this report, the financial statements which are in agreement with the said books have been prepared and presented in accordance with Sri Lanka Accounting Standards and the stated accounting policies and the Notes, (No.01 to 09) to the financial statements and give a true and fair view of the financial position of the National Institute of Library and Information Science as at 31 December 2006 and the financial results of the operations and cash flows for the year then ended.

##### 2.2 *Comments on Financial Statements*

###### 2.2.1 *Accounting Deficiencies*

The draft financial statements were presented for audit on 28 February 2007. Those financial statements were examined and the accounting deficiencies detected were pointed out in audit. Subsequently, the amended financial statements rectifying such deficiencies were presented for audit again on 18 April 2007. Further deficiencies observed in those financial statements are given below.

- (a) A sum of Rs. 879,394 received for the year 2006 in connection with sundry courses had been brought to account under the Development Fund, thus understating the income of the year by that amount.
- (b) The increase of funds amounting to Rs. 879,394 that should have been shown under the Operating Activities in the Cash Flow Statement had been shown under the Financing Activities.

### 2.2.2. *Non-compliance with Laws, Rules and Regulations*

The following instances of non-compliance were observed :

(c) National Institute of Library and Information Science Ordinance No. 01 of 1991–Section 12(6)	The Academic Committee should conduct not less than ten (10) meetings in each year. Nevertheless, only 07 Committee meetings had been conducted in the year 2006.
(d) Financial Regulation 756(1)	Even though a Board of Survey should be appointed before 15 December of each year, it had not been done so.
(e) Letter No. UGC/F/GA/2002 dated 13 January, 2003 of the Chairman of the University Grants Commission	Contrary to such instructions, a Development Fund had been established and course fees amounting to Rs. 879,394 had been credited to that Fund.

### 2.2.3. *Transactions not Supported by Adequate Authority*

The following observations are made :

- (a) Even though the Circular No. BD/PF/1/174/1 dated 25 October, 2002 of the Director General of Public Enterprises had instructed that the allowance for proficiency in the second and third languages should not be made applicable to Public Corporations and Boards, contrary to such instructions a sum of Rs. 16,860 had been paid as salaries and allowances for proficiencies in second and third languages.
- (b) An overpayment of contributions amounting to Rs. 82,356 had been made to the Universities Provident Fund and the Employees' Trust Fund due to the erroneous inclusion academic allowances to the salary. Even though the Director General of National Budget had, by his letter No. BD/INS/CLUS-A/078 of 18 July 2003, stated that the payment was irregular and that the payments made should be recovered, no action had been taken in compliance.

## 3. *Financial and Operating Review*

### 3:1. *Financial Results* :

According to the financial statements presented, the working of the Institute for the year ended 31 December, 2006 had resulted in a deficit of Rs. 9,911,824 before taking into account the Government Grant for recurrent expenditure as compared with the corresponding deficit of Rs. 6,612,420 for the preceding year. The Government Grant of Rs. 5,927,000 received for the recurrent expenditure of the year under review had reduced that deficit to Rs. 3,984,824 while the Government Grant of Rs. 3,883,000 received for the recurrent expenditure of the preceding year had reduced the deficit for the year to Rs. 2,729,420.

### 3.2. *Performance*

The National Institute of Library and Information Sciences had been established on World Bank aid under the Second General Education Project.

According to the Project Plans, the primary objective of the institute is making provision for improvement of libraries and the Education, Training and Research in the Branches of Library and Information Science.

The activities expected to be carried out for the achievement of the objectives are given below.

- (i) Establishment of the Institute ;
- (ii) Recruitment of Academic and Non-academic Staff ;
- (iii) Training of the Academic and Non-academic Staff locally and abroad ;
- (iv) Improvement of the Libraries and the Computer Unit of the Institute ;
- (v) Commencement of Courses ;
- (vi) Training of between 300-400 Teacher Librarians annually.

The following matters were observed during the course of audit :

- (a) Even though the training of 300-400 Teacher Librarians annually is the main objective of establishment of the Institute, the number of students registered under each course since the establishment of the Institute in the year 1999 up to 31 December of year under review stood at 610. The number of students who participated at one-day and two-day workshops stood at 3,572 and the number of students who obtained certificates on completion of the courses stood at 97. Therefore, the number of students who obtained certificates on completion of courses as a percentage of the number of registered students amounted to 16 per cent. The number of Teacher Librarians trained during the year under review stood at 90 but no certificates had been awarded.
- (b) The number of students registered for courses during the year 2006/2007 as compared with the year 2005/2006 disclosed a decrease of 44 or 37.93 per cent.
- (c) A sum of Rs. 163,454 had been spent on the publication of newspaper notices on various occasions for the conduct of 9 courses during the year 2006. Nevertheless two courses had not been conducted as a number of students sufficient for the courses had not been registered, while the number registered for the other courses stood at 134. Therefore, it is observed that sufficient number of students do not register for the courses. The Directress informed that the teachers do not show much interest in registration for the courses, due to the problematic state prevailing in the Ministry of Education with regard to Teacher Librarians, that is, the unsettled conditions relating to the designation of Teacher Librarians, criteria for their promotions, etc.

### 3.3 *Idle Money*

It was observed in audit that idle cash balances accumulate in Fund Accounts due to the crediting of income received annually to such Fund Accounts. However, a sum of Rs. 3,458,373 remained in seven day call deposit investments and a current account as at 31 December, 2006.

### 3.4 *Budgetary Control*

Significant variances were observed between the budgeted and the actual income and expenditure, thus indicating that the budget had not been made use of as an effective instrument of management control.

## 4. *Systems and Controls*

Special attention is needed in respect of the following areas of control :

- (a) Inventory Stocks Control ;
- (b) Collection and Accounting for Income ;
- (c) Maintenance of Books and Registers relating to Courses and Workshops'

**Report of the Auditor General on the Accounts of the National Institute of Library and Information Sciences affiliated to the University of Colombo for the year ended 31 December 2006 in terms of Section 108(2) of the Universities Act, No. 16 of 1978 and Section 13(7) (a) of the Finance Act, No. 38 of 1971**

THIS has reference to your Report No. CE/G/NILIS/FA/2006 dated 31 August, 2007 on the accounts of this institute.

Following are our replies on the audit observation made by the Auditor General's Department on the final accounts of year 2006.

**2. Accounts**

*2.2 Comments on Accounts*

*2:2:1. Accounting Deficiencies*

- (a) After completion of academic programs started in 2006 and before, course income of Rs. 879,394 has been transferred to the development fund of the Institute as a result of Board of Management decision.
- (b) As a result of the above decision, this income was treated as a change in internal fund instead of operational income of the year.

*2:2:2. Non-compliance with Laws, Rules and Regulations*

- (a) The financial statements of the institute have been published in the *Gazette* in accordance with Section 109 of Universities Act, No. 16 of 1978.
- (b) Actions have been taken to submit the Annual Report of the Institute of Parliament according to Section 110 of Universities Act, No. 16 of 1978.
- (c) In accordance with the Section 12(6) of the National Library & Information Sciences Ordinance No. 01 of 1991 ten meetings of the Academic Committee were scheduled per year but scheduled three meetings scheduled could not be held due to lack of the quorums.
- (d) Board of Survey was appointed after due date. But the report has been submitted to the Audit.
- (e) Balances of the completed Budgets have been transferred to the Development Fund according to the decision of the Board of Management.

*2:2:3. Transactions not supported by Adequate Authority*

These two allowances have been paid in accordance with the circular instructions issued by the University Grants Commission. No instruction has been issued by the UGC to discontinue the payments.

**3. Financial and Operating Review**

*3.1 Financial Results*

Agreed with the observation made in the Report.

*3.2 Performance*

*Conducting Courses*

- (a) & (b) The Institute was established in 1999 under the ordinance but fulltime Director was appointed in January 2002. The curricula developments and approval of the Senate of the University have taken place thereafter. Post-graduate and Non Post-graduate courses were started in June 2003. 4182 students have been trained by the Institute by the end of 2005. (pl. see Annexe Nos. 1&2) No. of students trained during the year 2006 was indicated in Annexe No. 3.

(b) Paper advertisements were made to promote courses of the institute and image of the Institute. In the year of 2006, 399 students have been trained according to the annexed No. 03. Adequate numbers of students for the Teacher Librarian programs were not registered due to the problem in the designation of the Teacher Librarian. The promotion and designation of the Teacher Librarians have not yet been finalised by the Ministry of Education. Therefore, Teachers are reluctant to register for these programs. Ministry of Education has taken steps to solve these problems.

### 3.3 *Idle Money*

Cash balance arises as incomes of the programs have been received from students at the beginning of the programs and expenditure is spread out throughout the year.

### 3.4 *Budgetary Control*

Action will be taken to use the Budget of the Institute as an effective management tool for control purposes.

## 4. **Systems and Control**

Action will be taken to improve the controls over stocks, income of programs and maintain of books of workshops.
