1. Camp Area:-

"Camp area" means (a) the area within a radius of a mile from the ford of the Manik Ganga at Kataragama and (b) the area within a radius of a quarter mile from the Pillayar Kovil at Sella Kataragama.

2. Construction of Buildings:-

No person shall construct any building or boutique whether permanent or temporary within the camp area during the period of 3rd July, 2008 to 19th July, 2008 without a written permission obtained from me or from any other authorized officer.
