NOTES TO THE FINANCIAL STATEMENT

UNIVERSITY OF SRI JAYEWARDENEPURA

01. Significant Accounting Policies

1.1 General:

The financial statements of the University have been prepared in accordance with the Sri Lanka Accounting Standards on the historical cost basis. The transactions are recorded at a value prevailing at the dates when the assets were acquired, the liabilities

were incurred and funds received in accordance with generally accepted accounting principles consistent with those used in the previous year.

1.2 Assets and Basis of their Valuation:

The fixed assets are shown at cost less accumulated depreciation. All assets have been recorded at cost of purchase with incidental expenses. Assets reveived as donations have been valued at their cost.

1.3 Depreciation of Non Current Assets:

Depreciation is charged on straight line method at the following rates per annum in order to write off the cost of such assets over their estimated useful lives:

Building - including Structures	5%
Furniture and Fittings	10%
Office Equipment	20%
Books and Periodicals	20%
Motor Vehicles	20%
Lab and Teaching Equipment	20%
Cloaks	20%

1.4 Inventories:

The first in first out method (FIFO) is adopted to valued a cost of stock. Stock were physically verified and valued to ascertain the current value as at the balance sheet date.

1.5 Provision for Gratuity:

Provision for gratuity has been calculated only for the staff who have completed five (5) years at the University services.

1.6 Provision for Accruals and Liabilities:

Provision for accruals and liabilities are provided based on the available supporting documents.

1.7 Receivable:

A sum of Rs. 41,482,365 is due from employees on account of Breach of Contracts as at 31.12.2006.

1.8 Construction Contract:

Contract of Rs. 150 million for construction of new hostel project for 400 students at lower playground was awarded to Central Engineering Consultancy Bureau on a Specific Cabinet approval under turnkey contract basis.

Report of the Auditor General on the Financial Statements of the University of Sri Jayewardenapura for the Year ended 31 December 2006 in Terms of Section 108 (2) of the Universities Act, No. 16 of 1978 and Section 13 (7) (a) of the Finance Act, No 38 of 1971

The audit of financial statements of the University of Sri Jayewardenapura for the year ended 31 December 2006 was carried out under my direction in pursuance of provisions in Article 154 (1) of the Constitution of the Democratic Socialist Republic of Sri Lanka read in conjunction with Sections 108 (1) and 111 of the Universities Act, No. 16 of 1978 and Sub – sections (3), (4) and (7) of Section 13 of the Finance Act, No 38 of 1971. This report is issued in terms of Section 108 (2) of the Universities Act and Section 13 (7) (a) of the Finance Act.

1.2 Scope of Audit:

Audit opinion, comments and findings in this report are based on a review of the financial statements presented to audit and substantive tests of samples of transactions. The scope and the extent of such review and tests were such as to enable as wide an audit coverage as possible within the limitations of staff other resources and time available to me. The audit was carried out in accordance with Sri Lanka Auditing Standards methods and practices to obtain reasonable assurance as to whether the financial statements are free of material misstatements. The audit included examination of evidence supporting the amounts and disclosures in financial statements and assessment of accounting principles and significant estimates and judgments made in the preparaion of financial statements evaluation of their overall presentation and determining whether accounting policies adopted were appropriate consistently applied and adequately disclosed. Sub - sections (3) and (4) of Section 13 of the Finance Act, No. 38 of 1971 give discretionary powers to the Auditor General to determine the scope and extent of the audit.

2. Financial Statements:

2.1 Opinion:

So far as appears from my examination and to the best of my information and according to the explanations give to me, I am of opinion that the University of Sri Jayewardenapura had maintained proper books of account for the year

ended 31 December 2006 and except for the effects on the financial statements of the matters referred to in paragraph 2.2 of this report, the financial statements which are in agreement with the said books have been prepared and presented in accordance with Sri Lanka Accounting Standards and the stated accounting policies and the Notes (No. 01 to 20) to the financial statements and give a true and fair view of the financial position of the University of Sri Jayawardenapura as at 31st December, 2006 and the financial results of its operations and the cash flows for the year then ended.

2.2. Comments on Financial Statements

2.2.1 Sri Lanka Accounting Standards:

The following non compliances with Sri Lanka Accounting Standards were observed:

- (a) Fully depreciated assets which are still being used had not been revalued and brought to accounts in terms of Sri Lanka Accounting Standard No. 18. Accordingly, Water Supply Scheme, Telephone Board and the Electricity Scheme the original cost of which was Rs. 14,056,745 represented such assets;
- (b) In addition buildings, motor vehicles, books, laboratory equipment, office equipment and cloaks with an accumulated depreciation valued at Rs. 735,499,868 had not been revalued in terms of Sri Lanka Accounting Standard No. 18.

The Vice Chancellor informed me that it is not possible to adopt revaluation as a policy as the revaluation of assets involves heavy expenditure.

2.2.2. Accounting Deficiencies:

The following accounting deficiencies were observed:

- (a) Even though a sum of Rs. 10.4 million had been shown in the financial statements as course fees the total receipts during the year according to the classification registers of the Faculty of Postgraduate Studies amounted to Rs. 26 million;
- (b) The accrual concept had not been adopted in accounting for interest income on investments and the total interest received had been brought to account under income.

2.2.3. Accounts Receivable and Payable:

The following observations are made:

- (a) Amounts due to the University aggregating to Rs. 66,523,966 and amounts payable by the University amounting to Rs. 19,103,205 had not been confirmed by the relevant parties. No action had been taken to settle those amounts;
- (b) Action had not been taken for the recovery of loan balances amounting to Rs. 2,582,800 remaining without being recovered over a number of years and to settle the over-recoveries amounting to Rs. 55,089. The recovery of loan instalments on loans granted to certain officers had been delayed. Staff loan balances had been understated by Rs. 14,540 and overstated by Rs. 2,290 during the year under review;
- (c) A proper register for recording information on teachers proceeding abroad scholarships on academic leave had not been maintained. The number of teachers who had proceeded abroad in such manner and breached the agreements by not reporting for service after the expiry of the specified period stood at 43 and a sum of Rs. 36,250,676 was due to the University from them for the breach of agreements. An adequate course of action had not been taken for the recovery of such amounts.

2.2.4. Non-compliance with Laws, Rules, Regulations and Management Decisions:

Two retired officers had been re-employed and paid a sum of Rs. 245,429 as allowances from May to August 2006

(d) University Grants Commission Circulars:

Promotion granted to a teacher had been backdated and salaries and allowances amounting to Rs. 855,269 had been paid for the backdated periods

2.2.5 Transactions not supported by Aequate Authority:

The following observations are made:

- (a) Officers serving in other Universities who held temporary posts in the University of Sri Jayawardenapura while on sabbatical leave had been paid a sum of Rs. 934,947 as allowances from the year 2000 up to date. Nevertheless, the Treasury authority had not been obtained in that connection.
- (b) The estimates of income and expenditure of the Masters Course in Multidiscipline and Technology Conducted on fee charging basis had been prepared to result in a saving of 22 per cent. Even though the savings of the preceding years should have been credited to the University Fund, it had not been done so and a sum of Rs 668,228 out of that had been utilized for the purchase of a mechanical stability machine during the year under review.

3. Financial and Operating Review:

3.1 Financial Review

3:1.1. Financial Results

According to the financial statements presented the working of the University for the year ended 31st December, 2006 had resulted in a deficit of Rs. 908,325,284 before taking into account the Government grant for recurrent expenditure as compared with the corresponding deficit of Rs. 698,633,139 for the preceding year. Due to the Government grant amounting to Rs. 827,649,735 received for recurrent expenditure of the year under review the deficit was reduced to Rs. 80,675,549 and due to the Government grant amounting to Rs. 661,066,382 received for recurrent expenditure of the preceding year the deficit of that year was reduced to Rs. 37,566,757. In addition to the Government grant, other income of Rs. 63.7 million representing an increase of Rs. 37.4 million or 70 per cent over the preceding year had been earned.

3.2 Operating Review

3:2:1. Academic Activities

The following observations are made.

- (a) During the year under review 7,094 students had been studying in the 4 Faculties of the University while the cost incurred thereon amounted to Rs. 978,932,558. The annual cost per student amounted to Rs. 137,994.
- (b) Even though an imporvement or an equal status was shown in the enrolment of new students to the Medical, Management and Arts Faculties, a considerable decrease relating to two courses of the Faculty of Applied Science was observed. Details appear below.

(c) During the year under review 1745 students had followed academic studies in the Faculty or Postgraduate Studies while an income of Rs. 3,048,305 had been earned.

- (d) The number of students registered in the External Examinations Division in the year 2006 stood at 13,555 while its income amounted to Rs. 47,029,569. Nevertheless the marking of the answer scripts of external examinations had taken 11 months.
- (e) All Faculties except the Medical Faculty had taken more than 6 months for marking of answer scripts of internal examinations, thus revealing a delay in the release of results.
- (f) The academic staff of the University comprised 432 members and 83 of them had been on sabbatical leave or academic leave.

3:2:2 Performance on Examinations:

(a) Even though the final reporting period relating to the examinations conducted by Faculties had elapsed the Examiners had not submitted the reports even up to 31st December 2006. Details appear below.

(b) Even though an interim report once in three months and a half yearly report once in every 6 months should be furnished to the Committee by the lecturers after the commencement of research works, it had not been done so.

3:2:3. Hostel Administration:

- (a) A large number of unauthorized students are occupying the hostels and as a result, the registered students could not obtain at least the minimum facilities. In view of this position the University had to incur a heavy expenditure to maintain the hostels.
- (b) Fourteen houses had been taken on lease rent basis from private parties to provide hostel facilities to 543 students and a sum of Rs. 5, 391,000 had been paid during the year under review as lease rent. Accordingly the annual average cost per student amounted to Rs. 9,928.

3:3 Mangement Inefficiencies

The following observations are made.

(a) A sum of Rs. 1,229,214 had been paid to two consultants appointed on assignment basis for the finalization of action on the publication of the annual reports from the year 1995 to 2003 and on the recovery of compensation from the teachers who had breached agreements. Nevertheless the work completed had been limited only to the handing over of the annual reports up to the year 2004 for printing and the finalization of the annual report for the year 2005.

- (b) Delays in the settlement of advances for research works were observed and a sum of Rs. 103,000 had not been settled as at 31 December 2006. Out of that, a sum of Rs. 75,000 was due from a teacher who had resigned from service.
- (c) Audit examinations revealed major deficiencies such as the failure to file adequate documents to establish the correct value in the computation of bond value in the event breaching the agreements, failure to taken adequate and speedy action for recovery of compensation deciding on recovery of compensation in instalments and lack of proper follow up action on the recovery in instalments.
- (d) Out of a sum of Rs. 3.5 million received under the Project for Training of Daham Pasel Teachers commenced in the year 2004, a sum of Rs. 131,149 had been spent. An examination of the progress thereon revealed that even after the elapse of two years the Project work is carried out at a very slow pace.
- (e) Although a sum of Rs. 24 million had been paid up to the year 1998 in three instances in respect of the acquisition of the land "Meth Sevana" for the Faculty of Medicine of the University the land had not been acquired by the University. The following observations are made in this connection.
 - (i) The Western Provincial Council had increased the value of that land up to Rs. 80 million for its acquisition. The reason for this had been an attempt made to acquire the land without a proper plan and entering into agreement.
 - (ii) The sum of Rs. 24 million paid to the Western Provincial Council had been shown in the accounts under the current assets as well as current liabilities.
- (f) The balance shown under the Trade and other Advances in the year under review included a balance of Rs. 1,070,154 brought forward over a period exceeding 5 years without taking action for its recovery.

3:4 Contract Administration:

The failure to complete the contracts awarded to external contractors within the agreed periods had been a regular feature. The reasons adduced for extension of contract periods had been inadequate and most of the delays had been due to the weaknesses of the institution.

3.5 Idle and Underutilized Assets:

The following observations are made.

- (a) A land 41.3 perches in extent purchased for Rs. 1.6 million for the construction of a hostel to provide facilities to 300 students had not been utilized for any purpose whatsoever up to the end of the year under review.
- (b) Even though a sum of Rs. 940,188 had been spent in the year 2001 as capital advances on the Project for the disposal of sewage it had not been carried out even up to the end for the year 2006. A consultation fee of Rs. 2,070,000 had been paid to the National Water Supply and Drainage Board even during the year unde review.

3:6 Irregular Transactions:

The following observations are made.

- (a) In terms of Section 99 of Part xii of the Universities Act, No 16 of 1978, money received by the University from whatever source should be credited to the University Fund. Ultra Vires such provisions, a Fund called Vice Chancellor's Fund had been established with effect from the year 1995 on the approval of the Board of Governors of the University and expenditure on the welfare of various individuals had been incurred there from. The opening balance as at 01 January 2006 amounted to Rs. 1,237,614 and such expenditure incurred during the year under review amounted to Rs. 338,566.
- (b) A sum of Rs. 595,848 had been spent out of the University Fund on the approval of the Board of Governors, in connection with the foreign tour of retired Professor and a Professor serving on contract basis attached to two projects implemented under the SIDA SAREC Programme.
- (c) A sum of Rs. 1,310,000 had been paid on 17 February 1999 without an agreement to the Pradeshiya Sabha for the construction of a drains system for draining of rainwater in the University. Nevertheless, the University had not taken action to get the work done or to recover the money even after the elapse of 8 years.

3.7 Matters of Contentious Nature:

A sum of Rs. 70,344 had been paid as salary and allowances to a University teacher while serving as a Director of another institution. A sum of Rs. 170,310 had been paid to another University teacher in respect of a period of 3 months during which he had not served the University.

3:8 Annual Reports:

The draft annual report for the year under review had not been furnished to audit.
