03. *Beggars:*

No person shall solicit alms within the camp area except in the beggar hut constructed near the second bridge over the Menik Ganga or within a distance of five yards from there and no person shall distribute any alms to beggars within the camp area except at the aforesaid places.

04. *Bathing and washing:*

No person shall bath or wash cloths or animals within the area of 3 miles upward the Menik Ganga extending from the place of pumping water through the Kataragama Water Supply Scheme.

05. *Vehicles:*

5.1 No person shall enter any motor vehicle, bicycle, bullock cart or any other vehicle to the sacred area (Eastern part of Menik Ganga) without a permit issued by me or any other authorized officer.

5.2 No person shall park any vehicle within the camp area except within the areas reserve for parking vehicles in the New Town.

06. *Barber Saloons:*

No person shall establish any barber saloon within the camp area except the places reserved for the purpose.

07. *Kavadi Kada:*

No person shall establish any Kavadi Kada without a permit issued by me or any other authorized officer.

08. *Marketing:*

8.1 Hawkers are not allowed to sell anything within the scared area, pilgrims rest area, bus stand and on or near foot bridges No. 01 and No. 02.

**Report of the Auditor General on the financial statements of the Uva Wellassa University for the year ended 31 December 2006 in terms of Section 108(2) of the Universities Act No. 16 of 1978 and Section 13(7) (a) of the Finance Act No. 38 of 1971**

THE audit of financial statements of Uva Wellassa University for the year ended 31st December, 2006 was carried out under my direction in pursuance of provisions in Article 154(1) of the Constitution of the Democratic Socialist Republic of Sri Lanka read in conjunction with Sections 108(1) and 111 of the Universities Act No. 16 of 1978 and Sub-sections (3), (4) and (7) of Section 13 of the Finance Act, No. 38 of 1971. This report is issued in terms of Section 108(2) of the Universities Act and Section 13(7)(a) of the Finance Act.

**1.2 Scope of Audit :**

Audit opinion, comments and findings in this report are based on a review of the financial statements presented to audit and substantive tests of samples of transactions. The scope and extent of such review and tests were such as to enable as wide an audit coverage as possible within the limitations of staff. Other resources and time available to me. The audit was carried out in accordance with Sri Lanka Auditing Standards, methods and practices to obtain reasonable assurance as to whether the financial statements are free of material misstatements. The audit included examination of evidence supporting the amounts and disclosures in financial statements and assessment of accounting principles and significant estimates and judgements made in the preparation of financial statements, evaluation of their overall presentation and determining whether accounting policies adapted were appropriate, consistently applied and adequately disclosed. Sub-sections (3) and (4) of Section 13 of the Finance Act No. 38 of 1971 give discretionary powers to the Auditor General to determine the scope and extent of the audit.

**2. Financial Statements :**

**2.1 Opinion :**

So far as appears from my examination and to the best of my information and according the explanations given to me, I am of opinion, that the University of Uva Wellassa had maintained proper books of account for the year ended 31st December, 2006 and except for the effects on the financial statements of the matters referred to in paragraph 2.2 of this report, the financial statements which are in agreement with the said books have been prepared and presented in accordance with Sri Lanka Accounting Standards and the stated accounting policies and the notes (from note 1 to 5) to the financial statements and give a true and fair view of the financial position of the University of Uva Wellassa as at 31st December 2006 and the financial results of the operations and the cash flows for the year then ended.

**2.2 Comments on the Financial Statements :**

**2.2.1 Accounting Policies :**

Following Observations are made.

- (a) Method of valuation of closing stocks and policies regarding stocks had not been disclosed in the financial statements as required by SLAS 5.
- (b) Accounting policies with regard to the accounting of government grant for capital and revenue amounting to Rs. 292,600,000 had not been disclosed as required by SLAS 24.

#### 2.2.2. Accounting Deficiencies :

The following accounting deficiencies are observed in audit.

- (i) A sum of Rs. 22,83,453 being recurrent payments made in respect of the year under review had not been brought to financial statements.
- (ii) A sum of Rs. 327,842 being recurrent payments made in respect of prior period had been brought to the financial statements of the year under review.
- (iii) A sum of Rs. 10,00,000 of capital grant had not been brought to the financial statements for the year under review.
- (iv) Depreciation had not been provided in respect of buildings amounting to Rs. 11,959,906 and laboratory equipment amounting to Rs. 2,296,978.
- (v) A physical verification of stores had not been carried out and the value of the closing stocks based on the verification had not been shown in the financial statements.

#### 2.2.3 Lack of Evidence for Audit :

### 15. Financial Report.

#### 15.1 Accounting Policies :

##### *Basis of Accounting.-*

The Financial Statements are prepared in accordance with generally accepted accounting principles and the accounting standards laid down by the Institute of Chartered Accountants of Sri Lanka. These Financial Statements are prepared in accordance with the historical cost convention where appropriate accounting policies are disclosed in succeeding notes.

##### *Comparative figures.-*

Comparative figures have been adjusted to conform to the changes in presentation in the current financial year and/or described by a narration.

#### 15.2 Property, Plant and Equipment :

Land value indicates the payment of compensation to industrialists those who occupied the premises as the final acquisition of land has not been completed yet. Action will be taken to get the land valued only after taking over of land from the Ministry of Higher Education. Capital work in progress represents the cost of civil construction work not completed.

Property, Plant & Equipment are stated at cost or valuation less accumulated depreciation. Depreciation is provided using the straight-line method on a consistent basis over the period appropriate to the estimated lives of different type of assets as follows :

Furniture and Office Equipment	20%

Machinery and Laboratory Equipment	10%
Library Books	10%
Sports and Other Assets	10%

No depreciation is provided in the year of acquisition and full year's depreciation is provided in the year of disposal.

##### *Inventories.-*

Laboratory Consumables are indicated as Inventories and valued at lower of cost and net realizable value. The cost of inventories is valued on first-in, first out (FIFO) basis.

##### *Receivables.-*

Receivables are stated at the estimated realizable value.

### 15.3 Liabilities & Provisions.-

#### Retirement benefits :-

In terms of Gratuity Act, No. 12 of 1983 the liability to an employee arises only upon completion of 5 years of continued service. To meet the liability a provision is made, equivalent to half a month salary based on the last month of the financial year for all employees who have completed five years of service.

#### Accounts payable :

Payables are stated at costs.

### 15.4 Income & Expenditure :

#### Revenue recognition :

Revenue is recognized on accrual basis.

#### Amortization of Grants :

Grants that relate to capital expenditure are treated as deferred income which is then credited to income and expenditure account and loss over the related assets useful life.

#### Expenditure recognition :

All expenditure incurred in maintaining the University has been recognized on accrual basis and charged to revenue in ascertaining the income over expenditure.

#### Cash flow statement :

The Cash Flow Statement has been prepared using the indirect method. For the purpose of the Cash Flow Statement, Cash and Cash Equivalents consist of current accounts balances held at banks.

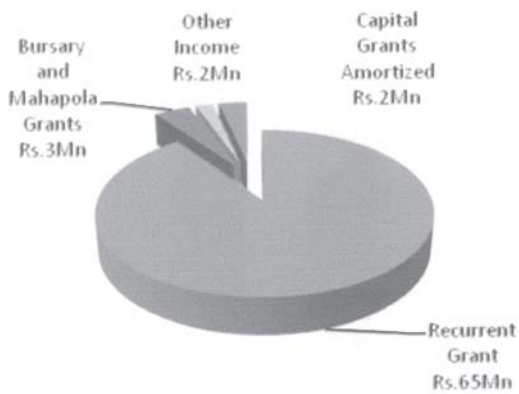

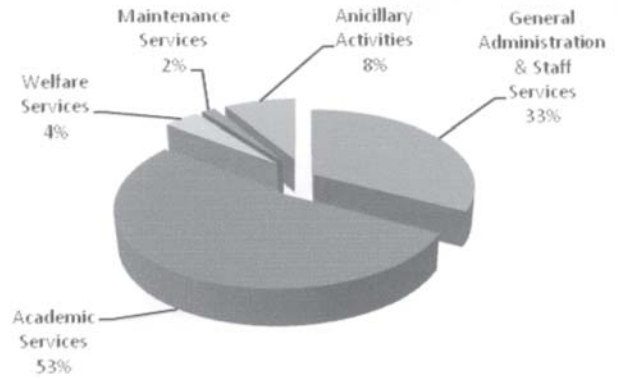

The graph shows the University income during the year 2007

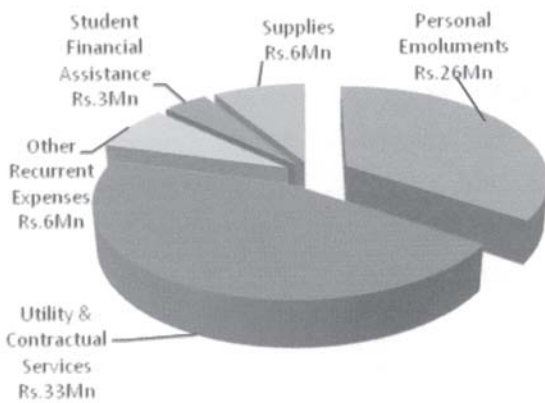


Recurrent Expenditure associated with core programmes

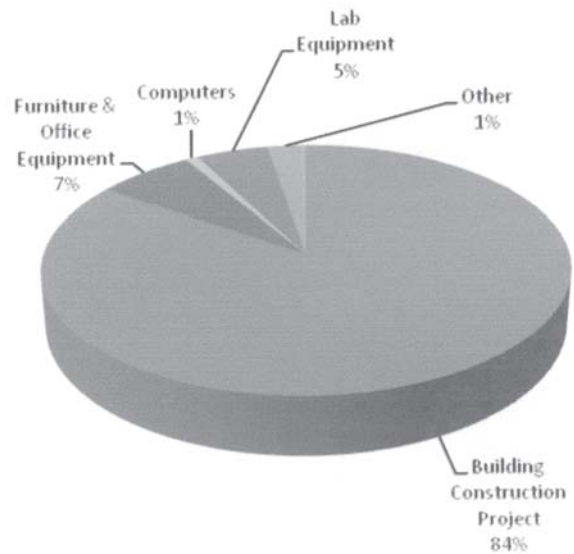

The audit of financial statements of Uva Wellassa University for the year ended 31 December 2007 was carried out under my direction in pursuance of provisions in Article 154(1) of the Constitution of the Democratic Socialist Republic of Sri Lanka read in conjunction with Sections 108(1) and 111 of the Universities Act No. 16 of 1978 and Sub-sections (3), (4) and (7) of Section 13 of the Finance Act, No. 38 of 1971. This report is issued in terms of Section 108(2) of the Universities Act and Section 13(7)(a) of the Finance, Act.

#### 1.2 Responsibility of the Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with Sri Lanka Accounting Standards and Generally Accepted Accounting principles. This responsibility includes, designing, implementing and maintaining internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatements, whether due to fraud or error, selecting and applying appropriate accounting policies and making accounting estimates that are reasonable in the circumstances.

#### 1.3 Scope of Audit and Basis of Opinion

My responsibility is to express an opinion on these financial statements based on my audit. Audit opinion, comments and findings in this report are based on a review of the financial statements presented to audit and substantive tests of samples of transactions. The scope and extent of such review and tests were such as to enable as wide an audit coverage as possible within the limitations of staff, other resources and time available to me. The audit was carried out in accordance with Sri Lanka Auditing Standards, to obtain reasonable assurance as to whether the financial statements are free from material misstatements. The audit includes examination on a test basis of evidence supporting the amounts and disclosures in financial statements and assessment of accounting principles used and significant estimates made by the management in the preparation of financial statements as well as evaluating their overall presentation. I have obtained sufficient information and explanations which to the best of my knowledge and belief were necessary for the purpose of my audit. I therefore believe that my audit provides a reasonable basis for my opinion. Sub-sections (3) and (4) of Section 13 of the Finance Act, No. 38 of 1971 give discretionary powers to the Auditor General to determine the scope and extent of the audit.

## 2. Financial Statements :

### 2.1 *Opinion*

So far as appears from my examination and to the best of my information and according the explanations given to me, I am of opinion, that the Uva Wellassa University had maintained proper accounting records for the year ended 31 December 2007 and except for the effects on the financial statements of the matters referred to in paragraph 2.2 of this report, the financial statements have been prepared in accordance with Sri Lanka Accounting Standards and Generally Accepted Accounting principles give a true and fair view of the state of affairs of the Uva Wellassa University as at 31 December 2007 and the financial results of its operations and cash flows for the year then ended.

### 2.2 **Comments on Financial Statements :**

#### 2.2.1 **Sri Lanka Accounting Standards :**

The following observations are made.

- (a) Accounting policies with regard to the accounting of government grant for capital and recurrent expenditure amounting to Rs. 96,800,000 had not been disclosed as required by SLAS 24.

- (b) Accounting policies with regard to the hiring of computers amounting to Rs. 2,648,449 has not been disclosed as required by SLAS 03.

#### 2.2.2 Accounting Deficiencies :

The following accounting deficiencies were observed in audit.

- (a) A sum of Rs. 684,562,750 in respect of work in progress had been included in the property, plant and equipment in the financial statements.
- (b) Land occupied by the University had not been acquired, but compensation paid for the industrialists amounting to Rs. 11,695,907 had been shown in the financial statements as land and buildings.
- (c) A sum of Rs. 2,283,453 being recurrent payments in respect of prior period had been brought to the financial statements of the year under review.
- (d) A sum of Rs. 2,648,449 being recurrent payments in respect of the year under review had not been brought to the financial statements.
- (e) A sum of Rs. 17,543,682 being construction payments in respect of prior period had been brought to the financial statements for the year under review.

### 3. Financial and Operating review :

#### 3.1 Financial Review :

According to the financial statements presented, the working of the University for the year ended 31 December 2007 had resulted in a surplus of Rs. 180,566 after taking into account the Government Grant of Rs. 65,800,000 received for recurrent expenditure as against the deficit of Rs. 994,760 for the preceding year after taking into account the Government Grant of Rs. 35,600,000 received for recurrent expenditure for that year, thus indicating an improvement of Rs. 1,175,326 in the financial result.

#### 3.2 Human Resource Management :

##### Position of Approved Carder :

According to the approved carder of the University, 32 vacancies in the academic staff and 45 vacancies in non academic staff had not been filled by the University.

#### 3.3 Rent for Quarters :

According to Section 5 of Chapter XIX of the Establishments Code of the Democratic Socialist Republic of Sri Lanka, rent for the occupation of government quarters should be deducted from the salary of the occupants. The University had taken on rent certain private houses for the University staff by making payment of Rs. 192,500, but no rent had been deducted from the salaries of the occupants.

#### 3.4 Hiring of Motor Vehicles :

The University had hired a motor vehicle for monthly payment of Rs. 66,000, without considering lowest bid of Rs. 54,000. therefore the University had sustained a loss of Rs. 144,000 for the year under review due to rejection of the lowest bid.
