1. Reporting Entity

The Postgraduate Institute of English has been incorporated under the Postgraduate Institute of English Ordinance. It launched its operations on 01st October, 2006. 2. Statement of Compliance

THE audit of financial statements of the Postgraduate Institute of English for the year ended 31st December, 2007 was carried out under my direction in pursuance of provisions in Article 154 (1) of the Constitution of the Democratic Socialist Republic of Sri Lanka read in conjunction with Ordinance No. 04 of 2005 of the Postgraduate Institute of English and Sections 108 (I) and III of the Universities Act, No. 16 of 1978 and Sub-sections (3), (4) and (7) of Section 13 of the Finance Act, No. 38 of 1971. My comments and observations which I consider should be published with the annual report of the Institute in terms of Section 108 (2) of the Universities Act appear in this report.

1.2 Responsibility of the management for Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with Sri Lanka Accounting Standards. This responsibility includes: designing implementing and maintaining internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatements, whether due to fraud or error; selecting and applying appropriate accounting policies; and making accounting estimates that are reasonable in the circumstances.

1.3 Scope of Audit and Basis of Opinion

My responsibility is to express an opinion on these financial statements based on my audit. Audit opinion, comments and findings in this report are based on a review of the financial statements presented to audit and substantive tests of samples of transactions. The scope and the extent of such reveiw and tests were such as to enable as wide an audit coverage as possible within the limitations

of staff, other resources and time available to me. The audit was carried out in accordance with Sri Lanka Auditing Standards to obtain reasonable assurance as to whether the financial statements are free from material misstatements. The audit includes the examination on a test basis of evidence supporting the amounts and disclosures in financial statements and assessment of accounting principles used and significant estimates made by the management in the preparation of financial statements as well as evaluating their overall presentation. I have obtained sufficient information and explanations which to the best of my knowledge and belief were necessary for the purpose of my audit. I therefore believe that my audit provide a reasonable basis for my opinion. Sub-sections (3) and (4) of Section 13 of the Finance Act, No. 38 of 1971 give discretionary powers to the Auditor General to determine the scope and extent of the audit.

2. Financial Statements

2.1 Opinion

(a

So far as appears from my examination and to the best of information and according to the explanations given to me, I am of opinion that the Postgraduate Institute of English had maintained proper accounting records for the year ended 31st December, 2007 and except for the effects on the financial statements of the matters referred to in Paragraph 2.2 of this report, the financial statements have been prepared in accordance with Sri Lanka Accounting Standards give a true and fair view of the state of affairs of the Postgraduate Institute of English as at 31st December, 2007 and the financial results of its operations and the cash flows for the year then ended.

- 2.2 Comments on Financial Statements
 - 2.2.1 Sri Lanka Accounting Standards Following observations are made:-
 - (*a*) Although a sum of Rs. 315,400 had been received during the year under review for conducting short term courses, it had not been taken as revenue in terms of SLAS No. 03;
 - (b) Although direct financial benefit received by way of Government grants should have been disclosed, the grants received from the Open University had not been disclosed in the financial statements in terms of SLAS No. 24.
 - 2.2.2 Accounting Deficiencies

The accounting deficiencies observed in audit are brought to the notice of the Director of the Postgraduate Institute and corrected those deficiencies. The amended financial statements were furnished to audit on 17th April, 2008.

2.2.3 Non-compliance with Laws, Rules, Regulations and Management Decisions

Instances of Non-compliance observed in audit are given below:-

3. Financial and Operating Review

- 3.1 Financial Review
 - 3.1.1 Financial Result

The financial results of the Postgraduate Institute of English (PGIE) for the year under review showed an excess of income over expenditure of Rs. 157,443.

3.1.2 Analytical Financial Review

A sum of Rs. 1,463,300 had been received as Government recurrent grant and the total expenditure amounting to Rs. 2,009,991 had been incurred by the Institute during the year under review.

- 3.2 Operating Review
 - 3.2.1 Performance

The Postgraduate Institute of English (PGIE) is concerned with Postgraduate studies in the field of English. The PGIE responsible for providing and enhancing English Teacher Education in Sri Lanka. The PGIE is currently conducting a Master Degree in teaching English course as a second language. According to the information provided by the Institute 55 students had been registered in the last two academic years to follow the Master Degree Programme and in academic year 2007/2008 only 22 students had been registered.

The PGIE conducted an English pilot programme course-for University administrative staff of the Open University of Sri Lanka.

3.2.2 Under-Utilization of Funds

A sum of Rs. 1.4 Million had been received as capital grant, and of this 96% had not been spent up to end of the year under review.

3.2.3 Idle and Under-Utilized Assets

Even though bank balance amounting to Rs. 1.4 Million had been shown in the bank account up to the end of the year 2007, no action had been taken to invest this balance in a short term investment to earn interest.

3.2.4 Internal Audit and Audit and Management Committee

Internal audit and management committee had not been established by the Board of Management.

3.2.5 Budgetary Control

According to the Section 2.2.4 of Public Enterprises Guidelines on Good Governance the annual budget should be approved by the Board of Management in 03 months prior to the commencement of the year. However, the budget of the Institute had not been prepared for the year under review.

Special attention is needed in respect of the following areas of control :-
