By virtue of the powers vested by Sub-section (1) of Section 2 of the Entertainment Tax Ordinance (Chapter 267), the Matara Municipal Council hereby, resolves to impose and levy, with effect from the 1st day of the following month of the month in which this resolution is published in the *Gazette*, a tax at the rates set out hereunder on payment of admission to entertainments defined in the Ordinance (other than Entertainment Tax) held in the area within the administrative limits of the Council.
