#### 3. Outcome of the Recurrent Services of the year

#### (I) Income

The government grant for the recurrent expenditure for the year 2008 was Rupees eight hundred and seventy Nine Million (Rs. 879,000,000). Government grant received under capital expenditure vote 101 rehabilitation and maintenance services was Rupees Ten Million Two Hundred and Ninety-five Thousand Eight Hundred Forty-three (Rs. 10,295,843). In addition, income from other recurrent sources was Rupees Two Hundred and Thirty-seven Million Six Hundred and Seventy-nine Thousand Five Hundred Seventy (Rs. 237,679,570). Accordingly, the total recurrent income for the year 2008 was Rupees One Thousand One Hundred Twenty-six Million Nine Hundred and Seventy-five Thousand Four Hundred and Thirteen (Rs. 1,126,975,413).

#### (II) Expenditure

The total recurrent expenditure for the year was Rupees One Thousand and Seventy-nine Million Forty-five Thousand Six Hundred and Ninety-four (Rs. 1,079,045,694). The expenditure for the rehabilitation and maintenance services was Rupees Ten Million Two Hundred and Ninety-five Thousand Eight Hundred Forty-three (Rs. 10,295,843). Accordingly, the total expenditure was Rupees One Thousand Two Hundred and Five Million Two Hundred Twenty-one Thousand Eight Hundred Two (Rs. 1,205,221,802) inclusive of the expenditure of fee-levying courses. The amount allocated for the depreciation for the year 2008 was Rupees One Hundred and Twenty-eight Million Four Hundred and Seven Thousand Six Hundred and Fifty-three (Rs. 128,407,653). Accordingly, the recurrent expenditure for the year 2008 was Rupees One Thousand Seventy-nine Million Forty-five Thousand Six Hundred and Ninety-four. (Rs. 1,079,045,694).

#### (III) Utilization of Accounting impact and allocations

The excess of expenditure over income, after consideration of the total income and expenditure including the depreciation was Rupees Seventy-eight Million Two Hundred and Forty-six Thousand Three Hundred Eighty-nine (Rs. 78,246,389).

#### (IV) Expenditure for Hostel Facilities

The income received from hostels in 2008 was Rupees One Million Four Hundred and Fifty-eight Thousand Eight Hundred and Twenty-one (Rs.1,458,821) while the expenditure was Rupees Twenty-three Million Seven Hundred and Nine Thousand Six Hundred Eighty-eight (Rs. 23,709,688). The additional expenditure of Rupees Twenty-two Million Two Hundred and Fifty Thousand Eight Hundred and Sixty-seven (Rs. 22,250,867) incurred for providing hostel facilities was financed by the other income.

#### (V) Expenditure for Centre for Open and Distance Learning

The income received from the activities related to Centre for Open and Distance Learning was Rupees One Hundred and Fifty Million Six Hundred and Three Thousand Five Hundred Fifty-one (Rs. 150,603,551) and the total expenditure

was Rupees One Hundred and Thirty-six Million Six Hundred and Thirty-six Thousand Four Hundred Thirty-three (Rs. 136,636,433). However the Government Contribution of Rupees Eight Million Nine Hundred and Three Thousand Eight Hundred and Seven (Rs. 8,903,807) was included in the total income.

#### (VI) Over and under provision account:

After adjusting for under provisions and prior year transactions, the aggregate amount carried forward to the next year is Rupees Eight Hundred and Ninety-nine Million Eight Hundred and Eighty-three Thousand Four Hundred Eight (Rs. 899,883,408).

#### 4. Output of the capital services

#### (I) Expenditure Vote 101 Rehabilitation and Maintenance Services:

The estimated government capital grant for expenditure vote 101 for the year was Rupees Thirty-three Million Five Hundred Thousand (Rs. 33,500,000) while the expenditure inclusive of the adjustments for the last year was Rupees Thirty-five Million Six Hundred and Fifty-seven Thousand Eight Hundred Sixty-seven (Rs. 35,657,867). From this expenditure, Rupees Ten Million Two Hundred and Ninety-five Thousand Eight Hundred and Forty-three (Rs. 10,295,843) was recurrent expenditure while Rupees Twenty-five Million Three Hundred and Sixty-two Thousand Twenty-four (Rs. 25,362,024) was capital expenditure.

#### (II) Expenditure Vote 102 Laboratory and teaching equipments, books and journals

The estimated government capital grant for the year was Rupees sixty million five hundred thousand (Rs. 60,500,000.) The expenditure for the year with the adjustments related to past years was Rupees Forty-four Million Four Hundred and Ninety-five Thousand Two Hundred Eighty-one (Rs. 44,495,281). In addition, the expenditure for advance payments was Rupees One Hundred and Forty Thousand One Hundred Sixty-six (Rs. 1,840,166).

#### (III) Expenditure Vote 103 Constructions

The estimated government grant for the year was Rupees Hundred Million (Rs. 100,000,000). Expenditure for the year with the adjustments related to past year was Rupees One Hundred and Six Million Eight Hundred Ninety-nine Thousand Eight Hundred Twenty-nine (Rs. 106,899,829).

#### 5. Analysis of recurrent expenditure

In the analysis of recurrent expenditure for the year 2008, it was revealed that of the total expenditure, 22.13% has been spent for General Administration (53.77% of this was for depreciation of fixed assets), 59.52% for Academic Activities, 2.42% for Library Services, 2.66% for welfare activities, 5.9% for maintenance of lands and buildings, 5.18% for centre for open and distance learning and 2.2% for student hostel facilities.

#### 6. Analysis of cost per student

Total number of registered students for the year 2008 was 8423. The direct and indirect costs per student in each faculty from year 2003 to year 2008 are as follows:

#### NOTES TO THE FINANCIAL STATEMENTS

#### 1. Significant Accounting Policies:

#### 1.1 General:

The financial statements of the university have been prepared in accordance with the Sri Lanka Accounting Standards on historical cost basis. No adjustments have been made for inflationary factors affecting the financial statements. The accounting policies are inconsistence with those used in the previous years.

Assets and basis of their valuation:

#### 1.2.1 Land and buildings and other assets:

The fixed assets other than Lands, Library Books & Periodicals and Cloaks are shown at cost less accumulate depreciation. Lands, Library Books & Periodicals and cloaks are shown on their Revalued amount. Depreciation has been charged to the Income Statement on the straight line basis at the following rates per annum in order to write off the cost of such assets over their estimated useful lives.

Lab & Teaching Equipment	20%

The rate of depreciation on Fiber Glass Boat and Machineries are changed to 20% and 10% respectively. Depreciation is not charged in the year of purchase whilst full year depreciation is charged in the year of disposal.

Buildings under construction have been shown as work in progress.

#### 1.2.2 Stores Advance -

Stores advance is represented by the inventories which have been valued at purchase cost.

#### 1.2.3 Receivables -

Receivables are stated at the amounts they are estimated to realize.

#### 1.3 Accounting for capital grant:

The total capital grant received for the year was Rs.194.0 Million which has been used as follows:

#### 1.4 Liabilities & Provisions:

All known liabilities as at the Balance sheet date are included in the Financial Statements and adequate provision is made for liabilities which are known to exist but the amount of which cannot be determined accurately.

#### 1.5 Employees' Benefits:

#### 1.5.1 Provision for Gratuity -

The policy for Provision for Retiring Gratuity has been changed according to the Retiring Gratuity Act No. 12 of 1983, which on the basis of completion of five years of continuous service.

#### 1.5.2 Defined contribution plans

Obligations for contribution to University Provident fund and Employees' Trust Fund are recognized as expenditure in the Income Statement as incurred.

#### 1.6 Current Liabilities:

Current liabilities are those which fall due for payment on demand or deposits which payable within two years from the Balance Sheet date as per financial regulations.

#### 1.7 Taxation

University is exempt from payment of income tax under the Inland Revenue Act. However Economic Service Tax is paid for internally generated income which is included in other recurrent expenditure.

#### 1.8 Income & Expenditure:

- 1.8.1 Student registration fees are recognized as revenue on receipt basis.
- 1.8.2 Interest income is accounted on accrual basic.
- 1.8.3 Income and expenditure of the Centre for Open & Distance Learning (CODL) and the Student Hostels have been included in the university accounts and separate accounts too have been presented along with the financial statements. The expenses incurred for electricity and water at the CODL have been accounted on the individual electricity and water consumption rate-basis. Capital expenses of the CODL have been presented under capital vote of that unit.

#### 1.9 Receivables from breach of agreements and bonds:

Two actions were filed by the University to recover moneys arising out of violation of agreement / bond by Teachers.

Three cases were filed against the University. One is an appeal from the order in an application for a writ in the court appeal, another an application for writ in connection with transfer from the Eastern University filed by 5 students and the other case in an appeal made to the University Services Appeals board by an employee seeking to ante-date his promotion.
