1. General Policies

- 1.2 Comparative Information

Where necessary comparative figures have been modified to conform with changes in presentation in the current year.

- 1.3 Valuation of Assets :
- 1.3.1 Inventories : Inventories are valued at actual cost using First in first out (FIFO) method.
- 1.3.2 Cash Flow Statement : The cash flow has been prepared by using the "Indirect method".
- 1.3.3 Property, Plant and Equipment :
 - (a) Cost and valuation -

All Property, Plant and Equipment are recorded at cost and are stated at historical cost less depreciation. However valuation of some Land and building is pending.

(b) Depreciation :

Provision for depreciation is calculated on all Property, Plant and Equipment, other than free hold land, in order to write off the cost and/or valuation over the estimated economic life of such assets. In the year of purchase depreciation in provided either for half year or full year.
