2. Review of the Board of Management :

2.1 Objective

The objective and the purpose of the Fund, is to afford Provident Fund benefits to those Public Servants who are, not pensionable.

2.2 Functions

The main functions of the P. S. P. F. are,

- (a) To recover and credit the Fund by an amount equivalent to 8% of the monthly salaries of those who are non-pensionable and are serving in the various departments of the Island and in the foreign missions abroad.
- (b) To receive the contributions and to store, such contributions in a methodical manner.

- (c) To process and maintain individual accounts of such contributors to enable the contributors to be notified of the amount lying to their credit at the end of each financial year, and refund the benefits at the end of contributor's service.
- (d) To invest the excess money of the Fund in "Government securities" to enable the contributors to secure a higher interest and appropriate such interest, at the end of every financial year.

2.3 Performance Appraisal

(a) Financial Results

The amount received as Compulsory contribution and Government Bonus during the year under review was Rs. 690,149,221 and Rs. 1,041,744,092 respectively, while the contributions received during the year 2008 was Rs. 607,756,141 and Rs. 563,527,235 respectively. The total income from investment of the Fund after tax was Rs. 2,399,711,836 as compared with Rs. 1,411,985,371 last year. After providing for administrative expenses of the fund amounting to Rs. 7,355,448, a sum of Rs. 2,392,356,388 was available for appropriation as interest to the contributors. The percentage of interest thus available was 11.82% as compared with the percentage of interest of 7.97% during the previous year. However, the percentage of interest rounded up to the nearest quarter being 11.80% amounting to Rs. 2,387,418,134 was appropriated and the balance amounting to Rs. 4,938,253 was transferred to the General reserve.

This account represents the amount lying to the credit of the contributors being the share of contributions of the contributors and the interest thereon together with the Government contributions with interest.

The balance in this account is the amount after appropriation of interest to the nearest quarter percent. A sum of Rs. 4,938,253 being the balance after appropriation was transferred to this account and the balance as at 31.12.2009 was Rs. 31,456,580.

3.5.8 Accrued Expenses:

This represents the expenses charged from the consolidated fund during the year under review, including Rs. 119,225 paid by the Department of Pensions as electricity and water.

Report of the Auditor General on the Financial Statements of the Public Service Provident Fund for the Year ended 31st December, 2009

The audit of financial statements of the Public Service Provident Fund for the year ended 31st December, 2009 was carried out under my direction in pursuance of provisions in Article 154 (3) of the Constitution of the Democratic Socialist Republic of Sri Lanka read in conjunction with Section 24 (1) of the Public Service Provident Fund Ordinance (Chapter 621).

1.2 *Responsibility of the Management for the Financial Statements :*

Management is responsible for the preparation and fair presentation of these financial statements in accordance with Generally Accepted Accounting Principles. This responsibility includes; designing, implementing and maintaining internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatements, whether due to fraud or error; selecting and applying appropriate accounting policies; and making accounting estimates that are reasonable in the circumstances.

1.3 *Scope of Audit and Basis of Opinion :*

My responsibility is to express an opinion on these financial statements based on my audit. Audit opinion, comments and findings in this report are based on a review of the financial statements presented to audit and substantive tests of samples of transactions. The scope and extent of such review and tests were such as to enable as wide an audit coverage as possible within the limitations of staff, other resources and time available to me. The audit was carried out in accordance with Sri Lanka Auditing Standards to obtain reasonable assurance as to whether the financial statements are free from material misstatements. The audit includes the examination on a test basis of evidence supporting the amounts and disclosures in financial statements and assessment of accounting principles used and significant estimates made by the management in the preparation of financial statements as well as evaluating their overall presentation. I have obtained sufficient information and explanations which to the best of my knowledge and belief were necessary for the purpose of my audit. I therefore believe that my audit provides a reasonable basis for my opinion.

2. Financial Statements

2.1 *Opinion*

So far as appears from my examination and to the best of information and according to the explanations given to me, I am of opinion that the Public Service Provident Fund had maintained proper accounting records for the year ended 31st December, 2009 and except for the effects on the financial statements of the matters referred to in paragraph 2:2 of this report, the financial statements have been prepared in accordance with Generally Accepted Accounting Principles and give a true and fair view of the state of affairs of the Public Service Provident Fund as at 31st December, 2009 and the financial results of its operations for the year then ended.

2.2 *Comments on Financial Statements :*

2.2.1 *Accounting Deficiencies -*

The following accounting deficiencies were observed :-

- (a) The erroneous debit balances as at the end of the year under review amounted to Rs. 6,069,020 and the net debit balance amounting to Rs. 5,983,197 after the set off of erroneous credit balance of Rs. 85,823 as at that date had been shown under the current assets in the balance sheet. These erroneous debit and credit balances included balances amounting to Rs. 2,779,140 and Rs. 85,823 respectively older than 05 years. Out of the erroneous debit balances, balances amounting to Rs. 1,590,590, Rs. 531,508, Rs. 205,859 and Rs. 166,608 related to the Ministry of Education and Higher Education, the Department of Police, the Department of Telecommunication and the Ministry of Transport and Highways respectively, while credit balances amounting to Rs. 25,000 and Rs. 22,443 related to the Department of Local Government and the Department of Attorney General respectively.
- (b) According to the provisions in the Public Service Provident Fund Ordinance, a sum equivalent to 1.5 times the balance of the compulsory contribution should be credited to the Fund as the Government Bonus. Therefore 1.5 times the compulsory contribution of Rs. 9,236,864,908 as at 31st December, 2008 amounting to Rs. 13,855,297,362 should be with the Fund. Nevertheless, the balance therein amounted to Rs. 13,976,345,711 thus overstating the balance of the Government Bonus Account by a sum of Rs. 121,048,349.

2.2.2 *Non-compliance with Laws, Rules and Regulations :*

Instances of non-compliance with the following laws, rules, regulations, etc. were observed :-

According to the Section referred to, the Director of Pensions should, after 31st December, of each year, inform the contributors the balances lying to the credit of their accounts. Nevertheless, the Director General of Pensions had not taken action in that connection in the year under review. The Director General informed that this could be done shortly through the E-Pensions Project.

3. Financial and Operating Review

3.1 *Financial Results :*

According to the Financial Statements presented, the financial results for the year under review had been a surplus of Rs. 2,392,356,388 before appropriation to the contributors as compared with the corresponding surplus of Rs. 1,404,715,787 for the preceding year, thus indicating an increase of Rs. 987,640,601 in the financial results as compared with the preceding year.

3.2 *Review Financial Results :*

The increase in the income from interest by Rs. 987,726,465 or 70 percent as compared with the preceding year, had affected the improvement in the surplus.

3.3 *Interest Entitlement of Members :*

An analysis of the interest percentage credited to the members during the year under review and the preceding 13 years are given below :

According to the above analysis a gradual decrease in the annual percentage of interest paid by the Fund to the members from the year 1996 to 2007 is observed and indicates an improvement from year 2008. A comparison of the year 1996 with the year 2009 indicates that the percentage of interest paid for the year 2009, as compared with the year 1996 had decreased by 15.35 percent.

3.4 *Trends in the Improvement of Membership and Investments :*

A analysis of the values of the improvement of the membership and investments for the nearest 08 years ended 31st December, 2009 and the trend analysis as at 31st December of each year are given in the following statement:

Even though the pace of the improvement in memberships in the year under review as compared with the preceeding year had decreased, with an increase with the pace of improvement in the investments. The pace of the improvement of the investments in the years 2002 and 2003 had been at a higher rate than in the year under review despite there being no improvement in the membership.

3.5 Interest Income deprived of to the Fund :

The Government bonus receivable from the Secretary to the Treasury had not been received by the Fund and as such the interest income that could have been earned by the investment of such money had been deprived of to the Fund. Such interest income deprived of during the year under review and the 05 preceding years (approximately) is as follows.

Even though action had been taken for the Treasury to cause the remittance of the above amounts the efforts had not been successful. Consequently the profit of the Fund had decreased resulting in the decrease in the interest payable to the members.

3.6 Staff Utilization :

The membership of the Fund by the year under review indicated an improvement of 34.6 percent as compared with the year 2003. Nevertheless, there was no change whatsoever in the number of officers for the operation of the activities of the Fund and as such it was observed that the ratio of members per officer had escalated. The positions for the year under review and the 06 preceding years had been as follows:

According to the above data, it was observed that the expected targets had been determined unrealistically in the preparation of the Action Plan.

- (b) According to the Analysis of Funds Management included in the Financial Statements for the year under review presented for Audit the maintenance of the members accounts in a manner to make it possible to notify the balance of the members' accounts as at the end of the year had been one of the 04 major activities aimed at reaching the objectives of the Fund. Nevertheless, updated individual accounts had not been maintained in a manner to make it possible to notify the balances of the individual accounts to the members as at the end of the year under review.

3.9 Management Weaknesses :

The following management in-efficiencies were observed.

- (a) According to Circulars No. 1/97 dated 31st July, 1997 and 14/2006 dated 30th October, 2006 of the Director General of Pensions, advices relating to the money credited to the Fund in each month should be forwarded by the respective institutions to reach the Secretary of the Fund before the 15th day of the month following. Nevertheless, such advices in respect of the year 2009 had been forwarded only by a few institutions. The courses of action taken by the Fund to get those advices had not reached the expected level. The Director General informed that such position was due to the lack of response from the institutions concerned.
- (b) An inspection carried out with regard to the grant the membership of the Public Service Provident Fund in terms of provisions of the Public Service Provident Fund Ordinance No. 18 of 1942 and the Public Service Provident Fund (Amendment) Act, No. 17 of 2003, to the non-pensionable officers and provide them with the benefits thereof revealed that no remittances to the Fund had been made under 127 Heads of Expenditure. A course of action had not been in operation to identify those employed therein and enroll them as members of the Fund and provide the benefits. The Director General of Pensions informed that due to the absence of a methodology for the identification of employed in such institutions who are entitled to receive benefits from the Fund, it had not been possible to implement a course of action to collect authorities.

4. Systems and Controls

Matters observed during the course of audit were brought to the notices of the Director General of Pensions from time to time. Special attention is needed in respect of the following areas of control.

- (a) Obtaining Abatement Registers
- (b) Collection of Contributions
- (c) Settlement of Erroneous Debit and Credit Balances.
- (d) Action on Audit Observations

Observations of the PSPF Management Board on the Report of the Auditor General concerning Accounts of the Public Service Provident Fund for the year ending 31.12.2009.

2.2 Comments on Financial Statements

2.2.1 Accounting Deficiencies

- (a) Despite frequent notices by letters and calling over the telephone to relevant departments and ministries to settle the balances existed over past 5 years in erroneous debits and credits, the institutions had not taken any action in that regard. Therefore above mentioned problematical situation could not solve. Nevertheless, most of the erroneous debits and credits committed in year 2008 were corrected within the same year.
- (b) This surplus existed due to most members are used to apply for their awards by elapse of long period of time subsequent to the nullification of membership. On the other hand the awards granted only to the date of nullification of membership. Hence the balance cash remained in the account. Investing the balance cash and remitting the interest benefits therein to the government bonus also has been caused to have this surplus.

2.2.2 Non-compliance with laws, rules and regulations

(a) *Section 25 of Public Service Provident Fund Ordinance*

It is accepted to inform the balance and accordingly the balance only till year 1999 was informed. Unavailability of proper information creates difficulties to make date base. At present we have initiated the task of computerizing the accounts having built-up a computer program. However, noticing the balances by producing datum had been delayed as a result that issuing awards for 27000 reserve police officers who absorbed into regular service, the casual employees in Postal Service and all civil employees in Free Armed Forces who confirm in the post had to expedite. I pleased to inform that in future the facility will be available to inform the balance under e-pension project.

(b) *Section 10 and 1 (3) (a) of Public Service Provident Fund Act, No. 18 of 1942*

The audit fees payable for auditing P. S. P. Fund during 2005, 2006, 2007, 2008 and 2009 had been allocated. Accordingly, it is informed that the estimated values for audit fees were adjusted when preparing income and expenditure account. Adjustments displayed below were done in compliance to the estimates produced by audit officers.

However the bills for auditing after year 2004 were not forwarded to this fund and it is informed that all payments till year 2009 can release on receipt of those bills.

(c) *Public Finance Circular No. PF/423 dated 22.12.2006*

Paragraph 04.01

The budget estimates for year 2009 was duly forwarded to the Hon. Minister on 05.11.2008 and the Hon. Minister of Public Administration and Home Affairs gave approval thereto. (Herewith attached a copy of the letter).

Paragraph 04.03 (E)

The verification letters on credit balances of the accounts of the fund was regularly delayed to receive. These verification letters had not received even at the time when the annual accounts of the fund was submitted for the auditing on 24.02.2010. We have already requested a balance verification letter from the Department of Public Accounts and the accounts will be produced for the auditing after receiving the letter.

(d) Paragraph 03 (IV) of the Treasury Operation Circular 01/2008

The fact that the Treasury Circular 1/2008 should adhere for the purposes of investments got to know by the audit draft for auditing year 2008. The relevant audit draft was received on 19.05.2009. Fixed deposits investments printed in audit draft for the auditing in year 2009 were done on 06.04.2009 and 17.05.2009. Accordingly it is informed that those two investments had done before receiving the audit draft for year 2008 and it is informed that the directions shown in circular 1/2008 are followed at present and further informed that these shortcomings will not happen in future.

3. Financial and operating review

3.3 Percentage of interest entitled for members

The average contribution collection from year 1996 to 2009 has been increased. The appropriate interest percentage comparing thereto was decreased as a result that contribution collection was raised in a phase by exceeding the growing phase of the interest income. Even though the contribution so collected was increased, the actual cash flow could not see since the contributions were credited by monthly account summaries. Therefore investing opportunities were declined. The preceding interest percentage had been declined as a result that the reinvestments carried out in a low interest rate when previous investments were matured. The interest percentage appropriated under these circumstances has been declined.

3.4 Trends in the improvement of membership and investments

A Slight increase in investments could observe due to receipt of cash imprest for government bonus in year 2009 and an increase in number of members also observed. Opportunities for additional investments were not available comparing the growth of membership since contributions received by account summaries but not as cash flow. Further, the investment opportunities had been lessened as a result that employees in PSPF appointments were confirmed and had to make awards for service concluded employees.

3.5 Interest income deprived from the fund

Letters sent to Secretary to the Treasury by informing that the interest rate would decline since the cash imprest had not received to settle the balance of the account of Deputy Secretary to the Treasury and for the Government bonus. A discussion in this regard was held with patronage of the Director General-Treasury Operations. Though a letter in this regard was sent on 16.03.2009 to the Secretary to the Ministry of Finance, cash not received yet.

It cannot accept the comment that this has happened due to abstain from taking any action to get remit cash from the Treasury and it is informed that all necessary action had taken to get remit the money.

3.6 Staff Recourse

Applications received in year 2008 and 2009 have increased with comparing the year 2003 and this has caused to ascend the workload that should cover by single officer. Lack of additional staff to deploy also has been caused to this difficulty.

3.7 Benefit payments for members

Applications received to obtain awards in year 2009 have been 6 times increased comparing the year 2004 and membership enlistment also boosted by 40%. The available staff to cover all these advancements is the same as in year 2004. Hence, the benefit payments have been delayed.

3.8 Operational performance

(a) Details in past years were based to formulate expected goals in year 2009. Comparing to year 2008 we could see a progress in year 2009 at all activities of the division due to approving over-time, getting assistance of computer trainee students, assigning additional staff for typing and assigning officers in other divisions on the basis of overtime payment. Accordingly it is informed that the expected outcome was exceeded.

- (b) Though it is necessary to maintain member accounts, it is informed that the fund had not maintained such accounts for members instead we have maintained files by getting received abatement records from each institutions. Awards have been made in accordance with those files. Therefore it is informed that the fund could not overcome this requirement at once and further it could not expedite as a computer program for the fund was prepared only from year 2008.

3.9 Management weaknesses

- (a) In addition to circular 1/97 action was taken to inform all departments and ministries by circular No. 14/2006 dated 30.10.2006 to get receive all credit notices to the Fund though the institutions concerned have not taken action to adhere. Up to date they maintain a procedure of sending a list alone with cheques or a report. Due to these situations the progress of productive actions which the fund expected for could not achieve. A public service provident fund instruction manual was issued in this regard by Circular No. 04/2010 dated 25.05.2010 and the fund will meet with its expected progress.
- (b) Only the central government institutions that have no pension entitlement but P. S. P. F. entitlement are crediting monthly contributions by account summaries. Hence the names of only those institutions are printed in computer generated treasury abstract. In addition, some central government institutions and provincial council institutions which have the employees with P. S. P. F. entitlement are crediting contributions by cheques. Therefore, names of those institutions are not enlisted in computer generated treasury abstract. Accordingly all heads not printed to the computer generated treasury abstract. Some institutions that have all expenditure heads as in the estimate may not have the officers with the entitlement. Due to unavailability of clear method to decide whether officers with P. S. P. F. entitled officers employed or not in insitutions, it has been unable to implement a system to collect contributions.
