AN ACT TO INCORPORATE THE ANIMAL WELFARE TRUST

I, Janaka Bandara, Member of Parliament do hereby give notice under Standing Order 48 of the Standing Orders of Parliament of the Democratic Socialist Republic of Sri Lanka, that I propose to introduce in Parliament, a Bill entitled "An Act to Incorporate the animal Welfare Trust".

The aim of the Bill is to incorporate the said animal Welfare trust which has the following general Objects :-

- (g) to engage in discussions with government, provincial and local authorities to promote animal welfare measures;
