**ESTABLISHMENT OF NATIONAL CHILD
PROTECTION FUND-ITS ACTIVITIES AND
ADMINISTRATION**

THIS Fund is known as “National Child Protection Fund” under the National Child Protection Authority. It is a non-profit making Fund for Protection of Children.

02. The Background to the Fund

The National Child Protection Authority was established as per National Child Protection Authority Act, No. 50 of 1998. In its functioning as per Section 20 of the Act, a fund should have been set up under the Authority. It had not been done due to an oversight. However, Section 20 of the Acts stipulates the activities and the responsibilities of the Fund in the enforcement of the authority’s powers and activities.

03. Power and Activities as per Act, No. 50 of 1998

Obtaining and utilization of the funds in the enforcement of the power and activities as per Act, No. 50 of 1998. Section 14 of the Act, No. 50 of 1998 stipulates the activities of the Authority and Section 15 of the Act explains the enforcement its powers for this purpose. Amongst the significant activities stated are the prevention of child abuses, protection of those children abused and ensuring of their rights. Provisions have been made to take all steps necessary for protection of children. As per activities and powers stipulated in the Act, the operations of the Fund also have been strengthened.

04. Tax Exemption granted for Monetary Donations to the Fund

As per Section 31 of Inland Revenue Act, No. 28 of 1979 donations made to the Fund in cash or otherwise are treated as donations in cash or otherwise made to a Fund established by the Government. As such donations are considered under section 21 of the Act as eligible for “exemptions from some of the taxes”, donors are granted tax exemptions for monetary donations by the Department of Inland Revenue. All donations received by the National Child Protection Authority are credited to this Fund. Government receipts are issued for all such donations, and there are duly scheduled in the Registers. On that basis recommendation for tax exemption are given.

05. Advice given by His Excellency the President

His Excellency the President at the Progress Review Meeting 2010 of Child Development and Women’s Affairs Ministry having observed that this Fund has not been established has emphasized that this should be activated.

06. Approval of the Ministry of Finance

The Ministry of Finance too has granted permission to set up the National Child Protection Fund, according to the Act, No. 50 of 1998. It is in operation since 16.11.2010 with the Director General of the Department of Public Finance and the Department of Budget.

07. In the Vision of “Mahinda Chinthana”

In the forward vision of “Mahinda Chinthana” His Excellency the President identifying *Children as little flowers* had stated that children who will be the future owners of the independent sovereign land should be allowed to function as a set who takes over this heritage and act bravely after surmounting whatever challenges. (Mahinda Chinthana Forward Vision P. 22).

08. The Administration of the Fund

This is a state owned Fund. It is used by the Authority to protect children and their welfare. The fund is spend as per decisions of the Board of Directors of the Authority, in required the written consent of the relevant Minister is also obtained on the limits of financial authority. No separate officials have been appointed for this work at the Fund, and officials of the Authority handles this work on an extra payment, as per the Financial Regulations. The Authority is responsible to conduct its activities as per the State Child Protection

Policy and as per general and specific directions of the Minister in charge. In Section 12 of the Act and the duly legislation of the operations of the Fund has confirmed the strong basis of utilization of monies lying to its credit.

09. The Administrative Structure of the Fund

Under the responsibility and the guidance of the Chairman, Vice Chairman and the Board of Directors of the National Child Protection Authority, the monies received from the Central Government are managed and the administration conducted. The Board of Directors of the National Child Protection Authority is duly appointed as in the case of appointment of the Chairman and of the Vice Chairman by H E the President.

10. Maintenance of Fund Accounts and Audit

As per Section 22 of National Child Protection Authority Act, the financial year is the calendar year, and Section 154 of the Sri Lankan Constitution concerning the maintenance of Accounts and Audit in State Corporation are applicable. Separate accounts are maintained on this basis. In addition, as necessary reports are forwarded to the Treasury, Parliament and Auditor Generals Department.

11. Security of the Fund

As the Fund is one operating under auspices of the Authority and the Authority is an entity under the Bribery and Corruption Act. The Account of the fund is maintained in a State Bank under the name of “National Child Protection Fund” (Bank of Ceylon Nugegoda Branch - Account No. 71252941).

12. Sustenance of the Fund and Development Expected

The applicability of this to all Sections from 1-40 of the N C P Act has been confirmed. Furthermore as per the Act in the future the activities of the Authority would be co ordinated for the improvement of Children and their security. The Fund will be originated from communities such as all Sri Lanka loving local and foreign entities, individuals and business ventures would be utilized, and the authority handled its in a very transparent manner.
