Regulations of (Volunteer Force and Volunteer Reserve) of the Sri Lanka Army 1985 published in the *Gazette* (Extraordinary) No. 476/26 dated 20th October, 1987 are hereby further amended as follows:-

Amendments to Regulations 33 and 51 of the Sri Lanka Army (Volunteer Force and Volunteer Reserve) Regulations 1985

#### Regulation 33

Regulation 33 of the Sri Lanka Army (Volunteer Force and Volunteer Reserve) Regulations 1985 is hereby amended by the addition of Regulation 33 (5) which reads as follows:-

Regulation 33 (5) - Any officer who possesses 10 years of reckonable service and retires from service or resigns his/her commission other than on disciplinary grounds shall be issued a statement of service on his/her retirement or resignation.

#### Regulation 51 (2)

Regulation 51 (2) hereby amended by substituting the following regulation.

On being discharged, every soldier shall be furnished with a discharge certificate by his Commanding Officer. Where the discharge has been effected for any of the reasons stipulated in paragraphs (a) (g) (h) or (i) of this regulation, such reason shall be stated in the discharge certificate and the discharge certificate shall contain an assessment of his/her military conduct during the period of his/her service. In all other cases the discharge certificate shall be on a specified form and the reasons for discharge shall be stated as "services of soldier being no longer required".
