#### COMPETITIVE EXAMINATION FOR THE RECRUITMENT TO THE POST OF REVENUE INSPECTOR GRADE II OF LOCAL GOVERNMENT INSTITUTIONS OF THE WESTERN PROVINCE PUBLIC SERVICE – 2011

APPLICATIONS are called in from both males and females with following qualifications for the vacancies existing in the Grade II Revenue Inspector positions of the Local Government Institutions of the Western Province Public Service.

- 02. 2.1 According to the Public Administration Circular 06/2006(IV), monthly remuneration relevant to this post is Rs. 13,120 145 x 10 170 x 11 240 x 10 320 x 10 Rs. 22,040. (Twelfth step of MN-1-2006A would be the commencing step of the salary according to the P. A. Circular 06/2006(IV)).
  - 2.2 Age Limit.- Should be not less than 23 years of age and not over 45 years of age as at the closing date for applications. The maximum age limit should not have exceeded at the time of recruitment. Applicants who are already employed in the Public/Provincial Public Permanent Service are exempted from the maximum age limit mentioned above. They should forward their applications through the Heads of their Department.
  - 2.3 *Service Conditions.* Service conditions depend on the approved Service Minute. This is a permanent position with eligibility for a pension.
- 03. The closing date for the applications is 28.04.2011.

04. *Educational and other qualifications*. – A degree obtained from a recognized university and a credit pass obtained at the G. C. E. (O/L) examination for English Language.

#### 05. Candidates :

- 5.1 Should be citizens of Sri Lanka;
- 5.2 Should be of sound character;
- 5.3 Should be both physically and mentally fit to accomplish the duties of this position ;
- 5.4 Applicants should prove the permanent residency within the Western Province and should have at least 03 years of permanent residence within the Province as at the closing date of the application which is 28.04.2011. To prove this, a certificate issued by the Divisional Secretary confirming permanent residence should be forwarded at the interview.

06. *Procedure of Recruitment.* – Recruitments for the Revenue Inspector Grade II will be made subsequent to calling for applications and holding a written examination for the applicants holding basic qualifications and according to the number of vacancies existing for the post. In an instance where two or more candidates have received equal marks, the final decision regarding the selection of a suitable candidate vests with the Provincial Public Service Commission of the Western Province.

- 07. The Syllabus for the Written Examination .- This examination consists of 02 papers :
  - 1. General Knowledge Time 01 hour, marks 100
  - 2. IQ Test Time 01 hour, marks 100
  - 1. *General Knowledge.* The General Knowledge part would consist of a Multiple Choice Question paper with questions pertaining to economic, social, scientific, cultural, political and technical and the field of sports of the current world as well as questions that pay special attention to Sri Lanka.
  - 2. *IQ Test.* The IQ Test would consist of Multiple Choice Questions to test the applicants human abilities of logical capability, ability to take decisions and make judgments, mathematical, linguistic and conceptual capabilities that pertain to the measurement of the applicant's intelligence.

In order to get qualified, at least 40% marks should be obtained for each paper and according to the approved number of vacancies ; applicants who obtain higher marks for both papers will be recruited on the order of merit and subsequent to examining their qualifications.

Examination for the recruitment will be held in the three language mediums of Sinhala, Tamil and English, however, the medium applied for in the application would not be changed later.

08. The final decision regarding the filling of vacancies that have been reported currently and the vacancies that get created in future, with candidates who pass from the above mentioned examination, will be vested with the Western Province Public Service Commission.

09. Rs. 350 should be paid as the examination fee to the nearest Divisional Secretariat crediting to the Provincial Council Revenue Head 20-03-90-01 and the receipt, W. P. 1. which is obtained thus should be attached to the application form. Securing a photocopy of the receipt would be useful. Except the receipts obtained in the above manner, Receipts or Money Orders received from other institutions will not be accepted and due to whatever reason the examination fees will not be refunded.

10. *Procedure for applying.*– Applications should be prepared in both sides of A4 size papers (21 x 29cm) according to the specimen application contained in this announcement. When preparing the application, No. 01 to 06 should be included into the first page, No. 07 to 09 should be contained in the second page whereas the rest should be included in the third page as it appears in the specimen application. Further, when the application is prepared, the name of the examination stated in the heading should also be stated in English in Sinhala or Tamil medium applications in addition to heading stated in Sinhala or Tamil. Duly completed applications should be sent to the Secretary, Provincial Public Service Commission (W. P.). Independence Square, Colombo 07, by registered post before 28.04.2011. On the top left corner of the envelope in which the application is enclosed, "Recruitment to the Post of Revenue Inspector Grade II of the Local Government Institutions of the Western Province Public Service - 2011" should be stated. (Officers who are already in the permanent positions of the Public Service/Provincial Public Service shall forward their applications through the Head of the Department). Applications received late or not conforming to the specimen application or with incomplete details will be rejected without any prior notice. Whether application is received or not will not be informed.

11. Applications which do not satisfy the requirements stated in the announcement will be rejected. Issuance of an admission paper to sit for the examination is not a valid reason to believe that the applicant has accomplished all the qualifications to be eligible for this post.

12. At the time of the interview conducted to check the qualifications of the applicants as required by the announcement, if it is revealed that the applicant does not possess qualifications as mentioned in the announcement, his/her right to obtain the appointment will be annulled. It is compulsory that every applicant should acquire all the qualifications relevant to this post by 28.04.2011 or on a date prior to that date.

13. The recruitment examination, if it will be held by the Department of Examinations, as soon as the admissions are issued, a news paper advertisement stating that will be issued by the Sri Lanka Department of Examinations. Subsequent to the publication of the announcement if the admissions did not reach you within 2 to 3 days, it shall be informed either to the Secretary, Provincial Public Service Commission (Western Province), Independence Square, Colombo 07 as stated in the notice or to the Department of Examinations, Sri Lanka. It is more apt to inform the Provincial Public Service Commission (Western Province), Independence Square, Colombo 07 as stated in the notice of the application of the receipt obtained for the payment of money secured with you and a photocopy of the receipt obtained for registered post along with your request letter containing a fax number for the admission to be faxed if you reside outside Colombo.

14. *Identity of the Candidates.*– The applicant should prove his/her identity to the officer who is in charge of the examination hall for the subject he/she is sitting for. For this, one of the following documents will be accepted.

- (a) The National Identity Card issued by the Department of Registration of Persons ;
- (b) Valid Passport.
- *Note.* If in any case, if the applicant is unable to prove his/her identity as stated above, he/she is considered as non-eligible to sit for the examination.

15. Issuance of an admission to an applicant shall not be considered as recognition that he/she has accomplised eligibility to sit for the examination.

16. Candidates are subjected to the rules and regulations enacted by the Commissioner General of Examinations/Provincial Public Service Commission regarding the conduct of examinations. If those rules and regulations are violated, he/she shall have to subject to a punishment levied by the Commissioner General of Examinations.

17. If at any instance it is proved that the applicant does not possess the qualifications required before he/she receives the appointment, the candidateship will be canceled. Subsequent to the appointment, if it was revealed that the applicant has consciously forwarded false details or has concealed the true information, he/she would be expelled from the service.
