#### **Entertainment Tax Ordinance**

THE following resolution passed by the Maho Pradeshiya Sabha in terms of Sub-section (1) of section 2 of the Entertainment Tax Ordinance (Chapter 267) has been approved by the Minister of Local Government in the North Western Province in terms of Sub-section and is hereby published in terms of that Sub-section.

### RESOLUTION

By virtue of powers vested by Sub-section (1) of section 2 of the Entertainment Tax Ordinance (Chapter 267) the Maho Pradeshiya Sabha, hereby resolves to impose and levy with effect from the 01st day of the following month of the month in which this resolution is published in the *Gazette*, a tax equivalent to 19% percent of the payment made for admission to entertainments defined in the Ordinance (other than Entertainment Tax) held in the area within the administrative limits of the council.

Provided that the tax levied upon a payment made to watch a film shall be 7.5 percent of that payment within the first two years in which this resolution is in force.
