The office shall be open to the public for inspection of the Register on every working day from 9 a. m. to 2.30 p. m. Applications for inspection of the Register will, However be accepted up to 2 p. m. on working days.

### Trade Marks Limited to Colours

Where it is stated in the advertisements of an application that the mark upon its registration to be limited to certain colours, are market in the usual heraldic manner.

### Association

Where it is stated that an advertised mark is to be associated under section 112 of the Code of intellectual Property Act. No. 52 of 1979 with another mark, it is indicated by its official number.

## OPPOSITION
