### Financial Statements for the year Ending 31st December, 2007

#### Notes to the Financial Statements

##### 01. Significant Accounting Policies

###### 1.1 General

The Financial Statements of the University have been prepared in conformity with the generally accepted accounting principles and the Sri Lanka Accounting Standards on the Historical Cost convention. The transactions are recorded at the value prevailing at the dates when the assets were acquired, the liabilities were incurred and funds received in accordance with generally accepted accounting principles consistent with those used in the previous years.

###### 1.2 Assets and the basis of their valuation

The Fixed Assets are shown at cost less accumulated depreciation. All assets have been recorded at cost of purchase with incidental expenses. Assets received as donations have been valued at their cost.

### 1.3 Depreciation of Non Current Assets

Depreciation is charged on Straight-Line method at the following rates per annum in order to write off the cost of such assets over their estimated useful life:

Building - Including Structures	5%
Furniture and Fittings	10%
Office Equipment	20%
Books and Periodicals	20%
Motor Vehicles	20%
Lab and Teaching Equipment	20%
Cloaks	20%

### 1.4 Inventories

The First in First Out method (FIFO) is adapted to value cost of stock. Stock were physically verified and valued to ascertain the current value as at the Balance Sheet date.

### 1.5 Provisions for Gratuity

Provision for gratuity has been calculated only for the staff that has completed five (5) years at the University service.

### 1.6 Provision for Accruals and Liabilities

Provision for accruals and liabilities are provided based on the available supporting documents.

### 1.7 Receivables

A sum of Rs. 42,053,439 is due from employees on account of Breach of Contracts as at 31.12.2007.
