I, the Chairperson of Manmunai Pradeshiya Sabha, notify all men by these present that in terms of the Provisions under section 134(1) of Pradeshiya Sabha Ordinance Act, No. 15 of 1987 and of the dominations and deletions of the By-laws made, it has been decided to impose and levy a 5% tax of it's annual estimate of value for all
