On the left side.– Limit from the sheet roofed tea shop at the Panana Junction ; belongs to Mr. D. P. Ranasingha to the tiled house belongs to Samarasekara of Kanadeniya area,

On the right side.– The limit from the house with concrete slab at the Panana junction ; belongs to Mr. A. W. S.
