- Priority will be given to those who are currently employed in Pradeshiya Sabha of Imaduwa on the basis of permanent/casual/temporary/allowance and contract. (Satisfactory service period has to be proved by a service certificate).
- Possession of heavy vehicle driving licence will be additional qualification for those apply for the post of Driver.

04. Method of recruitment :

- Recruitments will be made after verifying qualifications of applicants in an interview.

05. Conditions of service :

- The post is permanent and pensionable. Should contribute to the Widows and Orphanage Pension Scheme.
- Recruitment will be made under probation period of three years. If the work, attendance and conduct is satisfactory service would be confirmed at the end of this period of probation.

06. Other General Conditions :

- (iv) Should not be a person who was convicted in a court under Penal Code.
- (v) Applicant should be a permanent resident in Southern Province for a minimum period of 03 years at the closing date of application. (Residence has to be proved by electoral register or certificate issued by Divisional Secretary).
- (vi) Applicants who are already employed in Public or Provincial Public Service should not have been punished for an offence (Except warning) for last 05 years and they must have a satisfactory service period obtaining due salary increments. They are expected to contribute further more to the Widows and Orphanage Pension Scheme.
