INTERNATIONAL Postal Charges have been revised with effected from 01st of November, 2011 as per the consent of H. E. THE PRESIDENT as the Hon. Minister of Finance and Planning.

(02) *Foreign Letter Post*

Postal charges for sending up to the weight of 20g instead of 10g got levied as postal charges for foreign letter post have been calculated as per the rules of Universal Postal Union. Therefore, additional charges are not levied up to first 20g.

Relevant Postal Charges shall be collected for each 10g increased thereafter.

It has amended the classification of four groups of countries in the world as 8 groups according to the distance between Sri Lanka and the place of destination as to benefit the Public.

(03) *EMS*

It has amended the present classification of 9 categories of countries of the world as 14 categories as per the delivery charges levied by each country and their distance. Accordingly postage revised is appeared in annexure 2.

(04) *Sea and Air Parcels*

Postage for air parcels and postage for sea parcels are appeared in annexure 3 and 4 respectively.

(05) *Bulk Mail*

Foreign mail items, those are printed locally and directed for post in bulk by a certain person, are known as bulk mail. (Maximum limit is 1,500 per day or 5,000 per fortnight). A separate scheme of postage has been introduced for bulk mail this time. It appears under annexure 1.2.
