## 1. Accounting Policies

General Accounting Convention

The Financial Statements are prepared in accordance with the historical cost convention, whereby transactions are recorded at the values prevailing on the dates when the assets were acquired, liabilities incurred or the capital obtained. Further, the Financial Statements are in accordance with the Sri Lanka Accounting Standards laid down by the Institute of Chartered Accountants of Sri Lanka.

1.2 Previous year figures and phrases have been re-arranged wherever necessary to confirm the current year's position.

## 1.3 Post Balance Sheet Events

All material events occurring after the Balance Sheet Date have been considered and where necessary adjustments have been made in the Financial Statement.

## 2. Assets and Bases of their Valuation:

## 2.1 Property, Plant and Equipment

Costs incurred in acquiring improving or extending a property, plant and equipment have been treated as Capital Expenditure. Property, plant and equipment are recorded at cost less accumulated depreciation.

## 2.2 Depreciation

Depreciation has been calculated in order to write off the cost of property, plant and equipment on the reducing balance method basis over the expected useful lives of the concerned assets, using the following rates:

#### 2.3 Leased Assets

Where property, plant and equipment have been financed by leasing arrangements, which transfers substantial benefits and risks of ownership, the assets are treated as if they have been purchased outright and are included in Property, Plant and Equipment which have been depreciated according to rates specified above. The Capital Elements of the leasing commitment has been shown as an obligation under finance lease.

#### 2.4 Inventories

Inventories have been shown on an estimated basis.

#### 2.5 Short-term Investments

Short-term investments are valued at the lower of cost or Market Value.

#### 2.6 Trade Receivables and Other Receivables

Trade and other receivables have been stated at the amounts they are estimated to realise.

#### 2.7 Cash and Cash Equivalents

Cash and Cash Equivalents include cash in hand and at Bank and call deposits, fixed deposits at bank and Treasury Bills.

#### 3. Liabilities and Provisions:

### 3.1 Current Liabilities

Current liabilities are those which fall due for payment on demand or within one year from the Balance Sheet Date. Non current liabilities will fall due for payment one year or more after the balance sheet date.

#### 3.2 Taxation

The institute is exempt from income tax under Section 8 (a) (xii) of the Inland Revenue Act, No. 10 of 2006.

## 3.3 Retirement Benefit:

#### (I) Defined Benefit Plan

Provision has been made for retirement gratuity from first year of services for all employees in conformity with SLAS 16. However, under the payment of Gratuity Act, No. 12 of 1983, the liability to an employee arises only on completion of five years continued service.

#### (II) Defined Contribution Plan

All employees of the Company are members of the Employee's Provident Fund and Employee's Trust Fund, to which the employers contribute 12% and 3% respectively of each employees consolidated salary.

#### 4. Income and Expenditure:

- (a) Income generated from main activities and other income are accounted on accrual basis.
- (b) All expenditure incurred in continuing the operations and maintaining the capital assets in a state of efficiency have been charged to income and expenditure account in arriving at the excess of income over expenditure.

(c) Profit/(Loss) on sale of Popcorn, Janitorial Service BC1S income and Agency Post Office activities are taken to Income and Expenditure Account for the year on cash basis.

Report of the Auditor General on the Financial Statements of the University of Jaffna for the Year ended 31st December, 2009 in terms of Section 108 (2) of the Universities Act, No. 16 of 1978.

The audit of Financial Statements of the University of Jaffna for the year ended 31st December, 2009 was carried out under my direction in pursuance of provisions in Article 154 (1) of the Constitution of the Democratic Socialist Republic of Sri Lanka read in conjunction with Sections 108 (1) and 111 of the Universities Act, No. 16 of 1978 and Sub-sections (3), (4) and (7) of Section 13 of the Finance Act, No. 38 of 1971. This report issued in terms of Section 108 (2) of the Universities Act. A detailed report in terms of Section 13(7) (a) of the Finance Act was furnished to the Vice Chancellor of the University on 23rd July, 2010.

#### 1:2 Responsibility of the Management for the Financial Statements:

Management is responsible for the preparation and fair presentation of these financial statements in accordance with Sri Lanka Accounting Standards. This responsibility includes, designing, implementing and maintaining internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatements, whether due to fraud or error; selecting and applying appropriate accounting policies; and making accounting estimates that are reasonable in the circumstances.

#### 1:3 Scope of Audit and Basis of Opinion:

My responsibility is to express an opinion on these financial statements based on my audit. Audit opinion, comments and findings in this report are based on review of the financial statements presented to audit and substantive tests of samples of transactions. The scope and extent of such review and tests were such as to enable as wide an audit coverage as possible within the limitations of staff, other resources and time available to me. The audit was carried out in accordance with Sri Lanka Auditing Standards to obtain reasonable assurance as to whether the financial statements are free from material misstatements. The audit includes the examination on a test basis of evidence supporting the amounts and disclosures in financial statements and assessment of accounting policies used and significant estimates made by the managment in the preparation of financial statements as well as evaluating their overall presentation. I have obtained sufficient information and explanations which to the best of my knowledge and belief were necessary for the purpose of my audit. I therefore, believe that my audit provides a reasonable basis for my opinion. Sub-sections (3) and (4) of Section 13 of the Finance Act, No. 38 of 1971 give discretionary powers to the Auditor General to determine the scope and extent of the audit.

## 2. Financial Statements:

## 2:1 Opinion:

So far as appears from my examination and to the best of information and according to the explanations given to me, I am of opinion that the University of Jaffna had maintained proper accounting records for the year ended 31st December, 2009 and except for the effects on the financial statements of the matters referred to in paragraph 2.2 of this report, the financial statements have been prepared in accordance with Sri Lanka Accounting Standards and give a true and fair view of the state of affairs of the University of Jaffna as at 31st December, 2009 and the financial results of its operation and cash flows for the year then ended.

#### 2:2 Comments on Financial Statements:

## 2:2:1 Accounting Policies:

- (a) Although the depreciation on property, plant and equipment should be calculated individually to avoid charging the depreciation on fully depreciated assets in terms of Sri Lanka Accounting Standard No. 18, contrary to this requirement the University had charged the depreciation on total value of the assets. Therefore, the accuracy of the depreciation shown in the accounts amounting to Rs. 101,953,469 could not be considered as disclosing the correct position of each asset.
- (b) According to the University Grants Commission Circular No. 649 of 05th October, 1995 and Sri Lanka Accounting Standard No. 18, the depreciation should not be computed for the value of land. However, due to failure to identify the value of land and buildings separately the depreciation at a rate of 5% had been provided on lands as well.

#### 2:2:2 Accounting Deficiencies:

The following observations are made:

(a) Even though Books and periodical valued to Rs. 2,191,072 had not been received to the University up to the end of the year under review, depreciation amounting to Rs. 438,214 had been charged on these items of asset.

(b) Payment of gratuity amounting to Rs. 1,827,934 had not been charged against the provision for payment of gratuity in the accounts.

#### 2:2:3 Accounts Receivable and Payable

Following observations are made:

- (a) Supplies advance, displaced staff salary advance, building advance, sundry debtors and staff loan balances aggregating Rs. 4,718,972 had not been recovered for the period ranging from 01 to 23 years. Therefore the recoveries of these balances are in doubtful.
- (b) Confirmations had not been received from the debtors and creditors aggregating Rs. 551,553,205 and Rs. 26,801,425 respectively.
- (c) Age analysis in respect of debtors aggregating Rs. 1,697,624 had not been furnished to audit.
- (d) A sum of Rs. 37,455 over paid to an academic staff on account of books allowance in 1997 had not been recovered yet.

#### 2:2:4 Lack of Evidence for Audit:

Assets, advance to building constructions, bond obligations, liabilities and expenditure valued at Rs. 1,696,378,718 could not be satisfactorily vouched in audit due to non availability of required evidence.

2:2:5 Non-compliance with Laws, Rules, Regulations and Management Decisions:

## 3. Financial and Operating Review

#### 3.1 Financial Review:

#### 3.1.1 Financial Results:

According to the financial statements presented, the working of the University for the year under review had resulted in a deficit of Rs. 686,748,646 before taking the Government grant for recurrent expenditure as compared with the corresponding deficit of Rs. 626,517,307 for the preceding year. After taking the Government grant of Rs. 649,600,000 received for recurrent expenditure, the deficit for the year under review had been reduced to Rs. 37,148,646 and the Government grant of Rs. 601,700,000 received for recurrent expenditure for the preceding year the deficit of that year had been reduced to Rs. 24,817,307.

#### 3.1.2 Utilization of Specific Funds:

The specific funds amounting to Rs. 11,571,939 received had been transferred to fixed deposit account without being utilized for the purposes for which they were granted.

#### 3.1.3 Uneconomic Transactions:

Following observations are made:

- (a) One hundred direct telephone lines had been provided for faculties and service units in the University and most of those direct telephone lines had been utilized for internal communication in the University although, an internal communication system was already available in the University. As a result the telephone charges amounting to Rs. 7,132,248 paid could have been reduced to Rs. 6,800,248 if the intercom system is in operation in its full capacity.
- (b) Although cash balances ranging from Rs. 314 Million to Rs. 352 Million were held at the faculty of Graduate studies and external exam unit at the end of each month of the year under review, action had not been taken to invest this money in an interest bearing source. As a result considerable amount of income had been deprived to the University.
- (c) Even though a guest house facility is available at the University and a guest house keeper was appointed and salary aggregating Rs. 207,150 had been paid for the year under review, a sum to Rs. 421,548 had been paid to various lodges as accommodation charges (food and Lodging) for guests arrived during the year under review.
- (d) A sum of Rs. 343,645 had been paid to a private contractor for levelling and Gardening of courtyard of the New Arts block at the University including the maintenance labour charge of Rs. 195,000. This maintenance job could have been done by the labourers of the University.

#### 3.1.4 Assets Management:

The Following observations are made:

- (a) Two Scooters had remained unused for more than eight years.
- (b) A land purchased for construction of Management Faculty at a cost of Rs. 6,589,667 had not been utilized for over 5 years for the intended purpose.
- (c) 5,258 items of 10 Category of inventory aggregating Rs. 200,305 had been remained idle at the stores over eight years.
- (d) A time recording machine purchased for Rs. 182,400 had been remained unused since 2001.
- (e) 225 steel beds which were purchased for Rs. 2,137,500 had been remained unused for over two years.

#### 3.1.5 *Identified Losses*:

- (a) Losses of fixed assets, stores items and books, to the value of Rs. 348,370 had been written off during the year under review.
- (b) A sum of Rs. 90,062 had been recovered by a bank for the cancellation of six letters of credit for the period 2006 to 2009.

#### 3.1.6 Delays in Projects:

The Following observations are made:-

- (a) An advance payment of the consultancy fees amounting to Rs. 750,375 had been made to the National Water Supply and Drainage Board during the year 2008 for introducing a waste water disposal system to the female hostel complex of the University. However, the works had not been commenced even up to end of the year under review.
- (b) A sum of Rs. 7,611,885 had been paid to a construction company during 1999 to 2000 for the construction work for an Auditorium at Medical Facultry. However, construction works had not yet been fully completed. Further due to undue delay the cost of construction would be increased tremendously and the objective of this building also had not been achieved. In addition a sum of Rs. 13,000,000 had been paid to the Dept. of Buildings during the years 2005 and 2006 for the Interior decoration works, which was not yet commenced.
- (c) A sum of Rs. 2,607,050 had been paid in the year 2005 as an advance to the Ceylon Electricity Board for the supply of Bulk Electricity to the faculty of Agriculture. But that project had not yet been commenced.
- (d) Although a sum of Rs. 2,000,000 had been paid to the Department of Buildings as an advance for the construction of over head tank for students Hostel at Thirunelvely in 1989, works to the value of Rs. 1,590,000 only had been completed. As a result students of this facility are being affected.
- (e) A sum of Rs. 6,589,667 had been paid in 2005 to purchase a land for the construction of building for Faculty of Management and Commerce. The project had not yet been commenced.
- (f) A sum of Rs. 1,323,071 had been paid as Value Added Tax to a company in Colombo and another sum of Rs. 8,820,474 had been paid from SIDA IT Networking Project to the same company. No progress report relating to the above project had been made available for audit. This project was commenced on early part of the year 2005 but it was not completed even up to 30th June, 2010. As a result the objective of the project had not been achieved as expected.
- (g) Three advances amounting to Rs. 3,200,000, 3,014,000 and Rs. 5,615,000 had been released on 31st December, 2004, 16th November, 2005 and 10th November, 2006 respectively to the Chief Engineer, Department of Buildings of the then North East Provincial Council for the construction of overhead tank and sump for Vavuniya Campus at Pambaimadu.

The Construction of sump work had been completed. However, the overhead tank and balance works had not been completed. In the mean time, the contract was terminated by the Department of Buildings. A sum of Rs. 2,439,956 had already been paid to the Contractor up to the termination. A fresh Agreement to the value of Rs. 5,615,000 with another contractor had been signed on 10th November, 2006 for balance works. But the works had not yet been completed up to 30th June, 2010.

#### 3:2 Human Resources Management

The Following observations are made:

- (a) Appointments to the permanent posts of lecturers had been made separately to each and every Faculty of the University as a general rule resulting in engaging several lecturers in the same field of study. In preparing time tables of various Faculties, the availability of the service of permanent lecturers in other Faculties had not been considered. Whenever the service of lecturers in the permanent staff were required for another Faculty, separate letters of appointment had been issued to them as visiting lecturers and additional lecture fees had been paid for such services.
- (b) In several instances, temporary lecturers, tutors, demonstrators etc. had been appointed on the request made by the Heads of Department of the University without following proper recruitment procedures.
- (c) The regular feature of the University in filling the vacant posts of academic staff is in an improper manner without giving an opportunity to complete those who have qualified and expecting employment in the University system. Although this had been pointed out in my reports for the last several years, no action had been taken to rectify these deficiencies.

#### 3:3 Courses and Examinations

The Following observations are made:

- (a) Total numbers of students registered in 10 courses of the University were 4776. Total recurrent expenditure incurred during the year under review amounted to Rs. 423,716,860. The average recurrent cost per student for the year was Rs. 88,718
- (b) Dates to hold the examinations for various courses conducted under each faculty of the University and target dates to release results of the examinations had not been determined. It was further observed that there were considerable delays in releasing the results of examinations conducted by certain Faculties during the years 2008 and 2009. According to the University Grants Commission Circular No. 636 of 14th July, 1995 results should be released within three months after the examination. But results had been delayed by periods ranging from 6 to 12 months.

## 3:4 Granting Leave with Pay and No Pay for Postgraduate Studies

The Following observations are made:

- (a) Study leave had been approved for more than one year to the lecturers who had gone abroad for studies without taking into consideration of the instructions stipulated in Section 27.4 of Chapter 10 of the Establishments Code for the University Grants Commission and the Higher Educational Institutions.
- (b) There were instances of approving study leave to the lecturers who were under probationary period before completing one year service.

#### 3:5 Budgetary Control

Significant variations were observed between the budget and the actual thus indicating that the budget had not been made use of as an effective instrument of management control.

#### 4. Systems and Controls

Deficiencies observed during the course of audit were brought to the notice of the Vice Chancellor of the University by my detailed report issued in terms of Section 13 (7) (a) of the Finance Act. Special attention is needed in respect of the following areas of control:-

- (a) Human Resources Management,
- (b) Budget,
- (c) Stores,
- (d) Contract Adminstration,
- (e) Library Administration,
- (f) Fixed Assets.

  - (iii) Building Advance:- Action had been taken to settle the unsettled advance in 2010.
  - (iv) Staff Loan: Action has been taken to recover.
- (b) Most of the receivable amounts represent the balance of loans/advances paid to the employees and the payable account represent the students deposit and staff security deposits. In this context, obtaining the confirmation was not considered.
- (c) Age Analysis had been furnished in the Schedule for 2009 rendered to the Audit. Please revisit it. However the age analysis for the sum of Rs. 1,697,624.00 is given below for your easy reference.

- 2:2:5 Action has been taken to comply with certain lapses in complying with the provisions in the Universities Act, E. Code and Circulars etc.
- 3:1:2 Funds could be utilized as per the criteria's given by the donor.
- 3:1:3(a) It is with an anticipation that the ongoing and Networking project within the University funded by SIDA will replace, we postponed to effect the intercom system. There were unavoidable delay in completing the Network by the contractors due to the prevailing situation. But now this Networking project is recommenced and nearing completion and then the unnecessary charges to Telecom will be reduced.

- (b) The Cash balance available due to the collection of several Self Financing Courses. The Self Financing Courses are running Courses within the stipulated period. Also the amount received from Bond obligation and Engowment Fund are included in the balance and these have been transferred to the Fixed Deposits from time to time.
- (c) The guest house available at the university has very little facilitates such as Air condition and other items. Professors and other Officials are not willing to stay in this present condition. We are taking steps to improve the facilities.
- (d) The number of unskilled labourers of the University has not been increased substantially to meet our needs in the last 25 years. Whereas the space and the infrastructures have been increased more than fourfold. Further nearly 1/3 of the vacancies at the Maintenance Branch remain unfilled due to the procedural barriers. Since the available staff engaged with important and urgent works only, this work being outsourced.
- 3:1:4(a) Action is being to repair the Scooters.
  - (b) There was a delay in getting Cabinet approval for this project. But now after obtaining the Cabinet approval as well as architectural approval is received, the 01st phase of the construction is now completed.
  - (c) Action has been taken to use the items mentioned in the report.
  - (d) There were some impediments in implementing this item. But now action has been taken towards this.
  - (e) The beds that were purchased for the use by out station students with additional private residential hostels. And now these beds are being reserved for the re establishing Siddha Medicine hostels and for the additional needs of the existing hostels.
- 3:1:6 (a) The delay is due to the revision of the plan due to the experience by the Nisha Floods and also due to the financial limitations. Now we are proceeding with it.
  - (b) The University also regrettably admit this delay and given attention to complete this work and with frequent communication with the Buildings Dept., Colombo and the changing environment of the country the completion of this contract is now in progress.
  - (c) We were holding this money with CEB with depositive anticipation of the re-establishing our Faculty of Agriculture in Kilinochchi. But now the prolong delay and the limitation of fund now this money has been transferred to another urgent project of hostel (Medical Faculty) in 2010.
  - (d) Due to the adverse situation prevailed in North and due to lack of funds this was delayed. Now action is being taking to recommence.
  - (e) This refers the answer given under 3.1.4 (b).
  - (f) IT networking project had been undertaken by the University of Colombo School of Computing under the SIDA IT Networking Project. According to the terms and conditions the University of Jaffna had to meet the payment of VAT. Accordingly the University paid Rs. 1,323,071.10 as VAT to the Enterprise Technology (Pvt) Ltd who is the Contractor assigned the contract by the University of Colombo School of Computing. Further University of Jaffna had not paid Rs. 8,820,474 to the University of Colombo School Computing. This amount was paid by the University of Colombo School of Computing to the contractor. The project report from the University of Colombo School of Computing can be obtained for verification.
    - In fact as we referred in the answer 3.3.3 (a) This project is being delayed due to the prevailing situation and the contractors. Now with the change of environment this project is being activated and nearing completion.
  - (g) The Contract being changed due to the unavoidable situation faced by the Contractor and now with the change of contractor the work is in progress.
- 3:2 (a) The permanent teaching staff are involved in Faculty as well as interfaculty teaching without any additional remuneration other than their salaries. When the teaching load of a teacher in his/her departments/Faculty is far in excess of the approved academic norms of a particular academic position, payment is made by appointing them as visiting lecturers for the lectures. They take out side their academic norms in departments out side the faculty to which they belong to. Only a small number of such visiting appointments are made under inevitable circumstances.

Cadres are determined by the University Grants Commission based on the needs of each Faculty. Further although the title of the "Field of Study" may look alike, the scope of the course and the courses contents are varied. In few other occasions eminent persons of a particular field also invited as visiting Professors.

- (b) The temporary posts in Assistant Lecturer, Tutor, Demonstrator and instructors are regularly advertised before the commencement of every academic year and recruitment is made by following the proper recruitment procedure.
  - However when an appointed person resigns or leaves the service during an academic year and when there is no adequate time to fill the vacancy by advertisement, appointments are made on the request of the Head and the Dean in a very few occasions, so as to carry out the academic programmers within the Scheduled academic calendar. Such appointments (a few) are made only for the balance period of the appointments of the person resinged.
- (c) We are very conscious in recruiting academic positions with excellence and every effort is being taken in this regard according to the UGC regulations. In fact in certain disciplines in spite of our repeated advertisements, we are unable to find appropriate candidates. In such circumstances we employed visiting or contract staff. This again only few instances. In this regard we expect a conscious attention and clear understanding.
- 3:3 (b) In some Faculties examinations are conducted at the end of the academic year. In some at the end of each semester. However the results of the examinations conducted at the end of the first semester are released along with the result of the second semester. This is the examinations regulations. This is because of the results are released for each semester, there is a possibility of students skipping two out of five course units in the second semester. However the structures of the Degree Programmed are changed now and for the new batches of students results are released within three months.
- 3:4 (a & b) In special occasions such as the candidate obtained valuable scholarship.
- 3:5 The following steps have been taken with regard to Budgetary Control.
  - (i) Budget is approved by the Finance Committee and the Council annually;
  - (ii) Vote Ledger is computerized in order to monitor the expenditure within the allocation;
  - (iii) Monthly Comparative statement (Budgeted amount-Actual Expenditure) is placed before the Finance Committee;
  - (iv) Sub imprest to the Vavuniya Campus is monitored by a separate votes ledger at the Finance Branch of the University.
