**RECOMMENDATION UNDER SECTION 104 THE CANCELLATION OF A GRANT ISSUED UNDER THE LAND DEVELOPMENT ORDINANCE AS AMENDED BY THE ACT, No. 16 OF 1969 AND THE ACT, No. 27 OF 1981 (AMENDED)**

### NOTIFICATION MADE UNDER STATE LAND REGULATION No. 21 (2)

IT is hereby notified that for the Commercial Purpose, Mr. Upali Rathnayake has requested on lease a State land containing in extent about 12 P. out of extent marked Lot ..... as depicted in the Plan No. .... and situated in the Village of Polonnaruwa which belongs to the Grama Niladhari Division of No. 172, Polonnaruwa coming within the Area of Authority of Thamankaduwa Divisional Secretariat in the District of Polonnaruwa.

02. Given below are the boundaries of the land requested :-

- On the North by* : Water Drainage ;  
*On the East by* : Land of Mangalika ;  
*On the South by* : Main Road ;  
*On the West by* : Land of Hemantha Kumara.

The land requested can be given on lease for the necessary purpose. Therefore, the Government has intended to lease out the land subject to other Government approved conditions :-

- (a) *Term of the Lease.*- Thirty (30) Years ( From 15.06.1995 onwards);  
*The Annual Rent of the Lease.*- 4% of the undeveloped value of the land as per valuation of the Chief Valuer for the Year 1995;  
*Penalty .-* Treble 4% of the developed value of the land;
- (b) The must, within one year of the commencement of the lease, develop the said land in such a manner as to captivate the mind of the Divisional Secretary ;
- (c) The lessees must not use this land for any purpose other than for the purpose of Residential Purpose ;

- (d) This lease must also be subject to the other special conditions stipulated and imposed by the Divisional Secretary and by other institutions;
- (e) This lease must also be subject to the other special conditions stipulated and imposed by the Divisional Secretary/Scoping Committee/Board of Investment of Sri Lanka and by other institutions;
- (f) Once the land is given on lease and in the event of failure on the part of the lessees to substantiate within the specified time frame the purpose for which the land was obtained action will be taken to terminate the lease ;
- (g) No sub leasing can be done until the expiry of a minimum period of 05 years;
- (h) Payment of the lease must be regularly made and if defaulted in payment, the agreement will *ipso facto* lapse;
- (i) The buildings constructed must be maintained in a proper state of repair.

If acceptable reasons are not submitted to me in writing within six weeks of the date herein below to the effect that this land must not be given on lease, the land will be leased out as requested.
