As per the order issued to me in the above case and the judgment of Panadura District Courts dated 13th January 1993 the above mentioned 1st defendant should pay the Defendants Rs.300,000 together with interest at 24% from 21.10.1986 to the date of judgment being 13th January 1993 and at 4% interest from the date of judgment to the date of payment in full.

Further when the plaint in this case was filed Mortgage Bond Ni : 471, Marked 'අ' the 2nd and 3rd defendants answers mentioned about mortgaged Bond Nos. 48 and 829 Marked "2V1" and "2V2" respectively and they have been registered. As the Mortgage Bond Nos. 48 and 829 are registered the dues of 2nd and 3rd defendant institutions have to be paid first in case of a sale, and when dues of 2nd and 3rd defendant institutions are paid the balance money of the sale could be utilized to settle the dues of plaintiffs on Mortgage Bond No. 471 as per the delivered judgment.

Hence, as per the judgment, if the land described in the schedule is sold the dues of 2nd and 3rd defendants on Mortgage Bond Nos. 48 and 829 respectively have to be paid in the following manner.

- (a) Rs.76,808 with interest at 30% 01.06.1985 and 5% as Turnover Tax on Mortgage Bond No. 48.
- (b) Rs. 650,000 with interest at 30% from 01.11.1982 and 5% as Turnover Tax on Mortgage Bond No. 829. Dues of 2nd and 3rd defendants respectively should be paid first
- (c) As per the order in the judgment Rs.300,000 and interest at 24% from 21.01.1986 to the date of judgment, being 13.01.1993 and 4% interest from thereon to the date of settlement in full.

Further, the judgment orders the 1st Defendant to pay costs of the case to Plaintiffs, the 2nd and 3rd defendants.

The 1st Defendant has paid the Plaintiffs Rupees One Million (Rs.1,000,000) out of the amount due to them and Rupees Two Million (Rs.2,000,000) out of the amounts due to the 2nd and 3rd Defendants. (The 1st Defendant has taken back the Two Million rupees paid to the 2nd and 3rd Defendants.)

As the 1st Defendant has failed to comply with the order given by the District Court of Panadura on 13th January 1993, the property owned by the 1st Defendant and described in the schedule hereto will be sold by me at a Public Auction to be held.

On 10th Day of January 2013 at 2.00 p.m. at Kaldemulla land called Moratuwa Kurunduwatta within the Municipal Limits of Moratuwa.
