By virtue of power vested in the Pradeshiya Sabhas under Sub-section I of the Section 150 of Pradeshiya Sabha Act, No. 15 of 1987, it is to be imposed and leveid Industrial Tax for the Year 2012 from each industry maintained in the Rambukkana Pradeshiya Sabha jurisdiction as in the 1st Column of the 1st Schedule considering the annual value depicted in the IInd Column of the 1st Schedule below, and further it is proposed that the ditto industrial tax shall be paid to Rambukkana Pradeshiya Sabha before 30th day of April, 2012.
