Order under Section 27(a) (1)

THE PROTECTION OF THE RIGHTS OF ELDER'S ACT, NO. 9 OF 2000

REGULATIONS made by the Minister of Social Services under Section 34 of the Protection of the Rights of the Elders Act, No. 9 of 2000 read with Section 17 and 18 of the Act.

REGULATIONS

1. These regulations may be cited as the Protection of the Rights of Elders Regulations, 2012.
2. (1) Every person or organisation engaged in the establishment and maintenance of any Institution intended for providing residential care for elders shall, if such institution has more than five elders residing therein, forthwith make an application for registration of such Institution providing residential care for elders.
- (2) Every application for registration shall be made in terms of Section 16 and Section 18 of the Act, and shall be forwarded to the Secretary of the Council. Such application shall substantially be in the form set out in Schedule I to these regulations.
3. Where the applicant is an organisation -
 - (1) the following documents shall accompany the application -
 - (a) a copy of the Constitution of the organisation;
 - (b) a copy of the Minutes of the last annual general meeting of the organisation;
 - (c) a copy of the statement of accounts of the organisation of the year preceeding;
 - (d) a report on the services and assistance provided by the organisation; and
 - (e) a report from the Director of Health Services of the Administrative District within whose Jurisdiction the Institution sought to be registered is situated.

- (2) Every application shall be duly completed and shall be signed by the Secretary of the organisation.
4. Where the applicant is a person -
- (1) the following documents shall accompany the application -
- (a) a report on the services and assistance provided by that person;
- (b) two letters of recommendation issued by two eminent persons;
- (c) a report on the income, assets and liabilities of that person; and
- (d) a report from the Director of Health Services of the Administrative District within whose jurisdiction the Institution sought to be registered is situated.
- (2) Every application shall be duly completed and signed by the person in charge of the Institution.
5. Every organisation or person who is registered in terms of this Act, shall be issued a Certificate of Registration required by section 18 of the Act which shall be in the form as set out in Schedule II to these regulations. A Certificate of Registration shall not be transferable.
6. (1) Every registered person and registered organisation shall maintain the following documents in accordance with the directions given by the Council in connection with the Institution maintained by them which provided residential care for elders -
- (i) cash book with bank accounts;
- (ii) petty cash book;
- (iii) main ledger;
- (iv) main journal;
- (v) register of members;
- (vi) membership fees register;
- (vii) payment vouchers;
- (viii) debtors and creditors ledger;
- (ix) receipt books;
- (x) assets register;
- (xi) books containing minutes of committee meetings and general meetings;
- (xii) registers of resident elders who receive residential care in the Institution;
- (xiii) register of staff details;
- (xiv) file containing relevant Acts, regulations and rules.
- (2) The provisions of sub-paragraphs (v), (vi), and (xi) of paragraph (1) shall apply only in relation to a registered organisation.
7. (1) Every registered person or registered organisation shall, as the case may be -
- (a) Act in conformity with special or general directions issued from time to time by the Council;
- (b) maintain proper accounts of the income and expenditure, assets and liabilities and all other transactions of such person or organisation;
- (c) conduct the general meetings and committee meetings regularly;
- (d) identify projects and programmes which would highlight the objectives of the Act taking into consideration the funds available to such person or organisation, and submit them for approval of the Council;
- (e) submit where relevant an audited statement of accounts and an annual progress report to the Council along with the Minutes of the annual general meeting, within one month of the date of the holding of the annual general meeting.
- (2) The provisions of sub-paragraph (c) of paragraph (1) shall apply only in relation to an approval organisation.
8. Every approved person and approved organisation shall furnish to the Council, not later than January, 31st of every year subsequent to the registration of the Institution, the following information regarding resident elders -
- (1) (a) a certified copy of the register of resident elders in the Institution at the time of applying for registration;
- (b) a certified copy of the register of resident elders in the Institution on January, 01st of every year;
- (c) a certified copy of the register of deceased resident elders for the year ending on 31st December of the year immediately preceding that year; and
- (2) a report referring to the qualifications of the staff in employment on January, 01st of every year.
9. Every person and organisation, engaged in the establishment and maintenance of any Institution intended for providing residential care for elders for a fee shall submit to the Council on or before January, 31st of every year, a statement indicating -
- (a) the monthly fee to be charged during that year; and
- (b) services intended to be provided for the residents therein during that year.
10. No resident elder who has been an inmate in an Institution providing residential care for elders for a period of more than one year shall be removed from the Institution:
- Provided that a resident elder may be removed from an Institution for the purposes of transferring such elder to another home, only with the written consent of the elder. Such consent must be certified by a registered medical practitioner.
11. The Provincial Social Services Director, the Divisional Secretary, a Social Services Officer, a Social Development Assistant, an Elders Rights Promotion Assistant or any person authorized in writing by the Secretary of the Council may without prior notice, at any reasonable time, enter into and inspect any institution providing or purported to be providing, residential care for elders.

12. Every approved person and approved organization shall submit a report from the Director of Health Services of the Administrative District within whose jurisdiction such person resides or such organisation situates as the case may be. Such report shall be submitted to the Council for every six months.

13. The National Council for elders may suspend or cancel the registration of any institution which fails to carry out its functions in accordance with the rules and regulations made under the Act after investigation and considering the statements provided by the Provincial Social Services Director, the Divisional Secretary, a Social Services Officer, a Social Development Assistant, an Elders Rights Promotion Assistant or any person authorized in writing by the Secretary of the Council.

14. Every approved person and approved organisation, engaged in the establishment and maintenance of any institution intended for providing residential care for elders shall display in a conspicuous place in the Institution, the Certificate of Registration issued to such Institution by the Council.

15. (1) The Protection of the Rights of Elders Regulations, 2000 published in *Gazette Extraordinary* No. 1190/1 of June 25, 2001 are hereby rescinded.

(2) Notwithstanding the Protection of the Rights of Elders Regulations 2000 being rescinded, all Certificates of Registration issued by the Council and subsisting on the date of coming into force of these regulations shall continue to be in force for a period of six months from such date. Every person or organisation who or which is registered on that date shall make an application for a new registration, if such person or organisation is liable to register an Institution providing residential care for elders under the provisions of the Act.

16. In these regulations -

“Act” means Protection of the Rights of Elders Act, No. 9 of 2000, as amended by Act, No. 5 of 2011;

“Approved person” or approved organisation” means a person or an organisation registered under Section 18 of the Act, as the case may be;

“Council” means the National Council for Elders established under Section 2 of the Act.
