### NOTIFICATION MADE UNDER STATE LAND REGULATION No. 21 (2)

IT is hereby notified that for the Commercial purpose, Kirihamige Ramyalatha Balasooriya has requested on lease a State land containing in extent about 0.0126 Hectare out of extent marked and situated in the Village of Kebethigollewa which belongs to the Grama Niladhari Division of Kebethigollewa coming within the area of authority of Kebethigollewa Divisional Secretariat in the District of Anuradhapura.

02. Given below are the boundaries of the land requested :

- (c) The lessees/lessee must not use this land for any purpose other than for the Commercial Purpose;
- (d) This lease must also be subject to the other special conditions stipulated and imposed by the Divisional Secretary;
- (e) The buildings constructed must be maintained in a proper state of repair;

(f) Once the land is given on lease and in the event of failure on the part of the lessees to substantiate within the specified time frame the purpose for which the land was obtained, action will be taken to terminate the lease ;

(g) No sub leasing can be done until the expiry of a minimum period of 05 years;

(g) Payment of the lease must be regularly made and if defaulted in payment, the agreement will *ipso facto* lapse.
