# **By-Laws**

### PRADESHIYA SABHA-WARIYAPOLA

### By – Law on Declaration of Public Market "Public Market Area"

IT is proposed that the By-Law prepared by the Village Council, Wariyapola of the District of Kurunegala under Section 42 of Village Council Ordinance (Cap 257) and approved by the Minister of Public Administration and Home Affairs in terms of powers vested in him by the above said Section and then declared by a notice published in the *Gazette* No. 127 of 30.08.1974 by the Secretary of the said Ministry which mentions that the market area should be a circle of 02 miles' radii starting from the market should be further accepted by Pradeshiya Saba Wariyapola subject to the following amendments. The said amended By-Law notice has been accepted by general meeting held on 30.10.2003 and it is further notified that the said resolution should be implemented considering it is valid from the date on which the same was published in the *Gazette*.

1. The land area bounded by the Chilaw Road and Puttalam Road which are beginning from the centre of Wariyapola town and the Adikari Mawatha from which the either side of the said roads are linked shall be considered as the market of Wariyapola. The circular area with 02 miles' radii starting from the centre point of market premises shall be the market area.

1.1 Opening or maintenance of a meat/fish stall, a market or carrying out businesses by using a mobile vehicle holding or maintenance of a trade fair shall not be done within

this market area without a valid licence issued by the Chairman of Pradeshiya Sabha, Wariyapola or an officer authorized by him.

2. Carrying out businesses or publishing in that regard shall not be done in a place other than a place shown by the Chairman or the officer authorized by him, despite a person possesses a valid licence.

3. Pradeshiya Sabha, Wariyapola shall be the authority of opening and maintenance of meat/fish stalls, weekly fairs, daily fairs and day and night fairs within the said market area.

4. The resolution in respect of charges and rental for using a block of land or a shop apartment in the market area shall be adopted at general meeting and then annually imposed.

"Authorized Person" shall mean an officer authorized for aforesaid purpose on a written notice issued by the Chairman and "Sabha" shall mean the Pradeshiya Sabha, Wariyapola.
