GALIGAMUWA PRADESHIYA SABHA

By-laws

WE shall notify that the following By-laws are enacted by the Galigamuwa Pradeshiya Sabha which comes within the Administrative Authority of the Sabaragamuwa Province Provincial Council, under the power granted by Article 122, and Article 126 of Act, No. 15 of 1987 Pradeshiya Sabha laws and these By-laws are approved by the Minister of Local Government of the Sabaragamuwa Province under the power granted to him by Article 123 of the Pradeshiya Sabha Act.

BY-LAWS RELATING TO THE REGULARIZATION CONTROLLING AND COLLECTING OF CHARGES OF THE L. P. GASEOUS CREMATORIUM

Galigamuwa Pradeshiya Sabha

- 01. In terms of the powers vested in the Sabha under the Section 122 of the Pradeshiya Sabha Act, No. 15 of 1987, this Bylaw may be cited as the By-laws for maintenance, regularization, controlling and collecting of charges of the crematorium of the Pradeshiya Sabha. This will be come into effect from the date published *Gazette* notification.
- 02. (A) No any corpse shall be cremated in the crematorium of the Galigamuwa Pradeshiya Sabha without permission that issued by the Chairman or an authorized officer.
 - (B) Unless the Coroner or the Magistrate held inquest in to the death of the corpse under the Criminal Procedure Code, No. 15 of 1979 and at the end of the said inquest, the permission has been given by the said Coroner or the Magistrate for cremation the corpse, such corpses shall not be received for cremation or issued permission for cremation by the Chairman or the authorized officer.
 - (C) Unless the cause of death has been mentioned in the seventh row of the death certificate and the crematorium of the Galigamuwa Pradeshiya Sabha has been mentioned as the place of burial and cremation of the said certificate, such corpses shall not be received for cremation or issued permission for cremation by the Chairman or the authorized officer.
- 03. (*A*) The Sabha will determine the fees to collect for cremation of a corpse by a resolution of Galigamuwa Pradeshiya Sabha and the fees determined by that way may be amended occasionally by such a resolution.
 - (B) Fees, enacted under the above Section (A) or amended occasionally, shall be published in the *Gazette*

notification and displayed as apparently at the place where the applications are accepted to book the crematorium and the premises of crematorium.

- (*C*) The fees for cremation of a corpse may be enacted under the classification that mentioned in following Schedule 01.
- (D) No fee shall be charged for the cremation of a corpse of any Chairman, Vice Chairman, member or employ of the Sabha who serves or had served at the Sabha.
- (e) Even though a corpse has been delivered to the crematorium, the Chairman has the power of decision to bury the corpse, if the corpse shall be unable to cremate before or during of cremation on electric failure or technical faults.
- 04. Any person (hereinafter means Applicant) who intends to get permission shall forward an application prepared according to the Schedule 02 to the Chairman or the authorized officer with under mentioned documents.
 - (A) To confirm the relation between the deceased and the Applicant
 - 1. Birth certificate of the Applicant,
 - 2. Birth certificate of the Deceased,
 - 3. The certificate issued by the Grama Niladhari of the Grama Niladhari Division where the Applicant lives ;
 - (B) The certificate of permission for cremation the corpse, issued under Section 41.C of the Births and Deaths Registration Act, by the Coroner or the Magistrate, if he held inquest in to the death of the corpse under the Criminial Procedure Code, No. 15 of 1979 or if a corpse of a still birth, the certificate issued under Section 43.B of Births and Deaths Registration Act ; and
 - (*C*) The death certificate of the deceased.
- 05. If it has been decided to issue permission for the application, adduced to apply permission for cremation a corpse, it is the duty of the Chairman or authorized officer to Schedule such applications according to the receiving order. This register should be kept in the Office of Pradeshiya Sabha, Galigamuwa.
- 06. If it has been decided to accept for cremation a corpse according to the adduced application, Chairman or authorized officer shall issue permission to the Applicant after the collecting of due fee that levied according to the Schedule 01. According to the said permission, it should be clearly mentioned the time and the date that the corpse shall be given to the care-taker of the creamtorium.

- 07. If the corpse shall not be accepted for cremation, the reason for that shall be informed immediately to the applicant in writing by the Chairman or authorized officer.
- 08. Corpses shall be accepted for cremation of the crematorium within the time period from 7.00 a. m. to 8.00 p. m. in everyday.
- 09. Corpse shall be delivered to the care-taker of the crematorium on or before the time mentioned in the permission. The Chairman or authorized officer of the Galigamuwa Pradeshiya Sabha shall not be responsible for any inconvenience or damages, that cause from late delivery, to the Applicant or any other person who has the rights of the corpse.
- 10. The assistant of the crematorium shall maintain a register which recorded details according to the 2nd Schedule of this By-law in connection with each corpse, that cremated in this crematorium.
- 11. (*A*) The ashes of the every corpse shall be taken by the applicant or authorized person of him before the expiring of seventy-two hours from the cremation in over.
 - (B) At the occasion of reserve the crematorium for cremation of the corpse, a receptacle that mentioned the name and address of the corpse (can be closed toughly) shall be given to the care-taker of the crematorium by the close relatives of the deceased for the deposition of the ashes after the cremation of the corpse.
 - (C) Ashes disposed from the crematorium, shall not be given to any other persons except close relatives of the deceased.
 - (D) Even though on a written request of a applicant, authorized officer or the Chairman may extend the duration which the ashes is being kept under the custody of the care-taker of the crematorium.
 - (E) The extension period, that is being kept the ashes under the custody of the care-taker of the crematorium under the Section (D), shall not exceed two weeks from the date of cremation.
 - (F) The Chairman or the care-taker of the crematorium has the power to dispose the ashes which had not been removed after the extension period of removing the ashes was over.
 - (*G*) The duty of the Chairman or the authorized officer is to take actions to bury the ashes, that has been not received by any applicant or his authorized officer, in the premises of crematorium or any burial ground.
 - (H) The ashes disposed from the crematorium shall be kept in the receptacle, leaved according to the provisions of Section 11(B), with secure and deposited in the place or

room where reserved for same duty by the care-taker of the crematorium.

- 12. (A) No any other person shall enter to the covering partition of the cremation chamber except care-taker of the crematorium or his assistants after the corpse was entered to the cremation chamber and the safe door was closed of the crematorium.
 - (B) No person shall enter the premises of crematorium without permission of the Chairman or authorized officer or care-taker of the crematorium.
 - (C) However, what mentioned in the Section (B)
 - (i) Any person or persons who came with the person or authorized person, who has the permission to cremate a corpse, to hand-over the corpse for cremation; and
 - (ii) Any person or persons who came with the permit holder or his authorized representative to receive ashes of any cremated corpse on or before due date shall be considered as having permission to enter the premises of crematorium.
 - (D) In the event of any problem that arises at the implementation of these By-laws, the decision of the Chairman shall be the final.

Any person who violates these By-laws shall be guilty of an offence and on being convicted by a court of proper jurisdiction shall be liable to a fine not exceeding Rs. 750 and in case of a continued contravention, after convicted, an additional fine not exceeding Two Hundred and Fifty Rupees (Rs. 250) for each day of continuing the contravention.

- 13. In the premises of any crematorium, no person,
 - (A) shall behave in a disorderly manner;
 - (B) shall cause damage to the properties in the premises of crematorium of Galigamuwa Pradeshiya Sabha;
 - (*C*) shall disturb to the duties of care-taker of the crematorium and his any assistant ;
 - (D) shall decorate or stick bills in the premises of crematorium; and
 - (E) The person who booked the crematorium, shall agree to pay assessed value that determined by the Chairman, if a damage has been done for any property or building or instrument by the person who booked the crematorium.
- 14. (*A*) It is the duty of the Chairman to maintain and update the crematorium in due condition for cremation of corpses.
 - (B) If the crematorium has been closed for a short period to restore or maintain, it is the duty of the Chairman to display a notice in trilingual of that on a visible place at

the office of the permission issues and the entrance of the premises of the crematorium.

15. In these By-laws -

the term "Cremation chamber" means the chamber that deposited the corpse for cremation and the external chamber that built out side of the said chamber ;

"Premises of the crematorium" means all crematoriums and the land belongs to that ;

"Care-taker of the crematorium" means any servant who has been appointed to care the crematorium and do the duties of that ;

"Ashes" means anything that stands over the cremation of any corpse ;

"Corpse" means all corpse of any deceased or corpse of a still birth or a partition of a corpse.

16. In the event of any inconsistency between the Sinhala and Tamil texts of this By-law the Sinhala text shall prevail.
