01. Education qualifications :

- (a) Should have completed satisfactory service period of 05 years at lease as an officer of Sri Lanka Administrative Service or Sri Lanka Planning Service ;
or
- (b) Should possess a degree from a recognized university with one of subjects Natural Science/Economics/ Management (Business/Marketing/Human Resources/ Public) Commerce/Statistics ; and
- (i) Should have completed a satisfactory service of 05 years in an executive post in public, semi government or private sector and two years of that period must be of senior executive post ;
or
- (ii) Should have completed satisfactory service of 03 years in an executive post in public, semi government or private sector with a post graduate for one of above subjects.

02. *Special qualifications.*- Fluency in English Language, Computer literacy with the basic knowledge in designing computer data base, ability to implement income generation projects and knowledge of modern office procedures will be additional qualification.

03. *Age.*- Should be more than 18 years and not more than 45 years as at the closing date of application. Those who are in public service should be less than 55 years.

04. *Salary.*- Monthly salary is Rs. 30,175. In addition allowances decided by the Board of Directors will be paid.

05. *Recruitment.*- Qualified applicants will be interviewed and qualified person be recruited for above post on contract basis for a period of one year. Upon the satisfaction of the service, after one year, service continuation of the service will be considered by the Board of Directors of the Authority.
