THE following decision taken by the Seruwila Pradeshiya Sabha by virtue of the power vested in North East Provincial Council under Section 2 of the Local Authorities (Standard By-Laws) Act, No. 6 of 1952 is hereby notified.

THE DECISION

The Seruwila Pradeshiya Sabha do hereby decide under Sections 122, 126 with Section 221(a) of Pradeshiya Sabha Act, No. 15 of the 1987, to adopt and approve to come in force in the area of Authority of Seruwila Pradeshiya Sabha with effect from the date on which this decision is published in the *Gazette* of the Democratic Socialist Republic of Sri Lanka, the By-Laws Part I and Section No. 1 – 42 of Part II of the said Standard By-Laws, framed by the Honourable Minister of Local Government, Housing and Construction and published in the *Extraordinary Gazette* No. 520/7 of 23rd August, 1988, Part IV – Local Government and decided and approved by the Honourable Governor, North East Province to the limits of the North East Province, on which the decision published in Part IV of the *Gazette* of the Democratic Socialist Republic of Sri Lanka, No. 842 of 21.10.1994.

DARANIYAGALA PRADESHIYA SABHA

By-laws

WE shall notify that the following By-laws are enacted by the Daraniyagala Pradeshiya Sabha which comes within the administrative authority of the Sabaragamuwa Province Provincial Council, under the power granted by Article 122 and Article 126 of Act, No. 15 of 1987 Pradeshiya Sabha Laws, and these By-laws are approved by the Minister of Local Government of the Sabaragamuwa Province under the power granted to him by Article 123 of the Pradeshiya Sabha Act.

THE UTILIZATION OF ROADS BELONG TO DERANIYAGALA PRADESHIYA SABHA THE BY-LAW OF ADMINISTRATION AND FORMALIZATION

01. This By-Law is named as "The By-law of administration and formalization of vehicles transporting on roads belongs to Deraniyagala Pradeshiya Sabha".
02. The aim of enacting this By-law is minimizing the damages of roads and controlling and formalizing of heavy vehicles transportation on Pradeshiya Sabha roads and other roads which are not belong to other authority.
03. This By-law is activated from the publishing date of *Gazette*.
04. (i) Here onward the Vehicles as Tipper, Tractors the heavy Vehicles which are used to construct roads or metal, sand and all building materials, minerals or rubber products exceeding Two Tons are not allowed to transport without bearing a certificate issued by the Chairman of Pradeshiya Sabha under, first sub statement.
(ii) Dragging of logs or timber on these road using animals or tractors are not allowed.
(iii) It is not allowed to transport the vehicles without air pressure tyre, unless loading an another vehicle and any Pradeshiya Sabha road.
05. (i) According to second By-law of the sub constitution if anyone transports, building construction material, agricultural products, timber or machinery on above mentioned roads who is not allowed to transport without having a permission from Chairman after paying the fund mentioned in the first sub statement.
(ii) According to second By-law of the sub constitution if any transport, building materials, agricultural products, timber or machinery on roads shared in the Constitution the person should be taken permission from Chairman at least before 3 days.
(iii) According to a request as 5 (ii) a report will be taken by the Chairman through a technical officer or an officer authorized by Chairman, and a deposit will be have to be paid as a guarantee, considering the anticipating damage.
(iv) The permission should not be given unless the necessary funds are paid, and agreement is made according to the sub constitution 5 (iii).
(v) If a request is made under 5 (iv) constitution to get deposited the fund back. First 10% recovery will be made as department fund and an assessment should be made if there is a damage.
(vi) It is legal to order the particular personalities to pay the additional funds if there is a damage more than deposited guarantee. In such occassion if some someone escapes from paying the necessary fund, it is liable to file a case in the court and Pradeshiya Sabha has the authority to recharge the fund.
(vii) The contractors who have made agreements with Pradeshiya Sabha should be made requests in written to set free from the said fund as in first sub statement.
06. A special permission issued by Chairman or an authorized officer should be taken after paying the money as in the first sub statement.
07. All the permission issued by Pradeshiya Sabha according to the sub constitution is legal to be examined by the Chairman or Secretary of Pradeshiya Sabha or an Officer authorized by above Chairman or Secretary.
08. It is an offence to brake or avoid the statements or any statement which have been mentioned in the by constitution and a mean time if someone has been made an accused from a court according to the statement 122 (2) of No. 15, 1987 Pradeshiya Sabha Act who has to pay the fine and also if the offence is done continuously, in such occassion the special attention is made by the Chairman or Secretary or an Officer of authorized by them and if the officer is made after handing over the information in written by above officers. A special fine ordered according to the 122 (2) statement of No. 15, 1987 Pradeshiya Sabha should be surrendered.

09. At the implementation of this By-law the final decision is taken by the Chairman. Province under the power granted to him by Article 123 of the Pradeshiya Sabha Act.
10. According to this By-law in time to time the funds related to it liable to be changed and Pradeshiya Sabha has the power of amendments of funds. MAHIEPALA HERATH,

“Chairman” as Chairman of Pradeshiya Sabha at Deraniyagala,
“Secretary” as Secretary of Pradeshiya Sabha at Deraniyagala,
“Authorized Officer” as an Officer in Pradeshiya Sabha of Deraniyagala authorized by the Chairman or Grama Niladhari or Officer of Police.

YATIYANTOTA PRADESHIYA SABHA

BY-LAWS RELATING TO THE MAINTENANCE OF CREMATORIUM

- FIRST SUB STATEMENT
01. Transport of sand, soil or other minerals :-
For 2 cubes - 100 Rupees
For 2 cubes - 150 Rupees
The cubes exceeding every 3 cubes - 50 Rupees
02. Transport of firewood, yellow bamboo (For single transport) - 500 Rupees
Transport of timber for single transport - 1,000 Rupees
Construction Machine (Not chain loader) - 1,500 Rupees
03. Agricultural transport :-
1. Everyday or more than 5 days per month - 200 Rupees
2. Not every day of less than 5 days - 100 Rupees
01. These By-laws may be cited as ‘The By-laws for cremation of corpses, fixing of charges, collecting of charges, and regularization of the ruling of the crematorium; that situated at the public burial ground, Hamandha, belongs to Yatiyantota Pradeshiya Sabha.
02. No any corpse shall be cremated in the crematorium without permission issued by the Chairman or another officer who is assigned into the power by the Chairman of Pradeshiya Sabha, Yatiyantota.
03. Any person (herein after means Applicant) who intends to get permission mentioned in section 02 in these By-laws shall forward an application prepared according to schedule 01 to the Chairman with under mentioned documents.
(i) A certificate issued by the Grama Seva Niladhari of the Grama Niladhari Division where the deceased had lived.
(ii) The certificate of permission for cremation the corpse issued under Section 41.3 of the Births and Deaths Registration Act by the coroner, if he held inquest in to the death of the corpse under the Criminal Procedure Code.
(iii) If a corpse of a still birth, the certificate issued under Section 43 (1) of Births and Deaths Registration Act.
04. It shall be recorded in sequence, after the prepared application has been received to the Chairman.
05. If the corpse shall be delivered for cremation, the permission shall be issued to the applicant after collecting of due fee. The time of delivery the corpse to the caretaker of the crematorium shall be mentioned in the permission.
06. If the corpse shall not be accepted for cremation, the reason for that shall be informed to the applicant in writing.
07. Corpses shall be accepted for cremation within the time period from 6.00 a. m. to 8.00 p. m. in everyday.
08. Corpse shall be delivered by the applicant to the crematorium on or before the time mentioned in permission. The Pradeshiya Sabha shall not be responsible

YATIYANTHOTA PRADESHIYA SABHA

By-laws

WE shall notify that the following By-laws are enacted by the Yatiyantota Pradeshiya Sabha which comes within the administrative authority of the Sabaragamuwa Province Provincial Council, under the power granted by Article 122 and Article 126 of Act, No. 15 of 1987 Pradeshiya Sabha Laws, and these By-laws are approved by the Minister of Local Government of the Sabaragamuwa

- for any inconvenience or damages that cause from late delivery.
09. No fee shall be charged for the cremation of a corpse of any Chairman, Vice Chairman, and Member, Officer or employee of the Sabha who serve or had served at the Sabha.
 10. The care-taker of the crematorium shall record the details of each corpse that cremated at the crematorium such as applicant's name and address, deceased's name and address of the place where the deceased had lived before the death, the relation between the applicant and the deceased and date and time of the cremation.
 11. The Ashes shall be taken by the applicant or authorized person of him before the expiring of seven days from the cremation day of the corpse. Where the Ashes shall not be taken within that period, the chairman has the power to exclude the Ashes in any manner.
 12. No person shall enter the premises of the crematorium without permission of the care-taker of the crematorium or the Chairman. However, it is considerable for any person or persons who came with the permit holder to cremate the corpse having permission.
 13. Even though a corpse has been delivered to the crematorium for cremation, the Chairman has the power to bury the corpse, if the corpse shall be unable to cremate before or during of cremation on electric failure or technical faults.
 14. No person shall behave in a disorderly manner or disturb to the duties of the care-taker of the crematorium or his assistants or decorate in or about the premises of the crematorium. If it shall be damaged to the property of the Sabha situated within the premises of the crematorium, action shall be taken to value that damage by an authorised officer and collect the damage.
 15. Any person who violates any section in these By-laws shall be guilty of an offence and on being convicted by a court of proper jurisdiction shall be liable to fines that mentioned sub-section 122 (2) of the Pradeshiya Sabha Act, No. 15 of 1987.
 16. It is a duty of the Sabha to maintain and update the crematorium in due condition for cremation of corpses. If the crematorium has been closed for a short period to maintain or restore, it is the duty of the Chairman to display a notice of that on a visible place at the crematorium and on the notice board of the Sabha.
 17. The Sabha shall determine the fees to collect for cremation of corpses by a resolution in annually. The fees determined by that way may be amended by the Sabha in any occasion where the Sabha is considerable to do so.

18. The term "Sabha" means the Pradeshiya Sabha, Yatiyantota, the term "Chairman" means the Chairman of the Pradeshiya Sabha, Yatiyantota, or any officer received written order of vesting power from the chairman of the Pradeshiya Sabha Yatiyantota, "care-taker of the crematorium" means any person who appointed as the care-taker of the crematorium of the Pradeshiya Sabha, Yatiyantota and "Corpse" means corpse or a partition of a corpse of a human or a body of a still birth.
19. In the event of any inconsistency between the Sinhala and Tamil texts of this By-law the Sinhala text shall prevail.
