NOTIFICATION MADE UNDER STATE LAND REGULATION No. 21 (2)

IT is hereby notified that for the commercial purpose, Samurdhi Authority of Sri Lanka has requested on lease a state land containing in extent about 0.101 Hec. from the total 0.560 Hec. land out of extent marked lot No. 127 in additional No. 4 as depicted in Plan F. V. P. 2151 and situated in the village of Kamburapola which belongs to the Grama Niladhari Division of 1402, Kamburapola coming within the area of authority of Paduwasnuwra Divisional Secretariat in the District of Kurunegala.

02. Given below are the boundaries of the land requested :-

On the North by Lot No. 123 ;
On the East by Lot No. 123 ;
On the South by Rest of Lot No. 127 ;
On the West by Lot No. 126 ;

The land requested can be given on lease for the necessary purpose. Therefore, the government has intended to lease out the land subject to other government approved Conditions and following conditions.

(a) *Terms of the lease* .- Thirty (30) years (from 31.05.2012 Onwards);

The annual amount of the lease .- 4% of the Commercial value of the land as per valuation of the Chief Valuer in the year 2012. This amount of the lease must be quinquennially revised in such a manner that the amount as a result of the revision will be not less than 50% of the amount that just preceded;

- (b) The lessee must, within one year of the commencement of the lease, develop the said land, in such a manner as to captivate the mind of the Divisional Secretary ;
- (c) The lessee must not use this land for any purpose other than for commercial purpose;
- (d) The buildings constructed must be maintained in a proper state of repair;
- (e) Once the land is given on lease and in the event of failure on the part of the lessees to substantiate within the specified time frame the purpose for which the land was obtained, action will be taken to terminate the lease;
- (g) No sub-leasing can be done until the expiry of a minimum period of 05 years;
- (h) Payment of the lease must be regular made and if defaulted in payment, the agreement will ipso facto lapse.

If acceptable reasons are not submitted to me in writing within six weeks of the date herein below to the effect that this land must not be given on lease, the land will be leased out as requested.
