RESOLUTION

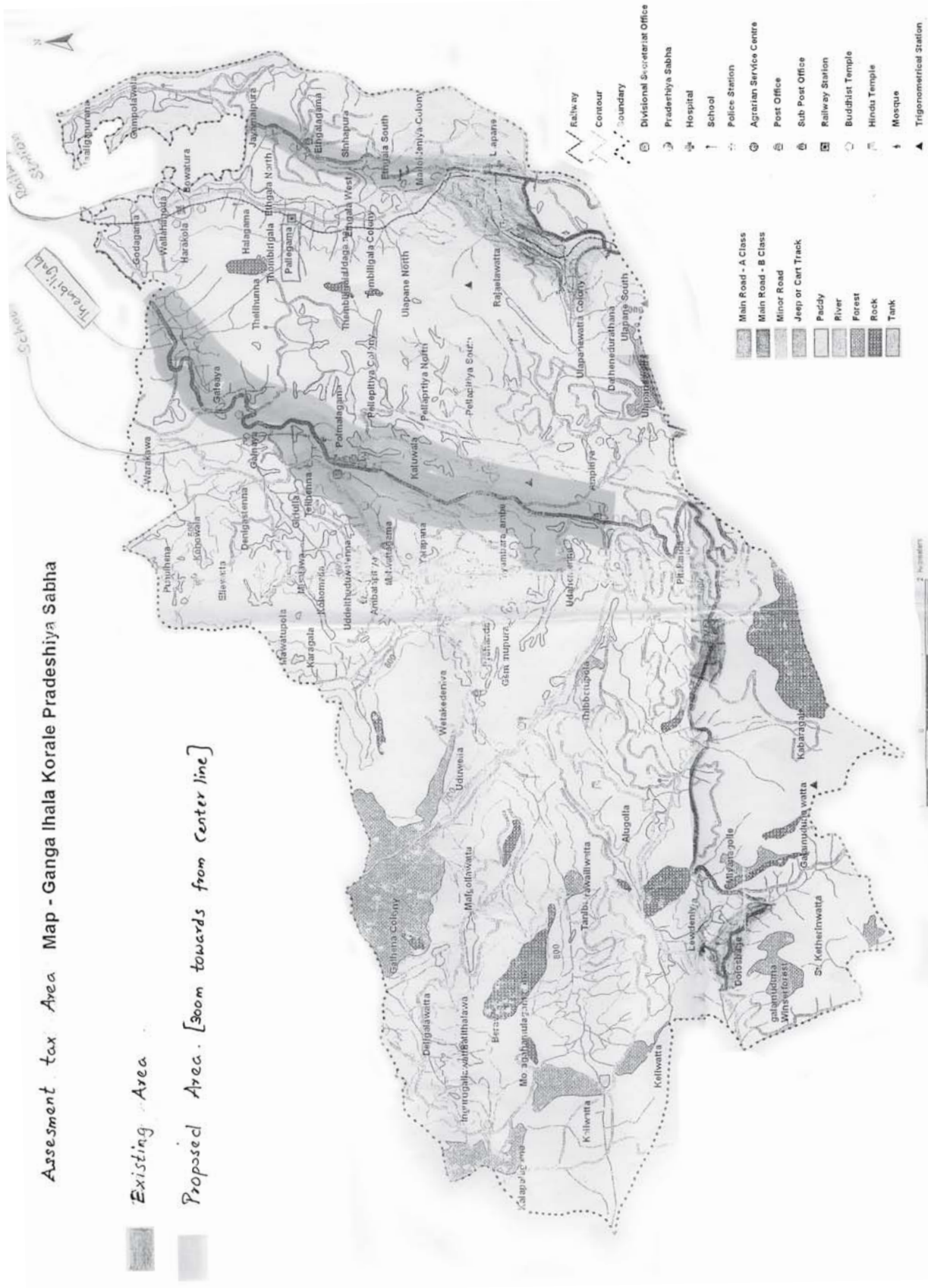
By virtue of power vested on Pradeshiya Sabha, under Sub-section (1) of Section 134 of Pradeshiya Sabha Act, No. 15 of 1987, the Ganga Ihala Korale Pradeshiya Sabha has proposed to accept the areas situated within the jurisdiction of Ganga Ihala Korale Pradeshiya Sabha, mentioned in the following Schedule are as developed and,

02. The adopted Resolution should be forwarded to the Assistant Commissioner of Local Government, Kandy District for his formal approval.

SCHEDULE

01. The area extending on either side by 300 meters, starting from the 6th Lane at Jayamalapura, Mr. Jayasundara's provision shop, Athgala in Gampola Nawalapitiya Main Road, up to Ranasinghe's Communication, off SAARC settlement, towards Nawalapitiya.
02. The area extending on either side by 300 meters, starting from first mile post at Mr. Ananda's provision shop at Sinhapitiya junction, in Dolosbage Sinhapitiya Road, in Kurunduwatta, Gampola up to the road towards Udahentenna post office, turning Lokananda Viharaya, passing Kurunduwatta town.
03. The area extending on either side by 300 meters, starting from the Pradeshiya Sabha office, in Kurunduwatta town up to the road entering Mr. R. P. Alwis's house, 01km, away from the Pellepitiya road towards Pellepitiya.
04. The area extending on either side by 300 meters, starting from the Pradeshiya Sabha office, in Kurunduwatta town up to the road opposite to Mr. H. S. Wijsekera's house covering 01km, passing Tenna in Giraula.
05. The area extending on either side by 300 meters, starting Pradeshiya Sabha office, in Kurunduwatta town, up to Mr. Ariyasinghe's trade shop, covering 01km in Meetalawa road.
