AN ACT TO INCORPORATE THE PIYASENA GAMAGE FOUNDATION

I, Thenuka Vidanagamage, do hereby give notice under Standing Order, No. 48 (1) of the Parliament of the Democratic Socialist Republic of Sri Lanka that I propose to introduce in Parliament a Bill entitled "An Act to incorporate the Piyasena Gamage Foundation".

The aim of the Bill is to incorporate the said Foundation which has the following general objects :-

1. To organize, maintain and improve facilities for education and pre-training facilities for the needy children and the youth ;
2. To grant financial assistance to Cultural Centres and Art Circles with a view to preserving the cultural heritages of all the communities in Sri Lanka ; and
3. To grant financial assistance to the institutions established for the welfare and rehabilitation of the destitute, invalid, old, sick and displaced persons in Sri Lanka and if necessary, to establish new centres for the purpose, etc.
