By North.— Habarana - Batticaloa A11 Road (by the Thamankaduwa and Hingurakgoda Pradeshiya Sabhas limits) and from the Central Line Crossing in Kumbukkan Aru and travelling towards the North of the Central Line in Kumbukkan Aru and proceeding up to the Crossing Point in Kumbukkan Aru and Colombo-Batticaloa Main Railway Line and traveling towards the direction of Batticaloa through the Central Line in the same Railway Line and going further and finding Parakrama Samudraya 1st Canal (upto Kurunduwatte Handiya) turning on the left in the Central Line in the same 1st Canal and turning to the left and going down nearly 500 metres up to Naught Canal Road alias Kumaraswamy Wadiya Road (including 100 meters on the left).
